## RACE COMMENTS

### Race 1 ZAFARA FOLEY MAIDEN 1600

**EDDIE WOOD** (L Douglas) - Restrained from a wide draw and then raced wide throughout.

**OVERAGAIN** (D Turner) - Checked passing the 1000 metres when racing to the inside of MATINEE (M Sanson) which shifted when not the required distance clear. Also affected was LINCOLN LANE, which had to take evasive action to avoid that runner's heels, losing ground.

**LINCOLN LANE** (L Hemi) - Had to take evasive action to avoid heels passing the 1000 metres.

**M Sanson** (MATINEE) - Admitted a subsequent charge of careless riding in that she permitted MATINEE to shift inwards when not sufficiently clear of OVERAGAIN, which was checked near the 1000 metres. After considering submissions the Adjudicator suspended her licence to ride in races from the conclusion of racing on Wednesday, 24 November up to and including racing on Sunday, 28 November (4 national riding days).

**Race 2** | **WENHAM GRAIN & SEED/TUI SINCE 1889 3YO 1300**

**REIGN IT IN** (D Turner) - Began awkwardly and then over-raced.

**SON OF THUNDER** (T Comignaghi) -Over-raced when three wide without cover throughout. Inclined to shift in under pressure in the home straight.

**MORUS** (S Macnab) - Over-raced passing the 1100 metres. Held up in the home straight.

**NOBELLEM** (L Hemi) - Lay in under pressure passing the 200 metres.

**D Turner** (REIGN IT IN) - Admitted a charge in that he struck his mount REIGN IT IN 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

**Race 3** | **CERVUS EQUIPMENT/MILTON PARK STABLES 1200**

**KICK START** (R Hannam) - Slow away.

Several runners were steadied into the first turn when the pace ahead eased abruptly. Those runners being GO JAMES, LINCOLN'S KRUZ, POWER 'N' GLORY, LILHOOVESGOTMOVES and BRING IT ON.

**GO JAMES** (T Comignaghi) - Over-raced near the 800 metres for some distance when the pace eased, making contact with the running rail.

**LINCOLN'S KRUZ** (L Hemi) - Over-raced near the 800 metres when the pace eased. Lay out and bumped with CASAQUINMAN in the home straight.

**POWER 'N' GLORY** (S O'Malley) - Steadied 800 metres.

**LILHOOVESGOTMOVES** (B Grylls) - Steadied 800 metres.

**BRING IT ON** (H Schofer) - Steadied near 800 metres.

**CASAQUINMAN** (D Turner) - Bumped home straight.

**S Macnab** (KAPINOS) - Admitted a charge of slowing the pace passing the 800 metres to the extent that several runners following had to be eased abruptly. After considering submissions the Adjudicator suspended her licence to ride in races from the conclusion of racing on Thursday, 25 November up to and including racing on Thursday, 2 December (5 national riding days).

**Race 4** | **SMARTPHONE REPAIRS/STEVE'S TYRE SERVICE 2200**

**THE SEAGULL** (A Mudhoo) - Began awkwardly.

**SASSENACH** (R Hannam) - Slow away.

**BEAR GRYLLES** (C O'Beirne) - Raced three wide into the first corner prior to being taken forward near the 1400 metres.

**JAKKANO** (J Mudhoo) - Raced wide without cover throughout and raced in restricted room on the home turn when SASSENACH (R Hannam) shifted out into clear running. R Hannam was advised to exercise greater care.

**PRINCE TURBO** (D Bradley) - Lugged inwards in the home straight.

**THE BIG BOSS** (S Macnab) - Finished last. Rider advised the mare would prefer more rain-affected footing.

**Race 5** | **WAIPINE LOGGING/J.T FORESTRY BULLS COUNTRY CUP 2200**

**TWEEDLEDEE** (L Hemi) - Made the first bend awkwardly then over-raced for a distance.

**CARPE DIEM** (A Mudhoo) - Briefly held up passing the 250 metres.

**Race 6** | **HIGGINS CONCRETE 1400**

**JEWEL OF PATCH** (D Hirini) - Slow away.

**SHADOWS CAST** (A Mudhoo) - Began awkwardly bumping BELLISSIMO.

**BELLISSIMO** (M Sanson) -Bumped start and settled back.

**TAVIS COURT** (C O'Beirne) - Raced three wide throughout. Finished last. C O'Beirne was of the opinion the gelding would be better suited to rain-affected going. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**B Clement** (TAVIS COURT) - Admitted a charge of failing to follow a directive given by the Stewards and was fined \$100.

**Race 7** | **PROPERTY BROKERS/WRIGHT LIVESTOCK 1400**

**PUTORINO** (S O'Malley) - Slow away from its wide draw. Dictated wide on the point of the home turn.

**ARJAYBEE** (B Grylls) - Shifted out and away from WHATSUP (D Hirini) on making the bend and in doing so hampered ALHAMBRA LAD which was attempting a narrow run to its outside. Continued to hang outwards under pressure in the home straight.

**ALHAMBRA LAD** (H Schofer) - Hampered and steadied 400 metres.

**BALALAIKA** (D Turner) - Dictated wide on the home turn bend.

**SHELBYROCK'N** (L Douglas) - In or near the lead throughout. Compounded and finished well back. L Douglas had no excuse and advised the mare was disappointing.

**D Hirini** (WHATSUP) - Spoken to regarding her use of the whip in the home straight (above shoulder height).

**Race 8** | **BNZ PARTNERS/HARRIS CONTRACTING 1600**

**LINCOLN RADER** (R Hannam), **CARLINGFORD BAY** (C Dell) and **VICTOREM** (D Turner) all broke through their respective gates prior to the start and after undergoing veterinary inspections were cleared to start.

Prior to running of Race 8 the gates were tested.

**LINCOLN RAIDER** (R Hannam) - Slow away and awkward in its action over the first 100 metres.

**ZOLA EXPRESS** (L Douglas) - Had to be steadied shortly after entering the home straight when TORQUE TIME (H Schofer) shifted in when only marginally clear. ZOLA EXPRESS then had to be angled wide to improve. After viewing footage H Schofer, in the presence of the Riding Master, was advised to exercise greater care.
