**RACE COMMENTS** 

Race 1 DAVE HOSKIN CARRIERS MAIDEN 1200m

**TENNESSE ROSE** - Was declared a late scratching at 08.05 am due to transport difficulties.

**PAPENHUYZEN** (L Douglas) - Underwent a veterinary examination at the start after contacting the gate in the parade area.

**FASONG** (N Parmar) - Improved up on to the heels of KING OF HEARTS near the 400 metres, resulting in FASONG clipping that runners heels and falling. N Parmar who was uninjured, was checked by St John paramedics and cleared to fulfil his remaining engagements. FASONG sustained an injury to the near hind fetlock and was humanely euthanised. After viewing footage and questioning riders the incident was considered to be accidental.

**KING OF HEARTS** (L Hemi) – Slow away. Had to change ground passing the 200 metres to improve after being held up for a short distance.

**RAURIMU** (A Mudhoo) - Commenced to over-race in the back straight and had to be steadied off the heels of LINCOLN VALLEY going into the first turn. RAURIMU continued to over-race when in restricted room for some distance and had to be checked off heels when the pace ahead eased approaching the 800 metres. Finished some distance last. A Mudhoo advised that after over-racing throughout the gelding had little left at the finish.

**LITTLEREDCORVETTE** (C O'Beirn) - Made the lead approaching the 800 metres and was then steadied going back onto LINCOLN VALLEY which was steadied and in turn went back on to BAZOOKA which was steadied. C O'Beirne was shown footage of her ride in the presence of the Riding Master and issued with a warning under Rule 638(4) after unnecessarily slowing the pace to a degree where those runners in behind had to be steadied.

## Race 2 PLATINUM HOMES 3YO 1200m

**ALL IN ECHOES** (R Hannam) - Stood in its gate, refused to jump away and took no effective part. Connections were advised the filly must trial prior to the satisfaction of stewards prior to its next start.

**ELUSIVE TEN** (L Allpress) - Was inclined to hang outwards rounding the home turn.

**PRADASPHERE** (M Singh) - Was reminded of his obligations with regards to his use of the whip in a runner out of contention.

**AVONALLO** (L Hemi) - When questioned into the run of AVONALLO, L Hemi was of the opinion the gelding may be suited to a longer distance.

### Race 3 GAS & HEATING 1200m

**SCOTCH** (S O'Malley) – Began awkwardly and was slow away.

**HORLISTIC** (J Mudhoo) - Made the first corner awkwardly.

SHE'S A GODDESS (D Hirini) - Was held up for some distance around the home turn.

**TOWN BELT** (C O'Beirne) - Was angled outwards to improve near the 400 metres and in doing so bumped with GOT THE CALL.

**SWISH** (R Hannam) - R Hannam was issued with a warning under Rule 636(3)(b)(ii) for his use of the whip in succession inside the 100 metres.

### Race 4 SOUND ELECTRICAL 1340m

**FAMILY TIME** (D Hirini) - Slow away.

**HA'PENNY BRIDGE** (R Hannam) – Began awkwardly settling at the rear.

**LINDA LOLA** (C O'Beirne) – Restrained to the rear shortly after the start.

**TRANSITORY** (C Dell) – Restrained to the rear shortly after the start.

**HIGH FREQUENCY** (L Hemi) – Over-raced passing the 1,000 metres. Had to be steadied near the 700 metres when tightened after DU'BLUES (L Kauri) rolled inwards. After questioning riders and viewing video footage which was inconclusive, L Kauri was advised to exercise greater care.

**ALMERAKI** (T Yanagida) - Lay in under pressure over the concluding stages.

# Race 5 WANGANUI MOTORS AND THE DYKE FAMILY 1340m

SINARAHMA (H Schofer) - Was slow away (4 lengths) and then slow into stride.

**BARI** (R Hannam) - When questioned into the run of BARI, R Hannam advised the gelding had a tendency to over-race in the early and middle stages and when asked to improve near the 400 metres failed to quicken. R Hannam was of the opinion BARI may be better suited to a longer distance.

LOVE FOR ALL (L Allpress) - Over-raced passing the 1,000 metres.

# Race 6 DUNSTAN FEEDS STAYERS CHAMPIONSHIP QUALIFIER 1600m

**SPIDERMAN** (H Schofer) - Over-raced early stages and then had to be steadied entering the back straight when the pace ahead eased.

**BELCLARE** (L Allpress) - Over-raced into the first turn and then shortly after entering the back straight was checked when AOTEA LAD (N Parmar) shifted in when not clear. N Parmar admitted a breach of Rule 638(1)(d) in that he allowed his mount to shift in when not clear and had his licences to ride in races suspended from the conclusion of racing on 4 December 2021 up to and including 15 December 2021 – 4 riding days. Continued to over-race in the middle stages.

#### Race 7 STEELFORM ROOFING GROUP WANGANUI CUP 2040m

**HUNTA PENCE** (H Schofer) – Began awkwardly settling at the rear.

**UAREASTAR** (M Singh) - Restrained at start.

PEP TORQUE (C O'Beirne) - Blundered at the crossing near the 1,600 metres, briefly unbalancing the rider.

**SKYPHYTA** (L Douglas) - Unbalanced over the crossing near the 1,600 metres.

**MISS SHER NAN** (A Mudhoo) - Raced wide through the early and middle stages. Finished some distance last. A Mudhoo advised stewards that the mare was making a respiratory noise during the running.

**ZOLA EXPRESS** (C Dell) - Raced in restricted room rounding the final turn and early in the home straight, gaining clear running near the 200 metres. C Dell was spoken to with regard to his victory celebration at the finish.

**CHARLIE HORSE** (R Elliot) - When questioned into the performance, Rider R Elliot advised the gelding was suited to more rain affected going and was to spell.

#### Race 8 LOADERS WANGANUI 2040m

MISTER GERONIMO (L Douglas) - Slow away.

RAZORS EDGE (L Kauri) – Raced wide without cover throughout.

**DEUCE COUPE** (M Singh) - Raced keenly throughout.

**EXQUISITE PEARL** (L Hemi) - EXQUISITE PEARL and RED RUFUS came together and bumped for a short distance near the 1,200 metres.

**BEAR GRYLS** (C Dell) - When questioned into the improved performance of BEAR GRYLS, B Coxhead advised the gelding was obliged to race wide at its previous start.
