#### **RACE COMMENTS**

## Race 1 USE TAB APP AT TRACK (1600 metres)

**CLEVERCONVERSATION** (L Satherley) – Slow to begin. Lay in over the concluding stages.

**PUSHKA** (E McCall) – Became tailed off passing the 800 metres.

**BRING IT ON** (S Spratt) – Shifted out over the concluding stages when placed under pressure.

**SUPER GEE** (C Grylls) – Raced in restricted room over the concluding stages between CLEVERCONVERSATION (L Satherley) and BRING IT ON (S Spratt) which both shifted ground under pressure. L Satherley and S Spratt were advised to exercise care in a similar circumstance.

**S Spratt** (BRING IT ON) – Admitted a breach in that she used her whip excessively prior to the 100 metres. After hearing submissions, the Adjudicative Committee imposed a fine of \$500.

## Race 2 HIREPOOL (1600 metres)

**C'EST UNE STAR** (L Satherley) – Slow to begin. Raced keenly in the early stages improving onto the heels of PADDY WAGON which shifted in approaching the 1300 metres.

**HIGHLAND WHIPSER** (T Yanagida) – Began awkwardly. Raced wide throughout.

**TRUE NORTH** (J Fawcett) – Jumped outwards at the start losing ground. Over-raced in the early and middle stages.

**ARANCIA** (S Spratt) – Raced in restricted room passing the 1400 metres to the outside of PADDY WAGON which lay out when making the crossing onto the course proper. As a result, ARANCIA lost ground. Hampered when crowded 1300 metres by SAINT ALICE which shifted in abruptly.

**PADDY WAGON** (J Fillmore) – Slow to begin. Raced ungenerously in the early to middle stages. Held up for clear running until inside the 300 metres. Received veterinary attention following the race after showing significant lameness (grade 4/5) in the off foreleg. Stewards will follow up the condition of PADDY WAGON in the days subsequent with connections being advised that a veterinary certificate of fitness would be required prior to the gelding racing or trialling next.

**CINNAMON STAR** (A Calder) – Held up for clear running until inside the final 300 metres.

**STORMY'S SECRET** (D Danis) – Rider dropped his whip near the 300 metres.

**SAINT ALICE** (A Goindasamy) – Shifted in under pressure in the final straight making brief contact with HIGHLAND WHISPER passing the 100 metres.

A Goindasamy (SAINT ALICE) – Admitted a breach of careless riding in that he angled his mount in near the 1300 metres when insufficiently clear of ARANCIA which was hampered. After hearing submissions, the Adjudicative Committee suspended A Goindasamy's licence to ride in races from the conclusion of racing on Saturday 7 August up to and including racing on Friday 20 August, 5 national riding days and in addition imposed a fine of \$500.

**A Goindasamy** (SAINT ALICE) – Admitted a breach in that he used his whip excessively prior to the 100 metres. After hearing submissions, the Adjudicative Committee imposed a fine of \$300.

#### Race 3 NORTHLAND BUSINESS SYSTEMS (1200 metres)

KIWIANNA (J Kamaruddin) - Slow to begin.

**NEW DAWN** (S Collett) – Restrained in the early stages.

**BREEZON** (T Newman) – Raced wide in the early stages before obtaining cover passing the 900 metres.

PACKING NOBLESSE (C Grylls) – Raced keenly in the middle stages.

**PRETTY ROSSA** (E Nicholas) – Underwent a veterinary examination after being kicked on arrival at the barrier and was cleared fit to race. Lay out when placed under pressure in the final straight making brief contact with MASTER PARK passing the 100 metres. E Nicholas was advised to exercise greater care in a similar circumstance.

#### Race 4 AUG 21 – ALIBABA'S FLYING CARPETS RUAKAKA CUP (2100 metres)

MAKZABEEL (D Johnson) - Slow to begin. Over-raced early to middle stages due to a slow pace.

**FINAL SUGGESTION** (E McCall) – Restrained at the start then raced keenly early to middle stages. Attempted to improve into a diminishing run and was held up from near the 100 metres.

STEVEN JAMES (J Kamaruddin) – Raced keenly in the middle stages.

**BARBARA** (S Collett) – Over-raced early to middle stages due to a slow pace.

**DOUBLE HAPPY** (M Hashizume) – When questioned regarding the improved performance co-trainer S Clotworthy advised that the gelding's recent runs had been better than form would suggest and had also been schooling leading into today's event.

## Race 5 DUNSTAN ACCUMULATOR (1400 metres)

**DAYTONA RED** (D Danis) – Slow to begin.

**LILLY THUNDER** (T Yanagida) – Slow to begin.

MONACO (J Fawcett) – Began awkwardly.

**STAND TALL** (A Goindasamy) – Raced wide without cover throughout. When questioned regarding performance rider advised that the gelding was not entirely comfortable in today's track conditions.

### Race 6 AUG 21 – CAMBRIDGE STUD NORTHLAND BREEDERS STAKES (1100 metres)

**STREET KID** (J Kamaruddin) – Slow to begin. Raced keenly in the middle stages. Improved onto heels near the 500 metres then clipping a heel and blundering losing ground, then hung making the final bend. J Kamaruddin was advised that he must exercise better judgement in a similar circumstance.

**LA DOLCE VITA** (A Goindasamy) – Restrained from its wide barrier.

**TAZIMOTO** (S Spratt) – Began awkwardly. Hung throughout and ran very wide on the turn and was not persevered with in the final straight. Underwent a post-race veterinary examination which could find no significant abnormality. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**CRUISY LASS** (L Satherley) – Began awkwardly.

**ON MY SHOULDERS** (J Fawcett) – Shifted out to obtain clear running passing the 300 metres.

## Race 7 FIRECO (1400 metres)

APATCHEE POWER (E Nicholas) - Slow to begin (3L).

**UNCLE TERRY** (E Leighton) – Raced wide throughout.

**HIT THE SWITCH** (D Danis) – Restrained from its wide barrier in the early stages.

OUR SHAMAN (E McCall) - Began awkwardly.

**LAURANT** (C Grylls) – Steadied approaching the 1300 metres when crowded. Had difficulty obtaining clear running early in the final straight until inside the final 350 metres.

**PRETTY GOOD** (S Spratt) – Steadied approaching the 1300 metres when crowded. Held up until inside the final 350 metres.

**IMAREADY** (D Johnson) – Raced keenly in the early stages.

**J Kamaruddin** (ALWAYS SACRED) – Issued with a warning after allowing his mount to shift in near the 1300 metres when insufficiently clear of LAURANT and PRETTY GOOD which were both steadied when crowded.

**E Leighton** (UNCLE TERRY) – Admitted a breach in that she used her whip excessively prior to the 100 metres. After hearing submissions, the Adjudicative Committee suspended E Leighton's licence to ride in races from the conclusion of racing on Tuesday 17 August up to and including racing on Wednesday 25 August, 5 national riding days.

## Race 8 SEP 11 – HARCOURTS HATS, HEELS & HANDBAGS FOR HOSPICE (2100 metres)

**ZENNTARI** (S Collett) – Slow to begin.

**CERYS** (T Yanagida) – Slow to begin.

**SINGLE MOMENT** (A Goindasamy) – Restrained from its wide barrier in the early stages. A Goindasamy was reminded of his obligation to ride his mounts out to the finish of the race when circumstances permit him to do so.

**LADY GWENDOLYN** (C Grylls) – Raced wide without cover throughout.

**O'SUSANA** (S Spratt) – S Spratt was reminded of her obligation to ride her mounts out to the finish of the race when circumstances permit her to do so.

**J Kamaruddin** (SHEBRINGSMERUBIES) – Admitted a breach in that he used his whip excessively prior to the 100 metres. After hearing submissions, the Adjudicative Committee imposed a fine of \$500.
