RACE COMMENTS			
	Race 1	LANDMARK HOMES MAIDEN 1600	

WATUZZI (D Turner) - Slow away.

POITIN (F Lazet) - Bumped with EDDIE WOOD on two occasions entering the home straight.

SACRED PEARL (R Elliot) - Gave ground from the 600 metres with rider not persevering with the mare in the final straight. When questioned, R Elliot advised Stewards the mare was breathing abnormally. A subsequent veterinary examination revealed a slow recovery rate.

Race 2 DOWNER MAIDEN 1300

BORN TO RUN (M Hudson) - Underwent and passed a pre-race veterinary examination after becoming fractious when being resaddled at the start. Over-raced and steadied near the 900 metres.

CRY BABY (C O'Beirne) - Restrained to the rear from a wide draw. Steadied near the 500 metres.

KELSEY BE (A Mudhoo) - Over-raced in the early stages. Awkwardly placed on heels near the 200 metres when weakening.

HERMES (C Barnes) - Raced wide throughout.

TRUSTWORTHY (L Hemi) - Lost the nearside front plate during the running.

H Schofer (SEA MONARCH) - Issued with a warning for permitting SEA MONARCH to shift inwards when not sufficiently clear of KELSEY BE passing the 1200 metres.

Race 3 HIMATANGI TRANSPORT 1200

SCOTCH (S O'Malley) - Steadied passing the 800 metres when improving onto heels.

SASSY SUSAN (R Hannam) - Shifted out under pressure passing the 300 metres. Bumped concluding stages.

PICUAL (T Yanagida) - Lay inwards over the concluding stages bumping with SASSY SUSAN.

GAELIC SPIRIT (M Singh) - Raced in restricted room over the concluding stages.

Race 4 MCDONALDS PALMERSTON NORTH 1100

CHIKIRA LASS (R Hannam) - Bumped at start when runners either side began awkwardly.

KAPINOS (J Kamaruddin) - Began awkwardly. Worked hard to settle outside the leader from its wide draw and had little left at the finish.

GRAND MAYSON (C O'Beirne) - Began awkwardly.

MAISON ROXANNE (L Hemi) - Held up early in the home straight, gaining clear running inside the final 150 metres.

DARCI LA BELLA (L Allpress) - Lost the nearside hind plate during the running.

T Yanagida (ICONIC STAR) - Admitted a charge in that he struck his mount ICONIC START six times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Monday, 20 December until the conclusion of racing on Saturday, 27 December, 5 national riding days.

J Parkes (DAWN PATROL) - Admitted a charge of using the whip in three consecutive strides on his mount inside the final 100 metres. After considering submissions the Adjudicator imposed a fine of \$150.

Race 5 LAWNMASTER LITHIUM 1400

SINARAHMA (H Schofer) - Slow away. Taken wide to avoid the fallen runner near the 1100 metres. Dictated wide rounding the home turn when attempting to improve.

PLATINUM STAR (T Yanagida) - Restrained to the rear from its wide draw. Inconvenienced by fallen runner near the 1100 metres.

NO LOITERING (L Kauri) - Checked and fell passing the 1100 metres. L Kauri was immediately attended to by paramedics and transferred to hospital for observation.

COLORADO STAR (F Lazet) - Inconvenienced by fallen runner near the 1100 metres. Made the bend awkwardly near the 850 metres.

SATU LAGI (L Allpress) - Over-raced passing the 600 metres.

TAVIS COURT (C O'Beirne) - When questioned into the run of TAVIS COURT, C O'Beirne was of the opinion the gelding was unsuited to the firm nature of the track. Connections advised TAVIS COURT would be spelled.

R Hannam (WILD MOOSE) - Admitted a charge of careless riding in that he permitted WILD MOOSE to shift inwards near the 1100 metres when not clear of SATU LAGI, which was dictated inwards into the line of NO LOITERING which clipped that runner's heels and fell. After considering submissions the Adjudicator suspended his licence to ride in races from the conclusion of racing on Saturday, 18 December 2021 until the conclusion of racing on Friday, 14 January 2022 (4 weeks).

Race 6 DUNSTAN FEEDS STAYERS CHAMPS QUALIFIER 2100

The start of this race was delayed approximately 7 minutes due the requirement to wait for a replacement ambulance.

PASSWORD (L Hemi) - Over-raced briefly near the 1400 metres.

HUNTA PENCE (J Kamaruddin) - Bumped with MASTER FIN near the 200 metres.

MASTER FIN (C Dell) - Bumped 200 metres.

Race 7 COURTESY FORD 2200

SANCHEZ (D Turner) - Began awkwardly and settled at the rear.

INMYSHADOW (M Hudson) - Steadied off heels near the winning post on the first occasion. Held up throughout the home straight and went to the line without being fully tested.

NITRO TED (L Douglas) - Raced wide throughout.

DUBAI'S MOKO (C O'Beirne) - Improved on to heels near the 100 metres.

DIONYSUS (R Elliot) - Improved on to heels near the 50 metres.

SUPER FLASH (S McKay) - Finished some distance last. S McKay was of the opinion the gelding may be better suited to more rain-affected footing.

Race 8 LAWNMASTER EULOGY STAKES (G3) 1600

BELLACONTTE (R Hannam) - Slow away.

AVALENE (S McKay) - Began awkwardly, bumping with UNUSUAL CULTURE, which in turn hampered MARCELLA. Lay out under pressure passing the 300 metres. Steadied passing the 200 metres.

UNUSUAL CULTURE (L Allpress) - Bumped start. Dictated 200 metres.

NOT A BRASS RAZOO (C O'Beirne) - Raced wide without cover throughout. Dictated outwards near the 400 metres when MISS MADISON was angled outwards off heels. D Turner was shown footage of his ride and issued with a warning.

BELLE EN ROUGE (J Kamaruddin) - Shifted in near the 200 metres dictating UNUSUAL CULTURE into the line of AVALENE, which had to steady.

MARCELLA (C Barnes) - Hampered start. Finished well back. When questioned rider was unable to offer any excuse, advising the filly was disappointing.

JUST DANCE (L Hemi) - In restricted room near the winning post.

J Kamaruddin (BELLE EN ROUGE) - Issued with a warning for permitting his mount to shift in near the 200 metres dictating UNUSUAL CULTURE into the line of AVALENE, which had to steady.

D Turner (MISS MADISON) - Issued with a warning for permitting his mount to shift out near the 400 metres dictating NOT A BRASS RAZOO outwards.

BARRI HYDE (H Schofer) - Lost the off fore plate during the running.

Race 9 CONCEPT SECURITY 1600

ALMERAKI (C Dell) - Began awkwardly, losing ground.

JUSTASTATE (C Barnes) - Raced wide throughout.

POWER 'N' PASSION (C O'Beirne) - Lay in under pressure passing the 300 metres.

FLYING HABIT (A Mudhoo) - Finished well back. Rider was of the opinion the mare was unsuited to today's track conditions.

AWATANE (K Hercock) - Rider advised Stewards the gelding had got its tongue over the bit.

Race 10 SENZ 1600

IF YOU DANCE (R Hannam) - Dislodged rider R Hannam prior to leaving the parade area, escaping on to the track and proving difficult to recapture. R Hannam was uninjured. IF YOU DANCE was declared a late scratching on veterinary advice at 4.56pm.

JANE O' (A Mudhoo) - Slow away from its wide draw and then got back when being restrained. A Mudhoo was shown footage in the presence of the riding master and he advised stewards the mare got further back than he intended. A Mudhoo was advised he is expected to exercise better judgment in future.

WHATSUP (C O'Beirne) - Raced wide throughout.

S O'Malley (MISTEREX) - Spoken to regarding his whip use in the home straight (arm above shoulder height).

Race 11 HUNTING & FISHING NZ 1500

CASINO EL JAY (D Bradley) - Slow away.

FIANO (A Mudhoo) - Began awkwardly, settling towards the rear.

GEEZAS GEORGE (J Mudhoo) - Came together and bumped with HEZA LOOKER (C O'Beirne) over the concluding stages.

HEZA LOOKER (C O'Beirne) - Bumped concluding stages. When questioned, C O'Beirne advised her mount was unbalanced after being bumped in the home straight and was inclined to shift outwards.
