RACE COMMENTS

Race 1	POWER FARMING MANAWATU MAIDEN 1400
<p>STRAIGHT SCOOTER – N Parmar replaced S O’Malley (overweight).</p> <p>KINGFISHER LAD (H Schofer) - Late scratching at 12.06pm when refusing to load. Connections were advised the gelding must barrier trial to the satisfaction of Stewards.</p> <p>HYDRO DARCI (C Dell) - Restrained to the rear from its wide draw.</p> <p>REVELRY (L Douglas) - Restrained to the rear shortly after the start. Brushed the inside rail when attempting a marginal run to the inside of FIVE ROAD JUNCTION passing the 250 metres. L Douglas was shown footage of his ride in the presence of the Riding Master and advised to exercise care.</p> <p>TRUSTWORTHY (L Hemi) - Raced greenly passing the 800 metres.</p>	
Race 2	LAWNMASTER MAIDEN 3YO 1200
<p>COMPLEX (J Mudhoo) - Raced greenly in the early and middle stages and going into the first bend commenced to race ungenerously when being steadied by the rider. J Mudhoo was shown footage of his ride in the presence of the Riding Master.</p> <p>DIVINE SPIRIT (C O’Beirne) - Slow away. Improved onto the heels of the runner ahead near the 600 metres and had to be steadied.</p> <p>NIGHT ROCA (C Barnes) - Briefly raced in restricted room passing the 200 metres.</p> <p>LINCOLN THE FOX (D Turner) - Lay in under pressure passing the 200 metres.</p> <p>BLUE RATA BOLDNESS (L Hemi) - Raced in restricted room passing the 200 metres.</p> <p>SWEET JINEEN (N Parmar) - Raced wide throughout.</p>	
Race 3	ABERDEEN ON BROADWAY 1200
<p>STEPTOE – L Allpress replaced S O’Malley (overweight).</p> <p>PURE INCANTO (L Douglas) - Attempted to buck shortly after the start losing considerable ground. Connections were advised PURE INCANTO, which had trialled successfully after bucking at its previous start, must trial again to the satisfaction of Stewards. Trainer J Millar advised she will consider altering the mare’s gear prior to trialling in an attempt to improve the racing manners of PURE INCANTO. Improved up onto heels at the 100 metres having to be steadied.</p> <p>HORLISTIC (A Mudhoo) - Restrained off heels passing the 800 metres. Raced wide throughout.</p> <p>MY FATHER’S GUN (D Turner) - Made the bend awkwardly bumping JUGADOR. Lost the off-hind plate during the running.</p> <p>JUGADOR (C Dell) - Bumped 400 metres.</p>	
Race 4	NOEL EALES MEMORIAL 1400
<p>BOLD MAC (S Macnab) - Fractious in its barrier prior to the start. Lay out and bumped MAHOE passing the 200 metres and continued to lay out over the concluding stages.</p>	

NOD OF THE HEAD (L Douglas) - Began awkwardly and was slow away. Awkwardly placed on heels passing the 800 metres and steadied. Apprentice L Douglas was shown footage of the start in the presence of the Riding Master with regard to his balance at the beginning of a race.

GO JAMES (H Schofer) - Raced wide throughout.

POWER 'N' GLORY (M Singh) - Raced wide early and middle stages.

FLYING SURF (F Lazet) - Lay in passing the 300 metres.

MAHOE (D Bradley) - Bumped 200 metres.

H Schofer (GO JAMES) - Spoken to regarding her use of the whip on a runner out of contention.

Race 5 | **MORE FM 1200**

KICK START (M Singh) - Slow away.

GRAND MAYSON (C O'Beirne) - Slow away. Lugged outwards passing the 500 metres.

NEED I SAY MORE (J Parkes) - Held up rounding the final bend.

Race 6 | **JAPAC HOMES 2100**

HE NO OPILIO (C O'Beirne) - Wide throughout. Lay in passing the 300 metres.

PLATINUM SPIRIT (L Allpress) - Steadied off heels passing the 1200 metres.

CASINO EL JAY (F Lazet) - Hung outwards passing the 400 metres.

SUPER SPIRIT (C Dell) - Raced in restricted room passing the 400 metres.

CHAMPAGNE SUNDAY (L Hemi) - Finished a distant last. Rider advised the gelding failed to stay the distance.

LINCOLN STAR (H Schofer) - Held up entering the home straight, gaining clear running inside the final 200 metres.

C Dell (SUPER SPIRIT) – Spoken to regarding his use of the whip prior to the 100 metres.

C Rauhihi (HE NO OPILIO) - Issued with a warning for his late declaration of rider for HE NO OPILIO.

Race 7 | **TUI BACKING A WINNER SINCE 1889 1550**

HA'PENNY BRIDGE (K HercocK) - Reared as the start was effected and was considerably slow away, losing all chance. Stewards requested a ruling from the Adjudicator who declared HA'PENNY BRIDGE did receive a fair start. Connections were advised that HA'PENNY BRIDGE must barrier trial to the satisfaction of Stewards prior to racing next. Co-trainer G Lowry advised the gelding is no longer a racing proposition from their stable.

LANGKAWI (S McKay) - Restrained to the rear from a wide draw.

CAGE PHYTA (C Barnes) - Raced wide.

PUTORINO (H Schofer) - Briefly held up prior to entering the home straight. Lay out over the concluding stages.

Race 8 | **MANAWATU STANDARD SUMMER CUP 1550**

SWISSWATCH (S McKay) - Began awkwardly.

SKARLOEY (L Allpress) - Slow away.

FATHER LENIHAN (C Dell) - Began awkwardly, settling at the rear.

PASSIONE (S Macnab)- Began awkwardly. Made the final bend awkwardly.

PEP TORQUE (C O'Beirne) - Raced wide without cover throughout.

SINARAHMA (H Schofer) - Held up passing the 200 metres, and when being angled out dictated RANGITATA outwards onto TAMAHINE, which was dictated wide. H Schofer was advised to exercise greater care when shifting ground.

RANGITATA (D Bradley) - Dictated outwards 200 metres.

TAMAHINE (L Hemi) - Dictated wide 200 metres.

THE MITIGATOR (N Parmar) - Finished well back. When questioned rider had no tangible excuse.

K Hercocck (LOVE FOR ALL) - Admitted a charge of using the whip in 2 consecutive strides on her mount inside the final 100 metres. After considering submissions the Adjudicator imposed a fine of \$575.

Race 9

NZB INSURANCE PEARL SERIES RACE 1550

TRANSITORY (S Macnab) - Late scratching at 4.32pm on veterinary advice.

SHEZABELTER (L Douglas) - Tightened at the start when runners either side shifted ground, settling several lengths last. Held up over the concluding stages.

CARLINGFORD BAY (C Dell) - Over-raced passing the 900 metres. Held up rounding the turn.

SUNLIT LANE (D Turner) - Held up rounding the turn.

LITTLE WING (M Singh) - Lay out over the concluding stages.

HIGH FREQUENCY (L Hemi) - Raced wide without cover throughout.

KOOL CHOUXZ (S McKay) - Held up early in the home straight prior to being angled inwards to improve passing the 200 metres.
