Race 7 – THE ALLEVIATE ADMINISTRATION HASLETT STAKES OPEN (1200 metres)

A stable representative advised that SUMMER MONSOON which had raced disappointingly had undergone a further veterinary inspection upon return to the Christchurch stable which revealed the gelding to have suffered from travel sickness. It was further advised that SUMMER MONSOON would be given a few quiet days to recover before traveling back to its home stable at Matamata.

RACE COMMENTS

Race 1 | **KINGS (TKA) FAMILY FOOTWEAR SPRINT MAIDEN 1200m**

Trainer **J Blackadder** (DENY) - Issued with a warning after presenting DENY without the notified blinkers.

The start was delayed due to several runners proving difficult to load.

SHOW US PLENTY (Y Atchamah) - Late scratched at 1.00 pm after refusing to load. The connections were advised that the gelding must barrier trial satisfactorily prior to racing next.

ALL TICKETYBOO (S Toolooa) - Began awkwardly losing ground.

DENY (K Mudhoo) - Began awkwardly losing some ground.

BELLA BROOK (B May) - Slow to begin. Got its head up when being restrained in the early stages making the bend awkwardly passing the 1000 metres.

VAN DIESEL (R Mudhoo) - Began awkwardly shifting outwards making contact with **CAPTAIN**. Held up early in the straight having to shift outwards across heels to obtain clear running near the 300 metres.

CAPTAIN (J Lowry) - Contacted shortly after the start. Raced three wide without cover.

WHATA SHAMBLES (D Montes de Oca) - Over raced outside the leader in the early to middle stages. Rider dropped his whip near the 250 metres.

CHRISTOPHE VERMER (T Comignaghi) - Had to be restrained when improving onto heels passing the 600 metres.

ZACAT (C Johnson) - Held up in the straight until improving into a tight run to the inside of **SPORT MODE** near the 150 metres.

The track was downgraded to Heavy 10 retrospective to Race 1.

FAME SHINES (B Murray) - Taken back from a wide draw to obtain cover. When questioned regarding performance rider advised that the gelding had failed to cope with today's track conditions. A post race veterinary inspection of the gelding which had raced disappointingly to finish a distant last did not reveal any obvious abnormality.

YEAH RIGHT (T Moseley) - Taken back from a wide draw to obtain cover. Had to be steadied when placed in restricted room to the inside of **OUR ROSETTE** (C Johnson) near the 900 metres, contributing was some outward movement from **CEDDY SMITH**. C Johnson was advised to exercise care.

GLOBAL STAR (R Mudhoo) - Inconvenienced near the 50 metres when **ONCEACONNER** shifted inwards slightly under pressure.

Race 3	LASER ELECTRICAL TIMARU 1200 1200m

The start was delayed approximately 4½ minutes due to several runners proving difficult to load.

DAUPHINE (D Montes de Oca) - Proved difficult to load.

MELODY ROXX (C Barnes) - Proved difficult to load.

SKAABOOM (K Mudhoo) - Slow to begin.

RADEGAST (R Mudhoo) - Began awkwardly losing ground.

AVITUS (J Laking) - Was inclined to get its head up through the early stages.

PLAY THE FIELD (B May) - Raced three wide without cover through the early to middle stages.

ZAC BLACK (Y Atchamah) - Held up early in the run home until near the 200 metres.

Race 4 | **JON SNOW @ CLEARVIEW PARK HANDICAP 1200m**

OKAY PAL (C Johnson) - Slow away.

BLAIR FLIGHT (J Laking) - Raced keenly in the middle stages. When questioned regarding performance rider advised that the gelding had been unable to quicken in today's track conditions.

DARCI PALMER (K Chowdhoo) - Had to be steadied early in the straight to shift outwards across heels to obtain clear running.

MEARA MARY (T Comignaghi) - Contacted just short of the finish when OKAY PAL shifted outwards under pressure.

Race 5 | **CATERING SOUTH CANTERBURY MILE 1600m**

LEADERBOARD (S Toolooa) - Slow to begin.

ELIZABETH ROSE (K Chowdhoo) - Over raced in the early stages.

Race 6 | **NZB INSURANCE PEARL SERIES RACE 1600m**

TOO FERLAXED (J Laking) - Slow away.

EKSTREMEMISS (K Mudhoo) - Slow away.

MADAM SEQUOIA (T Jonker) - Had to angle outwards across the heels of the weakening SHE SPEEDS near the 150 metres. When questioned regarding her ride, T Jonker advised that after beginning well she had eased her mount which is its normal racing pattern, adding that it generally performs best when ridden in the open. T Jonker concurred with Stewards that she may have allowed her mount to lose too much ground in the early stages which she had been unaware of at the time. T Jonker added that MADAM SEQUOIA had never felt comfortable in today's track conditions, and coming around the final turn she had initially elected to remain on the inner in an attempt to save ground but it had not been until later in the race when she had got wider on the track that the mare had found the line well.

SHE SPEEDS (K Chowdhoo) - When questioned regarding performance rider advised that the mare had floundered in the track conditions near the 600 metres and failed to recover.

Race 7 | **CRAIGMORE SUSTAINABLE HOLDINGS TIMARU CUP 1600m**

PETTY'S LEGACY (T Moseley) - Co-trainer A Furlong reported that the mare had come into season. Steadied near the 800 metres when becoming awkwardly placed near the heels of GLORIOUS OCEAN when MISS TYCOON ROSE (K Chowdhoo) shifted outwards. K Chowdhoo was advised to exercise care. Held up for a distance near the 600 metres and continued to have difficulty finding clear running until near the 300 metres. Rider reported that the mare had not felt entirely comfortable in today's track conditions.

SOUTHERN OCEAN (K Mudhoo) - Slow to begin.

WHALE SONG (J Lowry) - Slow to begin.

WILLIAM WALLACE (B Murray) - Slow to begin.

OWEN PATRICK (S Muniandy) - Raced three wide without cover throughout.

MISS TYCOON ROSE (K Chowdhooory) - When asked to comment on the performance of this favoured runner, rider advised that the mare had failed to handle today's track conditions.

B Murray (WILLIAM WALLACE) - Admitted a charge in that he struck his mount WILLIAM WALLACE 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of B Murray's licence to ride in races from the conclusion of racing on Thursday 30 December until the conclusion of racing on Thursday 6 January, 6 national riding days, and in addition imposed a fine of \$800.

Race 8 | **CENTRAL SI OWNERS & TRAINERS 1600 MAIDEN 1600m**

FORT WILLIAM (B Murray) - Crowded leaving the barriers losing ground.

SNITZEL VANCUMB (J Laking) - Hampered leaving the barriers. Over raced in the middle stages.

Race 9 | **EQUINE VETERINARY SERVICES STAYERS 2200m**

PATSY LAD (T Moseley) - Slow to begin.

VENETO (K Kwo) - Raced wide in the early stages.

COLORADO MISS (K Williams) - Restrained to obtain cover after jumping from the outside barrier.

YOUNEVERKNOW (S Toolooa) - When questioned regarding performance rider advised that the mare failed to handle today's track conditions.

J Laking (ARE YOU CEREAL) - Stewards enquired into the manner in which rider J Laking used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.

Race 10 | **NIGHT 'N DAY PARK 2200 2200m**

AQUATTACK (T Comignaghi) - Raced wide without cover. When questioned regarding performance rider advised that the mare had failed to handle today's track conditions.

SULU SEA (K Chowdhooory) - Over raced through the early stages.
