<b>Race 1</b>	<b>GARRARD'S HORSE &amp; HOUND 1550</b>
<p><b>DRAGON REALM</b> (C Barnes) - Crowded shortly after the start losing ground.</p> <p><b>SOLID CONTACT</b> (K Asano) - Restrained behind runners shortly after the start.</p> <p><b>GARNET</b> (J Fawcett) - Raced keenly in the early and middle stages when being restrained.</p> <p><b>PRETTY GOOD</b> (S Spratt) - Contacted entering the final straight then had to be steadied passing the 150 metres when TANNAHILL shifted out slightly and LA CASA shifted inwards slightly. S Collett and W Pinn were both advised to exercise care in similar circumstances. Underwent a post-race veterinary examination which failed to reveal any abnormality.</p> <p><b>MILLENNIUM DAWN</b> (M Cameron) - When questioned regarding performance the rider could offer no excuse.</p> <p><b>TELLMESOMETHINGBOY</b> (T Thornton) - Raced three wide without cover throughout.</p> <p><b>LORD PAINTON</b> (C Grylls) – Raced wide without cover for the majority of the race.</p>	
<b>Race 2</b>	<b>NEW ZEALAND JOCKEYS ASSOCIATION 1550</b>
<p><b>LORD POLONIUS</b> (L Satherley) - Crowded shortly after the start losing ground. Held up for a distance entering the final straight.</p> <p><b>FLORAL BELT</b> (A Goindasamy) – Began awkwardly losing ground.</p> <p><b>ELLE MAKFI</b> (L Allpress) - Raced three wide without cover throughout.</p> <p><b>BEAUNE</b> (C Grylls) - Raced wide without cover passing the 900 metres.</p> <p><b>WILLY AWAY</b> (D Johnson) - Held up throughout the final straight.</p> <p><b>GINGER TOO</b> (S Spratt) - Improved onto heels passing the 500 metres having to be firmly restrained. Had some difficulty obtaining clear running rounding the bend and early in the final straight.</p> <p><b>MEMORIES ONLY</b> (J Fawcett) - Jumped a shadow near the 400 metres.</p>	
<b>Race 3</b>	<b>CAMBRIDGE EQUINE HOSPITAL MAIDEN 1550</b>

**TEXEL** (C Grylls) – Hampered shortly after the start losing ground. Steadied when placed in restricted room approaching the 50 metres.

**DAARIO** (S Collett) - Began awkwardly losing ground.

**ULAANBAATAR** (D Johnson) - Raced three wide without cover throughout.

**KING ZAZU** (M McNab) - Jumped a shadow near the 350 metres.

**TREVINO** (T Newman) - Improved onto heels passing the 150 metres having to be firmly restrained.

**IMPLICIT** (L Allpress) - Crowded having to be steadied passing the 150 metres.

**MISS INTERPRET** (A Goindasamy) - Shifted out under pressure passing the 150 metres with DAARIO improving onto its heels then shifted inwards to improve crowding IMPLICIT. A Goindasamy was advised to exercise care.

**S Collett** (DAARIO) - Issued with a warning for allowing her mount to shift in when not sufficiently clear of IMPLICIT which was crowded having to be steadied passing the 150 metres.

**Race 4** | **MARSH RACING NEW STABLES MAIDEN 1550**

**DOHA** (M Sanson) - Slow to begin.

**VALZACELLA** (D Johnson) - Hampered shortly after the start.

**DESERT ROSE** (B Rogerson) - Slow to begin.

**MOONSTRUCK** (T Thornton) - Slow to begin.

**TELEKINETIC** (M Cameron) – Raced three wide without cover passing the 1000 metres.

**SPECULATIVE** (R Elliot) - Steadied when placed in restricted room passing the 950 metres when the mare raced greenly.

**V Colgan** (CAPE GEM) - Admitted a breach in that he struck his mount more than five times prior to the 100 metres. After hearing submissions, the Adjudicative Committee imposed a fine of \$250.

**Race 5** | **MANNING INVESTMENTS LTD MAIDEN 1300**

**MY MAEBELLINE GIRL** (L Satherley) – Slow to begin.

**SCORIA** (E Nicholas) - Slow to begin.

**ALFIE OUR MATE** (E Leighton) - Slow to begin. Lay out rounding the final bend running wider on the track. Connections were advised that a warning would be placed on the gelding's record.

**SWEET TUI** (S Weatherley) - Raced ungenerously when being restrained in the early and middle stages.

**CHANDLER** (J Fawcett) – Raced wide without cover throughout.

**DEAR OH DEAR** (T Thornton) - Raced three wide without cover throughout.

**ANA D'OR** (D Danis) – Eased down by its rider in the final straight. Underwent a post-race veterinary examination which found the mare to be 2/5 lame in the right foreleg. Connections were advised that a veterinary clearance would be required prior to the mare trialling or racing next.

**GOLDEN HUE** (B Rogerson) - Lay out rounding the final bend. Jumped a shadow on the track near the 150 metres going off stride.

**T Thornton** (DEAR OH DEAR) - Admitted a charge in that she used her whip above shoulder height. After hearing submissions, the Adjudicative Committee suspended T Thornton's licence to ride in races from the conclusion of racing on Wednesday 8 September up to and including racing on Thursday 16 September, 5 national riding days and in addition imposed a fine of \$150.

<b>Race 6</b>	<b>GROUP ONE TURF BAR MAIDEN 1300</b>

**MARCHAND** (S Weatherley) - Crowded shortly after the start losing ground.

**LA FLORA BELLE** (M McNab) – Slow to begin.

**SUPERPOMPIDIOUS** (E Nicholas) - Slow to begin.

**ROWIN** (T Thornton) - Raced ungenerously when being restrained in the early and middle stages.

**EL VENCEDOR** (D Johnson) – Made the bend near the 1000 awkwardly when over-racing shifting outwards to avoid heels forcing ACAPULCO wider on the track. Had to be steadied after becoming awkwardly placed on heels passing the 800 metres.

**ACAPULCO** (J Fawcett) - Forced wider passing the 1000 metres.

**RIP VAN GOGH** (J Kamaruddin) – Steadied when placed in restricted room passing the 800 metres. Improved onto heels passing the 500 metres having to be steadied.

**SAVEZ VOUS** (C Grylls) - Crowded having to be steadied approaching the 300 metres.

**J Fawcett** (ACAPULCO) – Issued with a warning after permitting her mount to shift inwards when not clear of EL VENCEDOR which had to be steadied near the 800 metres.

**S Weatherley** (MARCHAND) - Defended a charge of careless riding in that he permitted his mount to shift out when not sufficiently clear of SAVEZ VOUS which was crowded having to be steadied approaching the 300 metres. After hearing submissions, the Adjudicative Committee found the charge proven and suspended S Weatherley's licence to ride in races from the conclusion of racing on Tuesday 7 September up to and including racing on Friday 10 September, 3 national riding days.

<b>Race 7</b>	<b>WAIKATO-BOP HARNESS RACING 970</b>

**VIVA LA BLUES** (W Pinn) - Crowded shortly after the start losing ground. Unable to obtain clear running throughout the final straight.

**FONTS DE L'ALGAR** (M McNab) - Began awkwardly.

**PRETTY ROSSA** (E Nicholas) - Hampered shortly after the start losing ground.

**FELIX FAURE** (E McCall) - Slow to begin.

**SOPHISTICARDO** (J Kamaruddin) – Slow to begin. Raced in restricted room for a distance approaching the 600 metres then had some difficulty obtaining clear running until passing the 125 metres.

**TEREINE** (D Johnson) - Began awkwardly losing ground.

**SHAMPAGNE DANCER** (K Asano) - Raced wide without cover throughout.

**ACTING OUT** (C Barnes) - Had difficulty obtaining clear running early in the final straight.

**LIVE FOR YOUR LOVE** (M Cameron) - Steadied just prior to the winning post when placed in restricted room.

**Race 8 OWNERS TRAINERS & FRIENDS SUPPORT RDA MAIDEN 970**

**DARCI'S QUEEN** (W Pinn) - Reared at the start briefly unbalancing its rider, losing ground (10L). Connections were advised that the mare would be required to barrier trial prior to racing next.

**FLYING FOR GLORY** (S Spratt) - Began awkwardly losing ground.

**SAKURA BLOSSOM** (L Allpress) - Became fractious in the barriers, beginning awkwardly losing ground. Raced wide without cover throughout. Lay out making the final bend running wide on the track.

**Race 9 ASCOT FARM MAIDEN 970**

**NIGHT NIGHT DORA** (J Fawcett) - Began awkwardly.

**NETANYAHU** (V Colgan) - Began awkwardly, then commenced to race ungenerously when being restrained in the early and middle stages. When questioned regarding performance rider advised that after being instructed to ride the gelding with cover it had raced greenly and tended to over-race, further adding the gelding had failed to finish the race off.

**ARABIAN SEA** (K Asano) - Hampered shortly after the start.

**WEEROCA** (D Danis) - Shied just prior to the winning post.

**SUPERACE** (D Johnson) – Raced three wide without cover throughout.

**GEE VEE CRYSTAL** (B Grylls) – Raced wide without cover throughout.

**Race 10 SHAW'S WIRE ROPES MAIDEN 970**

**GIMMEGOOSEBUMPS** (C Barnes) – Underwent a veterinary examination at the barrier and was declared fit to start.

**LA CAPITA** (S Weatherley) - Slow to begin. Raced greenly when awkwardly placed on heels passing the 550 metres.

**RUACH** (L Allpress) – Began awkwardly.

**IRISH RED** (J Kamaruddin) - Hampered at the start.

**BURGUNDY LASS** (L Satherley) - Blundered shortly after the start.

**SHEPHERD'S DELIGHT** (M McNab) – Clipped a heel and blundered after improving onto heels near the 500 metres.

**L Allpress** (RUACH) – Reprimanded for striking her mount in consecutive strides inside the 100 metres.

<b>Race 11</b>	<b>WAIPA EARTHWORKS MAIDEN 2000</b>
<b>BROTHER MAX</b> (E Nicholas) - Slow to begin. Shifted in to improve approaching the 100 metres.	
<b>SKY OASIS</b> (K Asano) – Began awkwardly. Raced keenly in the early and middle stages.	
<b>WHILE YOU'RE THERE</b> (L Satherley) - Crowded leaving the barrier.	
<b>PEARL HART</b> (D Johnson) - Restrained from its wide barrier.
