### RACE COMMENTS

**Race 1** | **AQUASHIELD ROOFING MAIDEN 2100**

**BERRY THE CASH** (L Allpress) – Tightened shortly after the start when in restricted room. Raced three wide without cover for the majority.

**SUPER SPIRIT** (C Dell) – Lay outwards on jumping away hampering UMUTAH LAD. Shied leaving the home straight on the first occasion.

**MOVINONBYE** (A Mudhoo) – Jockey A Mudhoo was questioned into his decision to shift wide near the 350 metres when the opportunity to improve into a gap between ESTABLISHMENT and DEMETRIAS eventuated. A Mudhoo, in the presence of the riding master advised that his mount was unable to quicken sufficiently, and he had concerns about the gap narrowing so elected to angle wide. Stewards were satisfied that his finishing position was not compromised.

**Race 2** | **THOROUGH BRED EXCHANGE HANDICAP 1100**

**A BOX OF TRICKS** (D Hirini) - Slow away. Had to be steadied approaching the home turn when MACUSHLA (C O'Beirne) shifted out when not fully clear. C O'Beirne was shown footage in the presence of the riding master and issued with a warning.

**HOT SHOCKOLATE** (C Jones) - Momentarily steadied after the start when crossed by MACUSHLA (C O'Beirne) which was only marginally clear. C O'Beirne was advised to exercise greater care.

**THE BIG BAD WOLF** (T Taiaroa) - Raced in restricted room over the last few strides when on the heels of HOT SHOCKOLATE which shifted out under pressure. C Jones was advised to exercise greater care.

**C O'Beirne** (MACUSHLA) - Issued with a warning after permitting MACUSHLA to shift out when not fully clear of A BOX OF TRICKS which was steadied.

**Race 3** | **VETS ON RIVERBANK MAIDEN 1600**

**FIRE DANCER** (K Hercock) - Stood in its gate and was reluctant to jump away, losing all practical chance. Stewards advised connections that FIRE DANCER must trial to the satisfaction of Stewards prior to its next start.

**HUNTERVILLE HARRY** (M Hudson) - Over-raced early.

**MILLIE GEORGIA** (C Jones) - Raced wide throughout.

**TEROTI** (A Mudhoo) - Disappointed, finishing well back. Failed to quicken in the going despite the rider's urgings. Was not persevered with over the final stages. A Mudhoo advised the gelding was never comfortable in the Heavy 11. A subsequent veterinary examination did not reveal any obvious abnormalities.

**CATCHOXLATER** (L Allpress) – When questioned L Allpress advised the mare was comfortable in the going but failed to run on to any extent and was disappointing.

**Race 4** | **CAVALLO FARM & CHRIS RUTTEN BLOODSTOCK HANDICAP 1600**

**DEEP BLUE** (T Taiaroa) - Had to steady for some distance in the back straight near the 800 metres when STORMY HABIT (L Kauri) was angled inwards. L Kauri was advised to exercise greater care.

**C Jones** (GOBUYIT) - Admitted a charge in that he struck his mount GOBUYIT 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

**Race 5** | **EL CHEAPO CARS MAIDEN 1400**

**BUDDY MARVELLOUS** (F Lazet) - Trainer A Baker sought and was given permission to race BUDDY MARVELLOUS without blinkers due to the prevailing track conditions.

**MYSTERY BAR** (M Hudson) - Very slow to load. Connections were advised that a warning has been placed against the barrier manners of MYSTERY BAR.

**FRAULEIN** (K Hercock) - Began awkwardly.

**MYSALLY** (L Allpress) - Tightened and lost ground at the start when runners either side shifted ground.

**DEE DEE SMASH** (C Jones) - Unbalanced when bumping with MY SALLY when tightened at the start.

**HERMES** (M Singh) - Steadied out of a narrow run shortly after entering the home straight when there was simultaneous movement from MAROTIRI MARSTA (L Hemi) which shifted in and FABULOUS NANCY (C Dell) which shifted out. C Dell was reminded of his obligations when shifting ground and issued with a warning.

**C Dell** (FABULOUS NANCY) - Issued with a warning for permitting his mount FABULOUS NANCY to shift out near the 350 metres when not clear of HERMES.

Race 6

NORWOOD MANAWATU HANDICAP 1400

**MONKEY TOWN** (T Taiaroa) - Began awkwardly losing ground.

**M Singh** (MY FATHER'S GUN) - Admitted a charge in that he struck his mount MY FATHER'S GUN 6 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

**C Jones** (SECRET SQUIRREL) - Admitted a charge in that he struck his mount SECRET SQUIRREL 7 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of his license to ride in races from the conclusion of racing on Thursday, 16 September until the conclusion of racing on Sunday, 26 September, 5 national riding days.
