PLATINUM EAGLE (D Turner) - Trainer L Latta reported to Stewards an endoscopic examination of the horse was completed at the stable on Tuesday, 4 January, which revealed PLATINUM EAGLE to be suffering from a mild respiratory infection requiring antibiotics.

RACE COMMENTS

Race 1 | **JCE CONSTRUCT 3YO 1400**

YEABOI (J Kamaruddin) - Began awkwardly losing ground.

EXTRAORDINAIRE (S Macnab) - Began awkwardly losing ground. Raced keenly in the early and middle stages. Lay in when placed under pressure in the final straight.

RAURIMU (M Hudson) - Raced keenly in the early stages.

A Mudhoo (MARTINA DIVA) - Spoken to regarding the manner with which he used his whip in the home straight (arm above shoulder height).

Race 2	RIVERSTONE CAFE MAIDEN 1200
<p>QUATORZE (C O'Beirne) - Slow to begin.</p> <p>TENZING (R Elliot) - Began awkwardly and shifted out making contact with ROYAL FLOWER. Held up until near the 200 metres. When questioned into his ride, in particular his decision not to angle out to improve near the 500 metres when able to do so, R Elliot advised his mount raced greenly and had not travelled in the middle stages and he was of the opinion his best option was to conserve ground by making his run in the home straight closer to the rail.</p> <p>ROYAL FLOWER (L Hemi) - Contacted shortly after the start, then crowded. Had difficulty obtaining clear running early in the final straight.</p>	
Race 3	VETS ON RIVERBANK HANDICAP 1200
<p>LITTLEREDCORVETTE (L Douglas) - Blundered on jumping away, shifting outwards abruptly and as a result lost ground.</p> <p>BRITISH ROYALTY (S Macnab) - Knuckled on jumping away. Steadied after becoming awkwardly placed on heels, dropping back on to GURTLYN, which had to be firmly restrained passing the 850 metres. Had difficulty obtaining clear running early in the final straight.</p> <p>JUSTASKPERCY (K HercocK) - Raced three wide without cover throughout.</p> <p>GURTLYN (A Mudhoo) - Improved on to heels passing the 850 metres, having to be firmly restrained.</p> <p>PERFECTSISTER (C Dell) - Rider C Dell was observed to relax his ride over the final few strides. C Dell advised he considered something amiss with PERFECT SISTER so did not ride the filly out to the finish. A subsequent veterinary examination revealed a slow recovery rate.</p>	
Race 4	NZB INSURANCE PEARL SERIES RACE 1200
<p>HYDRO CHARM (C Dell) - Knuckled shortly after the start.</p> <p>BE FLEXI (J Parkes) - Crowded shortly after the start.</p> <p>PRINCESS BIDDY (S Macnab) - Inconvenienced passing the 700 metres after becoming placed on the heels of LONDON POINT (L Allpress), which shifted out when not fully clear. L Allpress was advised to exercise care. Lay out entering the final straight making contact with WINKLE BAY. Made contact with WINKLE BAY on several occasions passing the 100 metres, when in restricted room.</p> <p>WINKLE BAY (L Douglas) - Contacted and forced wider rounding the final bend. Lay in when placed under pressure in the final straight. Made contact with PRINCESS BIDDY on several occasions passing the 100 metres.</p> <p>ISLA GRACE (M Hudson) - Returned to the enclosure with blood present in the left nostril. Underwent a post-race veterinary examination which revealed a minor laceration inside the left nostril.</p> <p>CYA MARIA (D Turner) - Contacted the running rail passing the 800 metres when racing greenly, then was not persevered with for the remainder of the race. When questioned regarding performance rider advised the mare had raced greenly throughout and failed to hit out when placed under pressure. A post-race veterinary examination did not reveal any obvious abnormality.</p> <p>LONDON POINT (L Allpress) - Shifted out and away from BE FLEXI approaching the 100 metres, with PRINCESS BIDDY shifting outwards to avoid the heels of LONDON POINT, making contact with WINKLE BAY on several occasions.</p>	

Race 5	THE TELEGRAPH HOTEL OTAKI MAIDEN 1400
<p>IVY DAZZLER (A Mudhoo) - Underwent and passed a pre-race veterinary examination after contacting the outside fence. A Mudhoo was advised to exercise greater care after allowing his mount to shift in near the 800 metres when not fully clear of LIQUID LES, which was steadied and angled outwards and in doing so hampered WINNIE ROSE.</p> <p>DARLINGTON COUNTY (M Hudson) - Slow to begin.</p> <p>RED ROSCOE (L Douglas) - Began awkwardly losing ground. Steadied when placed in restricted room passing the 500 metres.</p> <p>HERMES (T Allan) - Slow to begin.</p> <p>WINNIE ROSE (S Macnab) - Hampered near the 800 metres.</p> <p>LIQUID LES (D Turner) - Steadied to avoid heels near the 800 metres. Steadied passing the 400 metres. A subsequent veterinary examination revealed the gelding to have been galloped on incurring superficial abrasions.</p> <p>TITLED (R Elliot) - Held up for some distance approaching the home turn and early in the home straight prior to being angled inwards near the 300 metres to improve.</p> <p>MCDREAMY (J Parkes) - Raced wide without cover for the majority of the race.</p> <p>TAVIFERN (L Allpress) - Raced three wide without cover for the majority of the race.</p> <p>A Mudhoo (IVY DAZZLER) - Spoken to after making a celebratory gesture just prior to the winning post.</p>	
Race 6	AQUASHIELS ROOFING MAIDEN 1600
<p>CEE ARE EL – Late scratching at 4.04pm on veterinary advice.</p> <p>JENEVER (S Macnab) - Slow to begin (3L).</p>	
Race 7	CAVALLO FARM & CHRIS RUTTEN BLOODSTOCK HANDICAP 1600
<p>WHITE LIGHTNING (A Mudhoo) - Knuckled on jumping away, losing ground as a result. Lay out rounding the bend. Improved on to heels passing the 100 metres.</p> <p>CHASE (D Turner) - Slow to begin.</p> <p>SURPRIZE ME (L Hemi) - Began awkwardly. Raced three wide without cover throughout.</p> <p>IF YOU DANCE (S Macnab) - Raced in restricted room over the concluding stages.</p> <p>EXALTATION (J Kamaruddin) - Lay in over the concluding stages having to be straightened.</p> <p>C O'Beirne (BRUNO MAGILE) - Stewards looked at the ride of C O'Beirne on BRUNO MAGILE and were satisfied that the whip rule was not contravened.</p>	
Race 8	EL CHEAPO CARS HANDICAP 2100
<p>MASSO (L Douglas) - Began awkwardly losing ground.</p>	

CISJURANE (C O'Beirne) - Slow to begin (3L). Rider reported that the mare had made the bend awkwardly and may have struck itself.

NITRO TED (D Turner) - Held up early in the final straight.

NOT A BRASS RAZOO (S Macnab) - Held up early in the final straight.

ALMERAKE (M Hudson) - Raced wide without cover throughout. Hampered approaching the 600 metres when FREE SPIRIT shifted outwards slightly and PRINCE TURBO (D Bradley) shifted inwards when improving. Also hampered as a result was FAMILY TIME. D Bradley was advised to exercise care.

FAMILY TIME (R Elliot) - Hampered passing the 600 metres.

ROAD DIVA (A Mudhoo) - Improved on to heels near the 500 metres, having to be steadied.
