| Race 1 | RICHARD SIMPSON CONTRACTING 3YO 1400 |
| PRIORESS (S Macnab) - Slow to begin. Improved on to heels approaching the 150 metres, having to be steadied. | |

REIGN IT IN (K Asano) - Began awkwardly. Held up until shifting outwards passing the 200 metres.

NEST EGG (H Schofer) - Restrained in the early stages to obtain cover from its wide barrier.

L Hemi (THIRD TIME ROUND) - Admitted a charge of using the whip in 2 consecutive strides on her mount inside the final 100 metres. After considering submissions the Adjudicator imposed a fine of \$150.

Following Race 1 the track was upgraded to Dead 4 retrospective to Race 1.

Race 2 | **SPREADING RURAL BULK 1200**

LA QUERIDA (D Bradley) - Slow to begin.

HORLISTIC (K Hercock) - Knuckled shortly after the start.

BRADMAN (J Kamaruddin) - Made the bend near the 800 metres awkwardly when racing wide and laying out.

HYDROEXPRESS (S McKay) - Inclined to lay inwards near the 200 metres.

Race 3 | **TOM TROTTER MEMORIAL 1100**

MALO BIK (L Douglas) - Lost its footing on jumping away.

SCOTCH (S Macnab) - Began awkwardly then restrained in the early stages to obtain cover.

MEHRTENS (A Mudhoo) - Slow to begin.

M Hashizume (DARCI LA BELLA) - Admitted a charge of using the whip in 3 consecutive strides on his mount inside the final 100 metres. After considering submissions the Adjudicator imposed a fine of \$300.

Race 4 | **CENTRAL ITM 1400**

KICK START (K Hercock) - Slow to begin. Improved on to heels passing the 700 metres having to be steadied.

LIFFEY (C O'Beirne) - Slow to begin. Held up for a distance approaching the 150 metres.

MAHOE (D Bradley) - Blundered on jumping away.

IFINDOUBTGETOUT (J Mudhoo) - Raced ungenerously in the early and middle stages when being restrained. Finished well back. When questioned J Mudhoo advised the gelding over-raced throughout and had little left at the finish.

LANGKAWI (N Parmar) - Held up early in the final straight.

SUMI (M Hashizume) - Held up early in the home straight until near the 200 metres, before being angled inwards to improve.

SEAAPRINCE (L Allpress) - Raced three wide without cover throughout. Lost the nearside hind plate during the running.

D Bradley (MAHOE) - Admitted a charge of using the whip in 8 consecutive strides on his mount inside the final 100 metres. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing today, Saturday, 8 January until the conclusion of racing on Wednesday, 19 January, 5 national riding days and in addition imposed a fine of \$100.

| <p>TE AKAU CALIBURN (J Kamaruddin) - Slow to begin. Held up for a distance approaching the 400 metres.</p> <p>NO ROCK NO POP (A Mudhoo) - Began awkwardly then crowded shortly after, losing ground.</p> <p>KELLY COE (M Hudson) - Had to be steadied approaching the 1000 metres when WILD MOOSE (L Allpress) shifted in when only marginally clear. KELLY COE was then angled outwards abruptly to avoid heels and in doing so hampered AOTEA LAD (N Parmar), which was dictated outwards. Also inconvenienced was COLORADO STAR. L Allpress was advised to exercise more care when shifting ground. M Hudson was issued with a warning for shifting ground when not clear.</p> <p>AOTEA LAD (N Parmar) - Hampered and dictated outwards 1000 metres.</p> <p>COLORADO STAR (J Parkes) - Inconvenienced 1000 metres. Held up early in the final straight.</p> <p>M Hudson (KELLY COE) - Issued with a warning after permitting KELLY COE to shift outwards when not sufficiently clear of AOTEA LAD, which was hampered and dictated outwards near the 1000 metres.</p> | |

| <p>BALALAIKA (J Parkes) - Slow to begin.</p> <p>MY FATHER'S GUN (J Kamaruddin) - Slow to begin.</p> <p>PODKAST (D Turner) - Began awkwardly. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p> <p>SHADY GREY (A Mudhoo) - Began awkwardly.</p> <p>TRANSITORY (S Macnab) - Held up for a distance passing the 400 metres.</p> | |
| Race 7 | JAPAC HOMES MARTON CUP 2200 |
| <p>HE NO OPILIO (C O'Beirne) - Crowded shortly after the start. Steadied when placed in restricted room approaching the 500 metres when runners either side shifted ground. Hampered passing the 400 metres.</p> <p>MOTIVATION (L Hemi) - Slow to begin then crowded shortly after.</p> <p>MARIETTA LANE (C Burdan) - Checked when racing in restricted room entering the back straight near the 1500 metres and went back onto PRINCE LEO, which was also checked. After questioning riders and viewing video footage, which was inconclusive, no further action was taken.</p> <p>PRINCE LEO (A Mudhoo) - Checked 1500 metres.</p> <p>LEADERBOARD (K Asano) - Raced wide without cover for the majority of the race. Steadied after becoming awkwardly placed near heels approaching the 400 metres dropping back onto HE NO OPILIO which had to be steadied.</p> <p>WAI SAKE (D Turner) - Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p> | |

| <p>P McKay (IRON EAGLE) - Issued with a warning for presenting IRON EAGLE with incorrect gear (blinkers). 616(4).</p> | |

THAT'S INCRANIBULL (H Schofer) - Slow away. Improved on to heels passing the 500 metres, having to be steadied.

BENTAYGA (K Asano) - Slow away. Had to steady off heels when the pace eased near the 1300 metres.

BOBBY DEE (S O'Malley) - Slow away. Raced wide without cover throughout.

HEIRLOOM (M Hudson) - Had to steady off heels when the pace eased near the 1300 metres.

HINEPARA (A Mudhoo) - Had to steady off heels when the pace eased near the 1300 metres.

IRON EAGLE (S McKay) - Made the final bend awkwardly.

SERGIO (J Parkes) - Made the final bend awkwardly.

H Schofer (THAT'S INCRANIBULL) - Admitted a charge in that she struck her mount THAT'S INCRANIBULL 6 times prior to the 100 metre mark. After considering submissions the Adjudicator suspended her licence to ride in races from the conclusion of racing on Saturday, 15 January until the conclusion of racing on Thursday, 27 January, 5 national riding days.
