**GENERAL**

D Johnson advised Stewards on race morning that she was unwell and wouldn't be attending today's race meeting. A medical clearance is required from D Johnson prior to riding next.

**SUPPLEMENTARY****RACE COMMENTS****Race 1 THE PATRON'S MAIDEN HURDLE (3100 metres)**

**OUR CRAFTSMAN** (E Farr) - Raced keenly in the early stages.

**HAERE UP** (L Douglas) - Raced keenly in the early stages. Jumped indifferently throughout. Pulled up prior to jumping the final fence.

**CAPELLANI** (N Downs) - Hit the fence near the 1000 metres.

**TRUEMAN** (S Phelan) – Clipped a heel and blundered passing the 1900 metres. Pulled up prior to jumping the fence near the 1000 metres. Underwent a post-race veterinary examination which failed to reveal any abnormality.

**ROC YA SOX** (M Cropp) – Put in a poor jump at the second to last fence. Pulled up prior to jumping the final fence.

**VANGUARD** (D Parker) – Hit the final fence.

**E Farr** (OURCRAFTSMAN) - Admitted a charge of careless riding in that she permitted her mount OUR CRAFTSMAN to shift outwards when not sufficiently clear of TRUEMAN which struck a heel and blundered near the 1900 metres. After hearing submissions, the Adjudicative Committee suspended E Farr's licence to ride in races from the conclusion of racing on Sunday 19 September up to and including racing on Thursday 23 September, 1 national riding day and in addition imposed a fine of \$500.

**B Lammas** (IMA WONDER, ALFIE DEE - R3) - Admitted a charge in that he failed to make the declared riding weight for IMA WONDER and ALFIE DEE (R3). After hearing submissions, the Adjudicative Committee imposed a fine of \$200.

**Race 2 PAKURANGA HUNT LIFE MEMBERS MAIDEN HURDLE (3100 metres)**

**IZYMYDAAD** (S Karnicnik) - Slow to begin. Hit the final fence and knuckled on landing.

**TELL ME MORE** (G Walsh) – Pulled up prior to jumping the final three fences.

**SKY BALJO** (B Lammas) - Pulled up prior to jumping the final three fences.

**ZENNTARI** (D Parker) – Pulled up prior to jumping the final two fences.

**BULLITT** (N Downs) – Hampered after jumping the second to last fence by the fallen runner. Hit the final fence.

**MATARO** (S Fannin) - Hit the second to last fence then knuckled on landing falling to the track, dislodging its rider. Underwent a post-race veterinary examination which revealed lacerations in the nasal area and a minor laceration to the left stifle. S Fannin was attended to by the on-course Doctor and cleared to fulfil his remaining rides.

**Race 3 RMS CONTRACTING OPEN HURDLE (3100 metres)**

**DR HANK** (S Phelan) - S Phelan was given permission to ride the gelding 1 kg overweight due to there being no suitable replacement rider available. Hit the third to last fence.

**ALFIE DEE** (B Lammas) - B Lammas was given permission to ride the gelding 1 kg overweight due to there being no suitable replacement rider available. Crowded having to be firmly restrained after jumping the second fence.

**RICHARD OF YORKE** (S Karnicnik) - Shifted inwards when jumping the second fence crowding AIGNE inwards onto ALFIE DEE. Pulled up prior to jumping the final two fences. Underwent a post-race veterinary examination which revealed the gelding to be lame in the left hind leg. Connections were advised that a veterinary clearance would be required prior to racing next.

**AIGNE** (D Parker) - Crowded having to be firmly restrained after jumping the second fence.

**KAHARAU** (E Farr) – Hit the fourth fence. Hit the second to last fence.

**BANKS ROAD** (G Walsh) - Jumped indifferently throughout. Pulled up prior to jumping the final three fences.

**TOMMYRA** (C Thornton) - Pulled up prior to jumping the final two fences. Underwent a post-race veterinary examination which failed to reveal any obvious abnormality.

**CURIOUS GEORGE** (L Douglas) - Hit the final fence.

**ENGLISH GAMBLER** (S Fannin) – Hit the final fence unbalancing its rider who was dislodged. S Fannin was attended to by the on-course Doctor and cleared to fulfil his remaining riders.

**REMARX** (M Cropp) – Put in a poor jump at the second to last fence. Hampered after jumping the final fence when taking evasive action to avoid the fallen rider.

**S Phelan** (DR HANK) – Admitted a charge in that he failed to make the declared riding weight for DR HANK. After hearing submissions, the Adjudicative Committee imposed a fine of \$300.

**HEISTHEONE** (E Farr) - Raced keenly in the early to middle stages. Knuckled after jumping the fence near the 1200 metres. Lost left hind plate during the running.

**FLYINGWITHOUTWINGS** (N Downs) – Raced keenly in the early to middle stages.

**EL LUCHADOR** (S Phelan) – Lost the right hind plate during the running.

**SINO HEIGHTS** (D Parker) – Hampered after jumping the fence near the 1600 metres

**MAGIC CANNON** (G Walsh) - Hampered after jumping the fence near the 1600 metres.

**CAPTAINS RUN** (M Cropp) – Raced in restricted room prior to jumping the fence near the 1000 metres. Placed in restricted room near the 700 metres having to be steadied.

**N Downs** (FLYINGWITHOUTWINGS) - Admitted a charge of using the whip in three consecutive strides on FLYINGWITHOUTWINGS over the concluding stages. After hearing submissions, the Adjudicative Committee imposed a fine of \$400.

**KIPKEINO** (N Downs) – N Downs was given permission to ride the gelding 1 kg overweight due to there being no suitable replacement rider available. Badly misjudged the first fence and fell. N Downs was attended to by the on-course Doctor and cleared of any injuries. Underwent a post-race veterinary examination which revealed lacerations inside both nostrils.

**TITTLTATTLE** (G Walsh) - Slow to begin. Pulled up prior to jumping the final fence.

**TE KAHU** (M Cropp) – Put in a poor jump at the second to last fence. Raced in restricted room passing the 100 metres.

**IT'S A WONDER** (S Phelan) – Pulled up prior to jumping the fence near the 1000 metres. When questioned regarding performance rider S Phelan advised that the gelding had felt indifferent in its action racing down the back straight. Underwent a post-race veterinary examination which failed to reveal any abnormality.

**ZARTAN** (S Fannin) - Hampered by the riderless horse passing the 400 metres.

**S Fannin** (ZARTAN) - Admitted a charge in that he struck his mount ZARTAN twelve times prior to the 100 metres. After hearing submissions, the Adjudicative Committee imposed a fine of \$450.

**N Downs** (KIPKEINO) - Admitted a charge in that he failed to make the declared riding weight for KIPKEINO. After hearing submissions, the Adjudicative Committee imposed a fine of \$200.

**Race 6** | **WADE EQUINE COACHES AMATEUR 2200**

**ELLE D'BERRY** (C Isdale) - Crowded shortly after the start having to be steadied.

**LOT OF ZEES** (A Scott) - Crowded shortly after the start having to be steadied.

**BRUCIE** (S Malki) – Slow to begin.

**LEICA WARRIOR** (S Van Lierde) - Crowded shortly after the start having to be steadied. Improved into insufficient room inside of FORTUNE WINGS approaching the 200 metres then had to be firmly restrained for a distance until shifting outwards passing the 50 metres to obtain clear running.

**AL'S RED ZED** (L Zydenbos) - Had difficulty obtaining clear running early in the final straight.

**Race 7** | **VETERINARY ASSOCIATES EQUINE 1200**

**GOSPODIN** (W Pinn) - Contacted the front of its barrier stall after anticipating the start, forcing its gate to open slightly quicker and as a result began awkwardly. Stewards were satisfied the gelding did not gain any advantage by the gate being forced open early.

**DIVINE DIVE** (A Goindasamy) - Restrained from its wide barrier draw.

**AERO DE PARIS** (M Sanson) – Raced in restricted room passing the 150 metres when runners either side shifted ground.

**M Sanson** (AERO DE PARIS) - Reminded of her obligations in that she must ride her mounts out fully to the end of the race when circumstances permit her to do so.

**Race 8** | **THE HUNTSMAN'S MUSICAL MILE (1600 metres)**

**VERRY FLASH** (K Asano) - Slow to begin. Raced keenly when the pace steadied passing the 800 metres.

**MONT VENTOUX** (M McNab) - Slow to begin.

**HUSK** (T Thornton) – Slow to begin. Held up early in the final straight.

**LE SABLIER** (E Nicholas) – Raced three wide without cover throughout. Contacted and forced wider approaching the 700 metres by TEEN TITAN which shifted out when not clear. N Parmar was advised to exercise care.

**N Parmar** (TEEN TITAN) - Issued with a warning for raising his arm above shoulder height when using the whip.

**Race 9**

**BRIDGES INSURANCE SERVICES (1400 metres)**

**GAGLIARDI** (B Rogerson) - Began awkwardly. Hampered passing the 450 metres by the fallen rider.

**IFFIE SHOWS** (R Elliot) - Slow to begin. Hampered passing the 450 metres by HOT PINX which shifted inwards.

**SUPERIOR SAM** (J Kamaruddin) - Crowded shortly after the start. Hampered passing the 450 metres by HOT PINX which shifted inwards.

**MIGHTY CASTLE** (E McCall) – Crowded shortly after the start.

**HOT PINX** (E Nicholas) - Clipped a heel and blundered near the 450 metres, dislodging the rider. E Nicholas was attended to by the on-course Doctor before being transferred to Waikato Hospital for further assessment. Stewards opened and adjourned an enquiry into the reason why HOT PINX clipped a heel and blundered near the 450 metres.

**FLEURGUNDY** (T Newman) – Hampered passing the 150 metres by INCA WARRIOR which shifted inwards abruptly.

**INCA WARRIOR** (W Pinn) - Shifted inwards abruptly passing the 150 metres.

**GNASHER** (K Asano) - Raced three wide without cover throughout. When questioned regarding performance rider advised that the gelding had failed to run on after racing wide without cover.

**W Pinn** (INCA WARRIOR) - Issued with a warning for permitting his mount to shift inwards passing the 150 metres hampering FLEURGUNDY.
