Race 8 INGHAM TAUPO 1800

UNDER THE PUMP (S McKay) – Trainer P Mirabelli advised Stewards that the gelding had bled following this race. Connections were advised that the gelding would now be subject to the mandatory two month stand down from training, three month stand down from racing with a veterinary certificate being required prior to trialling or racing next.

Race 3 RMS CONTRACTING OPEN HURDLE 3100

RICHARD OF YORKE (S Karnicnik) – J Richards advised Stewards that after undergoing further veterinary assessment it was discovered that the gelding had fractured its pelvis. Further advised that the gelding would now be retired.

Race 1	BOSTONIAN 1550
<p>BEAUTIFULNIGHTMARE (L Satherley) - When questioned regarding performance rider advised that in her opinion the mare had been unsuited by the synthetic surface. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p>EMBER ATTACK (T Thornton) - Had difficulty obtaining clear running early in the final straight.</p>	
Race 2	BONNEVAL MAIDEN 1550
<p>CATHAY EMPRESS (M McNab) – Was removed from the barriers after becoming fractious to undergo a veterinary inspection before passed fit to race. Raced wide without cover throughout.</p> <p>GOODO JO (C Barnes) - Slow away.</p> <p>ELUSIVE CAPITAL (S Spratt) – Jumped away awkwardly. Raced keenly for a distance in the early stages. Held up when disappointed for a run to the inside of BERGHEIM near the 200 metres.</p> <p>WINDERMERE (M Cameron) - Got its head up when being steadied off heels near the 1300 metres. Held up early in the final straight.</p> <p>LA FLORA BELLE (D Johnson) - Lay out when placed under pressure in the final straight.</p>	
Race 3	MONGOLIAN KHAN 1300
<p>FONTS DE L'ALGAR (M McNab) - Jumped away very awkwardly crowding VINCERE which lost ground.</p> <p>ELUSIVE EMPIRE (M Alam) – Restrained to obtain cover after jumping from the outside barrier.</p> <p>LANGKAWI (S McKay) - Contacted by VINCERE which shifted out slightly then raced ungenerously when being restrained shortly after the start losing considerable ground.</p> <p>VINCERE (D Johnson) - Crowded shortly after the start losing ground. Raced in restricted room for a distance entering the final straight.</p>	
Race 4	DUNDEEL 1300
<p>DEEP BEAUTY (J Kamaruddin) - Slow away.</p> <p>LELAWALA (T Newman) - Got its head up when being steadied shortly after leaving the barriers, losing ground.</p> <p>SHEZAWINKLE (S Spratt) – Raced wide throughout. Raced wide without cover throughout.</p> <p>I'M CAPABLE (W Pinn) - Raced three wide without cover throughout.</p> <p>FELIX FAURE (E McCall) – When questioned regarding the improved performance the trainer advised that the step up to 1300 metres had been of benefit.</p> <p>PURE IMAGINATION (D Johnson) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which failed to reveal any abnormality.</p>	
Race 5	SILENT ACHIEVER MAIDEN 1300
<p>BONO (S Collett) - Crowded shortly after the start having to be steadied. When questioned regarding performance rider advised that in her opinion the gelding would be better suited to a rain affected grass track.</p>	

FLAT TRACK BULLY (D Johnson) – Raced ungenerously in the early and middle stages having to shift outwards to avoid heels passing the 950 metres.

ERNIE’S TAKEN (S Spratt) - Steadied when placed in restricted room passing the 200 metres to the outside of RIP VAN GOGH which shifted out slightly. M McNab was advised to exercise care.

RIP VAN GOGH (M McNab) - Held up until passing the 200 metres.

TUMBARUMBA (C Grylls) - Had to shift out to obtain clear running passing the 200 metres.

Race 6 | **VEYRON MAIDEN 1300**

SUPER SIX (M McNab) - Slow away. Over-raced in the middle stages shifting outwards to avoid heels making contact with TRIESTE near the 900 metres forcing that runner over extra ground.

TRIESTE (C Barnes) - Slow away. Contacted and forced over extra ground near the 900 metres.

DUBAI DIVA (D Johnson) - Had difficulty obtaining clear running early in the final straight until shifting inwards passing the 100 metres.

BELLE EN ROUGE (J Kamaruddin) - Had to shift outwards passing the 150 metres to obtain clear running.

Race 7 | **NZB INSURANCE PEARL SERIES RACE 1300**

The start was delayed due to **ARABIAN SEA** requiring farrier attention behind the barriers.

LA CAPITA (C Grylls) - Declared a late scratching at 3:38 pm after refusing to load, further delaying the start. Connections were advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next.

DON’T LOOK ETHEL (S Spratt) - Bounded at the start. Raced wide without cover throughout.

TIGHTEN YOUR GRIP (D Johnson) - Slow away. Raced ungenerously in the early and middle stages.

PARIS RUBY (B Grylls) - Got its head up when being steadied near the 1100 metres dropping back onto **KOOL CHOUXZ** which was hampered.

KOOL CHOUXZ (D Danis) - Hampered passing the 1100 metres.

Race 8 | **KEEP THE PEACE MAIDEN 970**

ZEITAKU (D Johnson) – After being fractious in its barrier, jumped in the air at the start losing ground. Had difficulty obtaining clear running early in the final straight.

SHOW ME A DREAMER (B Grylls) - Slow away.

SHOW ME CHAMPAGNE (J Kamaruddin) - Slow away.

MORE THAN WORDS (C Grylls) - Jumped away awkwardly before being further hampered when crowded.

TESORINA (S Collett) - Briefly held up entering the final straight.

W Pinn (AMOROUS STU) - Questioned regarding a perceived lack of vigour in the final straight. W Pinn explained that when placed under pressure the gelding had commenced to race greenly and shift ground when he had elected to straighten the gelding. W Pinn's explanation was noted.

Race 9

MILITARY MOVE MAIDEN 2000

KRYPTONITE (M Sanson) – Began awkwardly then crowded shortly after having to be steadied.

THE ACTRESS (C Grylls) - Crowded shortly after the start having to be steadied.

THORA'S JOY (M Cameron) - Crowded shortly after the start having to be steadied.

FERDINAND (S Spratt) - Began awkwardly.

BROTHER MAX (W Pinn) - Steadied when placed in restricted room passing the 150 metres to the inside of CASPER which shifted in and to the outside of TYCOON WARRIOR which shifted outwards. K Asano and L Satherley were both advised to exercise care in similar circumstances. Lost the right front plate during the running.

CASPER (K Asano) - Lay in when placed under pressure in the final straight. Inconvenienced passing the 50 metres by THE ACTRESS which shifted out slightly.

W Pinn (BROTHER MAX) - Admitted a charge in that he failed to ride his mount BROTHER MAX out to the finish of the race when there was a reasonable chance of finishing in a higher placing. After hearing submissions, the Adjudicative Committee imposed a fine of \$300.
