Race 8 - CARO MEO BAYLEYS FASHION IN THE FIELD 1200

T Taiaroa (KAPINOS) - Following an adjourned inquiry, T Taiaroa admitted a charge of careless riding in that she permitted KAPINOS to shift inwards near the 900 metres when not sufficiently clear of TELLALL (M McNab), which was tightened and directed inwards into the line of POWER 'N' GLORY (M Singh). After considering submissions the Adjudicative Committee imposed a suspension of her license to ride in races from the conclusion of racing on 30 September until the conclusion of racing on 7 October, 5 national riding days.

Race 1	PALAMOUNTAINS NUTRITION OPEN HURDLE 3000
<p>T Moki - Fined \$100 under the Minor Infringement Schedule for failing to make the carded weight for CANDY CROSS.</p> <p>TWEEDLEDEE (S Karnicnik) - Had to be steadied near the 600 metres when over-racing. Lost ground when inclined to run its fences down throughout. Made heavy contact with MASTER FINN when jumping the fence near the 900 metres.</p> <p>ROC YA SOX (L Douglas) - Jumped the fence near the 600 metres poorly and then commenced to give ground. Landed awkwardly jumping the second last fence.</p> <p>WOTABLAST (D Parker) - Had to be steadied after jumping the fence near the end of the back straight when TWEEDLEDEE (S Karnicnik) shifted in. Retired from the event near the 400 metres when well back and out of contention.</p> <p>S Karnicnik (TWEEDLEDEE) - Issued with a warning after permitting TWEEDLEDEE to shift in near the end of the back straight when not clear of WOTABLAST, which had to be steadied.</p> <p>N Downs (BAKELA) – Stewards inquired into the manner in which N Downs used his whip in the home straight and were satisfied on this occasion he did not contravene the rule.</p>	
Race 2	WANGANUI FUNCTION CENTRE MAIDEN STEEPLE 4100
<p>VANGUARD (D Parker) - Over-raced leaving the home straight on the first occasion. Dipped on landing after jumping the fence near the 1000 metres.</p> <p>WHEREABOUTS (S Karnicnik) - Had to be steadied off the heels of VANGUARD leaving the home straight on the first occasion.</p> <p>MATOVANI (L Douglas) - Retired from the race near the 1800 metres when well back.</p> <p>HEISTHEONE (M Cropp) - Landed awkwardly at the fence near the 1200 metres.</p> <p>ZEDACE (B Lammas) - Jumped indifferently throughout when tailed off.</p> <p>PIERIAN SPRING (N Downs) - Withdrawn from the event near the straight entrance when well back.</p>	
Race 3	PRO POWDER COATING OPEN STEEPLECHASE 4100
<p>MESMERIZE (B Lammas) - Jumped the fence near the 900 metres awkwardly on the first occasion. Retired near the 600 metres when out of contention. When questioned B Lammas advised the gelding over-raced throughout and had little left at the finish.</p> <p>DAL KILCHOAN (M Cropp) - Blundered at the fence near the 1000 metres on the final occasion unbalancing the rider for a short distance.</p> <p>D Parker (BEAU GESTE) - Admitted a charge in that he used his whip on BEAU GESTE when clearly winning and after considering submissions the Adjudicative Committee imposed a fine of \$250.</p>	
Race 4	TAKE IT EASY TOURS MAIDEN 1200
<p>ONCE BITTEN (M Singh) - Over-raced in the early stages.</p>	

ROCKET SCIENCE (R Elliot) - Angled wide on the home turn to improve.

Race 5 | **CARPET MAINTENANCE & CLEANING 1200**

MIRACULOUS (B Rogerson) - Bumped with RINGTHEBELLEDARCI at the start.

RINGTHEBELLEDARCI (A Mudhoo) - Bumped at the start.

MEGEVE (A Goindasamy) - When questioned into the disappointing run of MEGEVE, rider advised the mare had not handled today's heavy track conditions.

Race 6 | **JUBEE AND CO 1340**

ROYAL PATCH (M Singh) - Finished last. Rider advised the gelding had not handled the Heavy 11 track conditions.

ATENARTIN (C O'Beirne) - Shifted in abruptly when struck with the whip near the 250 metres and bumped with HE'S A DOOZY.

HE'S A DOOZY (C Dell) - Bumped 250 metres.

L Hemi (TUMBLEWEED) - Issued with a warning for using her whip in consecutive strides over the concluding stages.

Race 7 | **WANGANUI MOTORS MAIDEN 1600**

WATUZZI (R Elliot) - Slow away and then slow into stride and settled some distance from the body of the field entering the back straight.

OREMUS (A Goindasamy) - Over-raced and steadied back straight when the pace eased.

BIG PAPI (S O'Malley) - Over-raced and steadied back straight when the pace eased. Contacted heavily and blundered near the 400 metres. Rider dropped his whip near the home straight entrance.

FOREVER WONDER (C O'Beirne) - Over-raced and steadied back straight when the pace eased.

IRISH PRAYER (L Allpress) - Over-raced and steadied back straight when the pace eased.

BEERSHEBA (F Lazet) - Raced greenly throughout and near the home turn shifted in abruptly across the heels of OREMUS and in doing so was checked and continued to shift inwards dictating HESACITYBOY inwards into the line of BIG PAPI, which blundered when making contact with the hind quarters of HESACITYBOY.

HESACITYBOY (L Hemi) - Dictated and contacted home turn.

F Lazet (BEERSHEBA) - Was shown footage of her ride in the presence of the Riding Master after she allowed her mount to shift inwards approaching the home turn resulting in her having to take evasive action to avoid the heels of OREMUS.

Race 8 | **COMMDIVES NZ 1600**

STORMY HABIT (E McCall) - Slow away.

THE SEAGULL (A Mudhoo) - Raced in restricted room entering the back straight. Buffeted 1100 metres. Briefly contacted 300 metres.

GREYSTONE (C O'Beirne) - Had to be steadied sharply near the 1100 metres when LOVE STORM (F Lazet) shifted in. After questioning riders and viewing footage it was established that LOVE STORM was not the required distance clear

when shifting ground. F Lazet was shown footage of her ride in the presence of the Riding Master and issued with a warning. Also affected was SEAGULL which was buffeted.

LAVA ROCK (L Kauri) - Gave ground quickly prior to entering the home straight. Rider was of the opinion there may be something amiss with the gelding. A post-race veterinary examination did not reveal any obvious abnormality.

ESTAFANIA (B Rogerson) - Shifted in approaching the 300 metres to obtain clear running, making contact with THE SEAGULL.

F Lazet (LOVE STORM) - Issued with a warning after LOVE STORM shifted in near the 1100 metres.

Race 9

ST JOHNS CLUB MAIDEN 2040

NOESS (S Macnab) - Over-raced in the early stages.

BROOKBOURNE (B Rogerson) - Shifted out and away from runners to its inside at the start when racing greenly and jostled with TRAMORE for a short distance. Raced greenly in the back straight and was inclined to shift out and away from runners to its inside. Clipped a heel of METALLO and blundered near the 1000 metres immediately prior to the field leaving the back straight. B Rogerson lost the use of an iron for a short distance. After viewing footage and questioning riders it was established that BROOKBOURNE lay out and away from METALLO which was racing to its inside, then jostled for a short distance with TRAMORE, whose rider L Kauri became unbalanced. The incident was considered beyond the control of either rider.

TRAMORE (L Kauri) - Jostled 1000 metres with the rider becoming unbalanced.

Stipendiary Stewards report as posted is provisional and subject to further review and amendment
