RACE COMMENTS

Race 1	HENDERSON LIVESTOCK MAIDEN (1335m)
<p>THREE OVER TWO (K Chowdhury) - Got back shortly after the start.</p> <p>TAVY ROAD (T Comignaghi) - Got back shortly after the start.</p> <p>CARLOS (S Khetoo) - Lay out rounding the final bend shifting wider on the track.</p> <p>OUR CLARRY (B May) - When asked to comment on the improved performance of the winner rider advised that after beginning well he had been able to set his own terms in front and benefitted from the shorter straight at Gore today.</p> <p>BUSH MILLS BILLY (A Bohorun) - When asked to comment on the performance rider was of the opinion the gelding is looking for more ground.</p> <p>JIMILICIOUS (J Laking) - When asked to comment on the performance rider advised the gelding had a nice run throughout however had disappointed when placed under pressure over the concluding stages.</p>	
Race 2	ADVANCE AGRICULTURE HANDICAP (1335m)
<p>EXCHANGE (J Lowry) - Slow to begin.</p> <p>DREAMING EASY (K Williams) - Slow to begin. Had to be steadied passing the 600 metres when placed in restricted room by GERRY JOYCE which stepped in momentarily. Held up over the concluding 100 metres and went to the line untested by the rider.</p> <p>NESTA (L Callaway) - Held up early in the run home, only gaining clear racing room inside the final 100 metres. When asked to comment on the improved performance Trainer S Blair-Edie advised the gelding had been racing well without much luck in its most recent starts and tends to perform at its best this time of the year.</p> <p>ZAC BLACK (S Khetoo) - Steadied passing the 100 metres when laying outwards onto the heels of RUBY ROYALE, then shifted inwards to obtain clear running passing the 75 metres.</p>	
Race 3	O'CONNOR RICHMOND MAIDEN (1200m)
<p>DORINGO (C Johnson) - Underwent a pre-race veterinary examination and was cleared to race.</p> <p>HYSPEC (S Khetoo) - Began awkwardly shifting out and crowding PINX who lost ground.</p> <p>PROBELLA (K Mudhoo) - Crowded at the start losing ground. Got its head up on a number of occasions when over-racing through the middle stages, having to be heavily restrained. Had to be shifted off heels passing the 600 metres when continuing to over-race.</p> <p>LEROY (J Lowry) - Slow to begin.</p> <p>CARISBROOK (K Rathoar) - Crowded and had to be steadied near the 800 metres. Held up by AGAINST ALL ODDS who had to be steadied near the 600 metres and again had to be steadied near the 400 metres when placed in restricted room.</p> <p>AGAINST ALL ODDS (K Selvan) - Crowded and had to be steadied passing the 600 metres when runners either side shifted ground. After speaking with riders and viewing replays which were inconclusive, Stewards took the matter no further.</p> <p>ROWIN (J Laking) - Raced wide without cover for the majority of the event.</p>	

B Murray was issued with a warning under Rule 638(3)(g)(ii) when using the whip in two consecutive strides on BEAU STITCH inside the final 100 metres.

C Johnson admitted a charge of using the whip in three consecutive strides on DORINGO inside the final 100 metres. After hearing submissions the Adjudicative Committee imposed a fine of \$170.

Race 4 | **AUTO FUNDS HANDICAP (1200m)**

ROSEY POSEY (S Wynne) - Fractious in the barriers. Began very awkwardly, making contact with BEESLASTSTING losing ground.

MAKABAR (K Chowdhoo) - Got back from a wide draw shortly after the start.

SACRED KITTY (BB Hong) - Raced three-wide without cover through the early stages.

WALKTHISSWEY (T Moseley) - Raced three-wide throughout.

TAKE A RISK (R Mudhoo) - Had to be shifted across heels passing the 200 metres to obtain clear running.

BEESLASTSTING (J Lowry) - Rider reported the gelding had shortened stride over the concluding stages. A post-race Veterinary examination revealed no obvious abnormalities.

A Bohorun was issued with a warning under Rule 638(3)(g)(ii) when using the whip in two consecutive strides on THE GOOD SHEPHERD inside the final 100 metres.

Race 5 | **OWNER'S BONUS SCHEME AT GORE (1200m)**

IRISH EXCUSE (K Williams) - Fractious in the barriers. Slow to begin.

HE'S GOT POWER (S Khetoo) - Raced three-wide without cover throughout.

Race 6 | **CROYDON CONTRACTING HANDICAP (1800m)**

WILD LIKE (K Chowdhoo) - Began awkwardly shifting out crowding outside runners.

MAZZURO (K Mudhoo) - Crowded at the start. Over-raced through the early and middle stages.

RAISE YOUR SIGHTS (C Johnson) - Crowded at the start losing ground. When asked to comment on the performance rider advised the mare was not suited by the sit and sprint nature of today's race.

DOUGH BOY (T Moseley) - Lay outwards throughout the run home.

MIDNITE KAOS (R Mudhoo) - Heavily restrained to avoid heels passing the 1500 metres as the pace of the race eased at this point. Following the race rider reported his runner had bled during the running. A post-race Veterinary examination confirmed the gelding to be a bleeder and as such was stood down for the mandatory period. Trainer A Dickson advised she would give consideration to retiring MIDNITE KAOS as a racing proposition from her stable.

Race 7 | **KEVIN COYLE MEMORIAL (1800m)**

ROSIE GLOW (S Khetoo) - Slow to begin and tailed the field throughout, losing contact with the body of the field and finishing in a distant last placing. When asked to comment on the performance rider could offer no tangible excuse. A post-race Veterinary examination revealed the mare had suffered a cardiac arrhythmia and as this was the third occasion connections were advised ROSIE GLOW is now ineligible to race unless authorised by the Stipendiary Stewards.

RIVIERA ROCK (S Wynne) - Raced wide in the early stages.

ANJAMEME (C Johnson) - Raced keenly through the early and middle stages with rider reporting that due to this the mare had failed to finish the race off.

FULL FURY (K Chowdhoo) - Held up rounding the final bend and early in the run home only gaining clear racing room inside the final 125 metres.

OCEANS AWAY (T Moseley) - Briefly steadied when in restricted room passing the 150 metres.

B Murray was unable to make the contract weight on **OCEANS AWAY** with the Adjudicative Committee imposing a fine of \$100 under the Minor Infringement Schedule. B Murray was replaced by T Moseley.

Race 8	HOKONUI SUZUKI HANDICAP (1335m)

CURVE (K Chowdhoo) - Reared as the start was effected dislodging rider K Chowdhoo. K Chowdhoo was examined by St John Ambulance Paramedics and found to be uninjured in this incident. **CURVE** was recaptured soon after the race was completed and following a Veterinary examination was cleared of any injury. Following the race Stewards requested a ruling from the Adjudicative Committee as to whether **CURVE** had been denied a fair start under Rule 632(1) when being held by a Starters assistant as the gates opened. After reviewing the footage, and hearing evidence the Adjudicative Committee declared **CURVE** a non-runner. Connections were advised the gelding was stood down pending a satisfactory barrier trial prior to racing next.

RAISE YA CARDS (K Rathoar) - Crowded at the start losing ground.

BORN TO BE BAD (T Moseley) - Crowded at the start losing ground.

DARCEE QUE (S Wynne) - Taken back from a wide draw to obtain cover shortly after the start. Had to shift ground inwards near the 150 metres to obtain clear running.

SYMPATHIQUE (R Mudhoo) - Crowded and placed in restricted room passing the 1050 metres when **SEA SHEPHERD** was briefly dictated inwards by **PLAY THE FIELD**.

PEARL DAVONE (B Murray) - Hampered at the 200 metres by the riderless horse shifting ground at this point.

PONIARD (J Laking) - Hampered by the riderless horse from the 175 metres and was unable to be tested by its rider.

WESTERN DREAM (K Mudhoo) - Steadied away from the heels of **PONIARD** near the 150 metres which was taken out by the riderless horse at this point.

SEA SHEPHERD (K Williams) - When asked to comment on the performance of favoured runner rider advised she had received a nice run throughout however the gelding had failed to let down in the straight and was disappointing.

PLAY THE FIELD (B May) - When asked to comment on the improved performance connections advised the win was unexpected however noted the mare had been aided by a positive ride today.

B May (**PLAY THE FIELD**) was issued a charge under Rule 638(2) in that he performed a celebratory gesture prior to the winning post which was adjourned sine die by the Adjudicative Committee to be heard at a later date due to B May having left the course.
