Race 1	MANAWATU TOYOTA/JOHN TURKINGTON FORESTRY 1200

ROSIELICIOUS (S Weatherley) - Began awkwardly and was slow away.

ICONIC LASS (A Mudhoo) - Briefly steadied off the heels of LADY KARTEL shortly after the start.

THE BIG BAD WOLF (T Taiaroa) - Shifted out under pressure near the 300 metres, dictating TED CAN TOO outwards.

OTTAVIO (B Rogerson) - Raced in restricted room until near the 100 metres.

TANGO LOVE (D Bradley) - Rider reported the mare raced greenly and was not suited to the Heavy 10 track.

L Allpress (MACUSHLA) - Stewards inquired into the manner in which L Allpress used her whip in the home straight were satisfied she did not contravene the rule.

Race 2	CARRFIELDS LIVESTOCK/CP WOOL 1200

MISS LIZZIE (C O'Beirne) - Late scratching at 12.51pm on veterinary advice after an examination behind the barrier revealed the mare to be lame. Connections were advised a clearance is required..

WORLD TOUR (K Asano) - Underwent a pre-race veterinary examination at the barrier after receiving a kick in the outside enclosure and was cleared to start. Finished well back. A subsequent veterinary examination revealed the gelding to have suffered an atrial fibrillation with a clearance being required prior to its next start.

CASAQUINMAN (D Turner) - Slow away.

BELLISSIMO (T Taiaroa) - Slow away.

DIOGENES (L Allpress) - Over-raced in the back straight. Held up final turn and had to be angled wide to improve in the home straight.

COLORADO STAR (F Lazet) - Held up for a short distance near the 600 metres behind the tiring WORLD TOUR.

Race 3	CR GRACE LTD/WATERFORCE 2200

SULIMAN (D Turner) - Unsuit to the slow early pace so was taken forward to sit outside the leader near the 1400 metres. Shifted ground outwards over the final stages.

BOTTI (L Allpress) - Held up and unable to improve for some distance rounding the home turn and early in the home straight.

C O'Beirne (DUBAI'S MOKO) - Issued with a warning after angling her mount out near the 700 metres dictating COLIN OSCOPY outwards over extra ground.

Race 4	H&T AGRONOMICS/AGRICOM 2200

MASSO (A Mudhoo) - Began awkwardly.

BEAUDACEA (D Bradley) - Slow away then dictated inwards shortly after the start when HEY HEY HEY shifted inwards. Steadied towards the end of the back straight when JAKKANO (J Mudhoo) shifted in. J Mudhoo was shown footage of his ride in the presence of the Riding Master and advised to exercise care.

JAKKANO (J Mudhoo) - Steadied when in restricted room near the 800 metres.

FULL SWING (M Hudson) - Obliged to race three wide without cover throughout.

THE BIG BOSS (S Macnab) - Briefly held up prior to entering the home straight.

JACKAROO (S O'Malley) - Inclined to shift outwards under pressure in the home straight.

C Dell (SACRED LADY) - Issued with a warning for using his whip in consecutive strides inside the 100 metres.

Race 5	MARSH INSURANCE BROKERS/FARMERS TRANSPORT MAIDEN 1400
BIG FRANCK (K Asano) - Began awkwardly.	
CHEQUER BOARD (A Mudhoo) - When questioned A Mudhoo advised the gelding was unsuited to the Heavy 10.	
HIGH FREQUENCY (D Johnson) - D Johnson reported the mare which finished well back was unsuited to the Heavy 10.	
MY MAN'S BACK (S Macnab) - Had to be angled wide in the home straight to improve and in doing so dictated TARGET outwards.	
TARGET (F Lazet) - Dictated home straight.	
Race 6	PIONEER SEEDS/PILET CONTRACTING 1400
ROSCHANA (M Hudson) - Began awkwardly from its wide draw and settled back.	
SPEED CALL (S O'Malley) - Skied its head on several occasions in the back straight when being restrained.	
HALLELUJAH BROTHER (K Asano) - Commenced to over-race near the 1200 metres and when being steadied hung inwards sharply when racing greenly prior to being corrected.	
DEN BOSCH (S Macnab) - Denied a run near the 200 metres when there was insufficient room to improve to the inside of SPEED CALL, then had to be angled outwards.	
Race 7	BOEHRINGER INGELHEIM METRIC MILE (G3) 1600
HOUSE OF CARTIER (S Macnab) - Tightened and lost ground at the start when DEERFIELD shifted in simultaneously as RITANI shifted out.	
MAUNA KEA (D Bradley) - Raced wide throughout.	
TAPPY'S ONE (C Johnson) - Finished some distance last. C Johnson advised that the gelding travelled reasonably until the 800 metres but failed to respond when placed under pressure and was disappointing over the final stages. Stewards ordered a veterinary examination of TAPPY'S ONE, which did not reveal any obvious abnormality. Connections advised that they would monitor the progress of the gelding over coming days and report any anomalies to the Stewards.	
Race 8	NUFARM/FPA NZ 1600
KUSUDA (S Macnab) - Began awkwardly and got back.	
SIR BEETS (R Elliot) - When questioned into the run of SIR BEETS, R Elliot had no particular excuse other than the gelding may be feeling the effects of recent racing. Trainer advised that SIR BEETS will be freshened prior to his next start.	
RUN LIKE BOO (J Mudhoo) - Commenced to give ground rapidly round the turn and finished well back. J Mudhoo reported the gelding was unsuited to the going.
