Race 7 BOEHRINGER INGELHEIM METRIC MILE (G3) 1600

TAPPY'S ONE (C Johnson) - Co-trainer Mrs K Taplin advised Stewards, TAPPY'S ONE, was examined by a chiropractor after the gelding was showing signs of slight lameness to the near side back area. K Taplin further advised TAPPY'S ONE completed a gallop the morning of Wednesday 29 September, with the gelding showing no signs of lameness to the treated area, and it is now the stables intention to continue on with TAPPY'S ONE's current preparation.

RACE COMMENTS

Race 1 BRUCE CLIFTON BUILDER/EDMONDS PAINTERS MAIDEN (2200)

MONITOR (F Lazet) - Began awkwardly and bumped with SPANISH HARLEM which settled back. Raced keenly in the early and middle stages. Held up for some distance rounding the home turn.

SPANISH HARLEM (M Hudson) - Bumped at start and settled back.

HUNTERVILLE HARRY (W Pinn) - Commenced to over race in the home straight on the first occasion and had to be severely restrained off heels for some distance rounding the first turn. When questioned W Pinn confirmed HUNTERVILLE HARRY raced intractably throughout and had little left at the finish. Stewards advised Connections that a warning is placed against the racing manners of HUNTERVILLE HARRY.

UMUTAHI LAD (K Hercock) - Hung throughout placing the rider at a disadvantage.

HARDTIMES (L Hemi) - Held up rounding the home turn gaining clear running entering the home straight.

REDGUM (D Montes de Oca) - Denied a marginal run near the 150 metres prior to being angled inwards to improve then held up over the final stages.

S O'Malley - (ESTABLISHMENT) - Issued with a warning after using his whip in 2 consecutive strides on ESTABLISHMENT inside 100 metres, with Stewards taking into account his clear recent record.

Race 2 LIQOURLAND WANGANUI/KENT MYERS PROGRESSIVE MAIDEN (1200)

LORD DONOVAN (A Mudhoo) - Jumped away awkwardly and got back.

NOT A BRASS RAZOO (C O'Beirne) - Ran wide at the start and lost ground.

SERGIO (S O'Malley) - Had to be steadied approaching the 600 metres.

MYSTERY BAR (C Dell) - Over raced near the 800 metres.

T Newman (MI CAROL) - Was shown footage of her ride and issued with a warning under Rule 638(1)(d) after allowing her mount to shift to the rail approaching the 600 metres, when not fully clear of SERGIO which had to steady.

SHELBYROCK'N (K Hercock) - Got its tongue over the bit during the running.

Race 3 MANUTAHI CONCRETE MAIDEN (1200)

KEW PLAYER (S O'Malley) - Began awkwardly and was slow away. Held up passing the 400 metres gaining clear running approaching the 200 metres. S O'Malley Charged with using his whip in consecutive strides inside the final 100 metres with the matter being adjourned to a later date.

REIGN IT IN (L Allpress) - Began awkwardly and was slow away. Held up briefly passing the 400 metres.

MAROTIRI MARSTA (C Jones) - Slow away. Dictated wide on the home turn when REIGN IT IN improved to its inside.

TOBKAY (M Hudson) - Dictated inwards shortly after the start.

SOUTHERN BABE (K Hercock) - Tightened shortly after start.

THIRD TIME ROUND (S Macnab) - Tightened shortly after start. When questioned into the disappointing run of THIRD TIME ROUND S Macnab advised the filly was never comfortable in the conditions.

D Montes de Oca (SWEET KARMA) - Shown footage of his ride in the presence of the Riding Master after he allowed his mount to shift in shortly after the start dictating TOBKAY inwards which resulted in SOUTHERN BABE and THIRD TIME ROUND being tightened. Montes de Oca was advised that he is expected to straighten his mount sooner than he did on this occasion.

Race 4 PROPERTY BROKERS WANGANUI (1200)

UNUSUAL COUNTESS (L Allpress) - Restrained to take cover near the 900 metres. Rider reported the filly was not suited to the Slow 9 track under the 59kg impost. A subsequent veterinary examination was clear.

TOWN BELT (C O'Beirne) - Shifted out over the final stages dictating KOPUA outwards over extra ground near the finish.

KOPUA (R Elliot) - Dictated over extra ground near finish.

Race 5 BOYS GET PAID/CHRIS HAYES LIVESTOCK MAIDEN 3YO (1400)

SILKY RED FOX (L Hemi) - Got its head up when over racing in the back straight.

PLATINUM MACHINE (K Asano) – Was inclined to lay inwards under pressure over the final stages.

Race 6 NZB INSURANCE PEARL SERIES RACE (1650)

SYBARITE (M Singh) - Slow away.

WONDERFUL BARBIE (L Kauri) - The saddle shifted forward on WONDERFUL BARBIE entering the back straight placing the rider at a disadvantage for the remainder. Established long lead in early and middle stages when over racing with slipped saddle.

C Jones MILLIE GEORGIA – Admitted a charge in that he struck his mount MILLIE GEORGIA six times prior to the 100 metres. After considering submissions the Adjudicative Committee suspended C Jones licence to ride in races from the conclusion of racing on 9 October up to and including racing on 17 October (6 days). C Jones was also referred to the Riding Master with regard to his whip use.

Race 7 WAVERLEY 4 SQUARE/PALAMOUNTAIN VITAPOWER (1650)

MAUNA LOA (C Jones) - Slow away. Had some difficulty gaining a clear run early in the home straight. Tightened over final stages.

FATTORE OTTO (M Singh) - Shifted in over the final stages resulting in MAUNA LOA being tightened. M Singh was issued with a warning.

TED LASSO (S O'Malley) - Finished some distance last. A subsequent veterinary examination revealed pain in the right hind quarter consistent with muscle. The connections were advised that a Veterinary Clearance would be required before next racing.

BIG BEN (L Kauri) - Raced keenly in the early and middle stages.

DEEP BLUE (K Hercock) - Slow away.

ODYSSEUS (L Hemi) - Raced keenly into the first bend.

Race 8 HOOPER ENGINEERING/NORWOOD HAWERA MAIDEN (1650)

FOREVER WONDERING (C O'Beirne) - Slow away.

BATTLE SECRET (S Macnab) - Raced keenly early.

ZUMA ROCK (L Kauri) - Steadied near the 1000 metres. Shifted out under pressure in the home straight.

HOLYELL (R Elliot) - Had to be steadied when in restricted room heading into the back straight.

GAMESTER (F Lazet) - Commenced to give ground rounding the home turn and finished well back. F Lazet reported the GAMESTER was never comfortable in the going.

DEE DEE SMASH (C Jones) - When questioned into the disappointing run of DEE DEE SMASH C Jones was of the opinion his mount was not entirely suited to the slow 9 track conditions.
