### **RACE COMMENTS**

## Race 1 WAIKATO DRAUGHT 1400

**IHU** (N Parmar) - Was declared a late scratching at 12:07pm after escaping under the front of its barrier stall. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**EVER SO EASY** (C Grylls) - Jumped away awkwardly making contact with MARCHIONESS. Had to be steadied when placed in restricted room shortly after the start to the inside of MARCHIONESS which lay in and away from POW WOW.

**MARCHIONESS** (M McNab) - Hampered when contacted leaving the barriers. Inclined to over race when being restrained in the early to middle stages.

**ALPHA CHARLIE** (L Allpress) - Raced three wide without cover. Inconvenienced and forced wider passing the 300 metres.

**CELEBRE** (A Goindasamy) - Crowded shortly after the start to the inside of EVER SO EASY which shifted in and away from MARCHIONESS which lay in and away from POW WOW. Had to be steadied after improving onto heels passing the 1100 metres. Made the bend awkwardly near the 800 metres when racing keenly.

**FLAVIUS** (T Yanagida) - Held up rounding the final bend.

**POW WOW** (S Spratt) - Inconvenienced passing the 300 metres by FLAVIUS which shifted outwards.

EVEN CHANCE (K Asano) - Steadied to avoid heels near the 750 metres.

#### Race 2 TE RAPA EVENT CENTRE IS OPEN MAIDEN 1400

**THEE AULD DOOZIE** (T Yanagida) - Declared a late scratching at 12:42pm after refusing to enter the barriers. Connections were advised that the filly is now required to barrier trial to the satisfaction of Stewards prior to racing next.

MASTER ORTEGA (K Asano) - Slow away.

ROCKET LAD (W Pinn) - Jumped away awkwardly making contact with ADHIRAA.

**ADHIRAA** (L Satherley) - Contacted leaving the barriers. Had to be steadied after improving onto heels passing the 1150 metres.

GLORY BOUND (C Grylls) - Jumped away awkwardly. Lay in when placed under pressure in the final straight.

## Race 3 HAPPY 40<sup>TH</sup> VICKIE BEGOVICH MAIDEN 1400

**ZAZZLE** (T Newman) - Slow away.

THE LANDING (M McNab) - Slow away. Held up rounding the final bend.

HALSTON (L Allpress) - Jumped in the air at the start, then hampered shortly after having to be steadied.

**ARDOUR** (S Collett) - Had to be checked to avoid the heels of RUHIA which was bumped outwards by CALLISSIDENT shortly after the start, also hampered was HALSTON. Made contact with the running rail when placed in restricted room having to be steadied passing the 100 metres.

**CALLISSIDENT** (K Asano) - Blundered when placed in restricted room to the outside of CALLISSIDENT, which had improved quickly and inside of MEDAL (D Johnson) which had shifted in when awkwardly placed near the heels of THE NIGHT KING (M Cameron) passing the 1100 metres before, MEDAL was then able to relieve the pressure. Both D Johnson and M Cameron were both advised to exercise care when in similar circumstances.

RUHIA (V Colgan) - Had to be steadied to avoid the heels of CALLISSIDENT passing the 1100 metres.

**ROYAL ROC** (C Grylls) - Lay in when placed under pressure in the final straight.

## Race 4 NZB READY TO RUN SALE BREEZE UPS 11/12 OCTOBER 1200

STREET KID (E Leighton) - Slow away.

**FISCAL FUN** (D Johnson) - Steadied shortly after the start when in restricted room. Improved onto heels passing the 600 metres having to be steadied. Had to steady to avoid the heels of MILLEFIORI which shifted outwards passing the 400 metres.

PAREANUI BAY (M McNab) - Raced three wide without cover.

**MERCURIAL** (W Pinn) - Raced four wide without cover.

**TURN THE ACE** (R Elliot) - When questioned regarding performance the rider advised that in his opinion the gelding would benefit from a step up in distance.

ARIS ARIS (C Grylls) - Held up until shifting outwards approaching the 200 metres to obtain clear running.

T Harris (PALAMOS) - Issued with a warning after weighing in 0.5kg over the weight at which he weighed out.

**S Weatherley** (MILLEFIORI) - Issued with a warning for angling his mount outwards when not sufficiently clear of FISCAL FUN which had to be steadied passing the 400 metres.

#### Race 5 DUNSTAN RECOVERY MASH 1200

**SUPERDONNA** (S McKay) - Restrained to obtain cover after jumping from the outside barrier.

**NETANYAHU** (V Colgan) - Jumped away awkwardly making contact with ISLA JAY.

ISLA JAY (E Leighton) - Contacted leaving the barriers.

**CADEAU** (S Collett) - Had to be steadied to avoid heels approaching the 800 metres then made the bend awkwardly when continuing to race keenly.

**ACTING OUT** (C Barnes) - Commenced to give ground in the final straight and was not persevered with. When questioned regarding performance the rider was unable to offer any excuse advising that the mare had never travelled well in the running and had been disappointing. Underwent a post-race veterinary examination with did not reveal any abnormality.

**TIA CELESTE** (L Satherley) - Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary examination which confirmed the mare to have bled. TIA CELESTE shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

**TEVERE** (M McNab) - Shifted inwards passing the 250 metres to obtain clear running forcing ROC CHA outwards inconveniencing TEREINE.

**ROC CHA** (T Thornton) - Contacted and forced wider passing the 250 metres.

**TEREINE** (D Johnson) - Inconvenienced passing the 250 metres.

**LISHEEN** (J Kamaruddin) - When questioned regarding performance the rider advised that the mare had not felt comfortable in today's track conditions.

**V Colgan** (NETANYAHU) - Admitted a charge in that he struck his mount NETANYAHU six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday 9 October until the conclusion of racing on Saturday 16 October, 5 national riding days, and in addition imposed a fine of \$150.

**V Colgan** (NETANYAHU) – Issued with a warning for permitting his mount to shift in when not sufficiently clear of CADEAU which had to be steadied passing the 800 metres.

**T Thornton** (ROC CHA) - Admitted a charge in that she struck her mount ROC CHA six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday 3 October up to and including racing on Wednesday 13 October, 6 national riding days.

#### Race 6 PHILL CATALDO BLOODSTOCK HANDICAP 1200

FESTIVITY (K Asano) - Jumped away awkwardly.

**LES CRAYERES** (D Johnson) - Slow to begin before being further hampered having to steady to avoid heels. Inconvenienced over the concluding stages.

RUN TO PERFECTION (M McNab) - Slow away.

MADAM HASS (S Weatherley) - Raced three wide without cover throughout.

**DEMONETIZATION** (L Allpress) - Crowded shortly after the start having to be steadied.

**MONEY TRAIL** (S Collett) - Made the bend awkwardly near the 800 metres then shifting out hampering CAVALLO VELOCE. Improved onto heels passing the 100 metres having to be steadied.

CAVELLO VELOCE (S Mckay) - Hampered passing the 800 metres.

**SHEEZALLMINE** (T Newman) - Had difficulty obtaining clear running early in the final straight. Lost the left front plate during the running.

HYPNOS (V Colgan) - Had difficulty obtaining clear running for the majority of the final straight.

# Race 7 SKYCITY HAMILTON WAIKATO CUP DAY 11/12 2100

**BEAUNE** (L Allpress) - Slow to begin. The rider reported that the horse had held its breath during the running. Underwent a post-race veterinary examination which did not reveal any abnormality.

**LORD PAINTON** (B Grylls) - Over raced in the early and middle stages.

**SINGLE MOMENT** (A Goindasamy) - Began awkwardly.

ZEE FALLS (W Pinn) - Improved onto heels passing the 500 metres having to be steadied.

**RISING RANSOM** (S Weatherley) - Underwent a post-race veterinary examination which did not reveal any abnormality.

**S Spratt** (CHEVAL PROMETTEUR) - Admitted a charge in that she struck her mount CHEVAL PROMETTEUR six times prior to the 100 metres mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

# Race 8 SUPER SETH @ WAIKATO STUD HANDICAP MILE (1600 Metres)

**SAVY YONG BLONK** (D Johnson) - Slow to begin (6L). Connections were advised a warning would be placed on the mare's barrier manners.

**SUMMER FESTIVAL** (C Barnes) - Began awkwardly losing ground.

MORE WONDER (R Elliot) - Slow to begin.

**CRYSTALLIZE** (B Rogerson) - Knuckled on jumping away.

MARRONI (K Asano) - Raced three-wide without cover throughout.

JUSTAMAIZ (M McNab) - Held up until shifting outwards passing the 400 metres.

**W Pinn** (OCEAN BILLY) - Admitted a charge in that he struck his mount OCEAN BILLY seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.

#### Race 9 SVS STARTING GATES MILE (1600 Meters)

**PLUSHENKO** (E Leighton) - Slow to begin. Hampered passing the 350 metres when runners either side shifted ground.

MIANJO (S Weatherley) - Slow to begin

**SOLID CONTACT** (M Alam) – Began awkwardly then hampered losing ground.

**THE BOUNDER** (W Pinn) - Commenced to over race passing the 1400 metres and continued to do so through the middle stages.

JUDY'S SONG (M McNab) – Raced three wide without cover throughout.

**CORUBA JAK** (B Grylls) – Held up for a distance entering the final straight.

**ALWAYS SACRED** (S Collett) – Held up passing the 350 metres before shifting inwards to obtain clear running hampering PLUSHENKO, contributing was outward movement from ROCK MY HEART.

**GRANADOS** (M Cameron) – When questioned regarding the performance the rider advised that the gelding had not been comfortable in today's track conditions.
