Race 3 - Manutahi Concrete Maiden 1200

S O'Malley (KEW PLAYER) - Admitted a charge in that he struck his mount with the whip in two consecutive strides just short of the finish, with the Adjudicative Committee imposing a fine of \$150.

RACE COMMENTS

Race 1 HASTINGS-HEART OF HAWKE'S BAY 2100

MARBUZET (C Grylls) - Declared a late scratching behind the barriers at 12.20pm on veterinary advice when found to be displaying low grade lameness behind, with a veterinary clearance now required prior to racing next.

SUPER TAP (C Johnson) - Blundered leaving the barriers. Was unable to obtain clear running over the final 200 metres.

LILLY LAGUNA (M McNab) - Lay in under pressure in the straight.

MASSO (A Mudhoo) - Had a tendency to lay inwards in the straight.

LE GRAZIE (T Harris) - Lay in under pressure over the concluding stages.

YOSSARIAN (W Pinn) - Eased down in the straight when well beaten. When questioned regarding performance rider advised that he felt there was something amiss with the gelding, which had been making abnormal breathing noises. A post-race veterinary inspection revealed a poor rate of recovery along with displaying signs of heat stress. Connections were advised that a veterinary clearance would be required prior to racing next.

Race 2 TWILIGHT XMAS AT THE RACES ON SALE NOW 1300

SCREAMIN EAGLE (S Weatherley) - Jumped away awkwardly. Steadied when crowded to the inside of LADY KOVAL (C Grylls), which lay in near the 1100 metres. C Grylls was advised to exercise care. Held up early in the straight.

LINDA LOLA (S Macnab) - Raced in restricted room near the 1000 metres. Shifted away from SHARKY near the 250 metres dictating NEWSTALK inwards onto the weaking BEAU MOND. Had to be steadied away from the heels of SHARKY (C O'Beirne) when that runner lay in near the 100 metres. C O'Beirne was advised to exercise care.

NEWSTALK (D Turner) - Raced keenly in the middle stages. Dictated inwards near the 250 metres.

IMPLICIT (J Kamaruddin) - Raced wide without cover.

MONZA (S Collett) - Raced wide throughout.

LADY KOVAL (C Grylls) - When questioned regarding performance rider advised that the filly had led throughout in its debut win but after being unable to take up a prominent position today had been field-shy racing very greenly throughout and should benefit from the experience.

BEAU MONDE (M Cameron) - Lay out rounding the final turn. Crowded when weakening near the 250 metres. When questioned regarding performance rider was unable to offer any excuse. A post-race veterinary inspection did not reveal any obvious abnormality.

Race 3 LI REDSHAW MEMORIAL 1300

THE MITIGATOR (S McKay) - Jumped away awkwardly crowding VIGOR WINNER onto JOE'S LEGACY.

VIGOR WINNER (M Cameron) - Crowded start.

JOE'S LEGACY (C Grylls) - Hampered leaving the barriers losing ground.

SATU LAGI (J Kamaruddin) - Commenced to over-race in the middle stages, having to be checked to avoid the heels of THE MITIGATOR which shifted inwards near the 800 metres.

OUR ALLEY CAT (S Weatherley) - Blundered badly leaving the barriers.

CORNFLOWER BLUE (D Johnson) - Slow away. When questioned regarding performance rider advised that the mare had never travelled well and had been disappointing being unable to offer any excuse. A post-race veterinary inspection did not reveal any obvious abnormality.

TIMES TICKING (T Yanagida) - Steadied when crowded shortly after the start. Held up passing the 300 metres and was unable to obtain clear running until near the 150 metres.

MAI TAI (S Collett) - When questioned regarding performance rider advised that after getting further back than intended the mare had hung inwards once placed under pressure but had found the line well and she had not been disappointed by the effort.

S McKay (THE MITIGATOR) - Defended a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of SATU LAGI, which was checked near the 800 metres. After viewing films and hearing submissions the Adjudicative Committee found the charge to be proven suspending S McKay licence to ride in races from the conclusion of racing on Wednesday, 6 October until the conclusion of racing on Thursday, 14 October (6 national riding days).

M Cameron (VIGOR WINNER) - Admitted a charge in that he failed to ride his mount out fully to the end of the race for third placing. After hearing submissions, the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Wednesday, 6 October until the conclusion of racing on Wednesday, 20 October (2 weeks).

Race 4 VILLA MARIA GIMBLETT GRAVELS 1400

IMPRESA (L Allpress) - Jumped away awkwardly losing ground.

KING FAROUK (M Cameron) - Slow away.

LORD ESPERANZA (C O'Beirne) - Commenced to over-race passing the 1200 metres, continuing to do so through the middle stages. Dictated inwards from the 200 metres before being hampered when crowded near the 100 metres.

RUM (S Weatherley) - Raced three wide without cover. Hung outwards rounding the final turn. Checked when weakening near the 100 metres.

SWEET ANNA (W Pinn) - Raced wide throughout.

RUSAVY (T Yanagida) – Shifted away from LORD ESPERANZA (C O'Beirne) when that runner shifted outwards entering the final straight near the 350 metres forcing KING FAROUK and SWEET ANNA wider on the track. C O'Beirne was advised to exercise care.

KING FAROUK (M Cameron) – Forced wider on the track near the 350 metres.

SWEET ANNA (W Pinn) - Forced wider on the track near the 350 metres.

AQUAOIR (S Collett) – Held up rounding the final turn again being held up near the 200 metres before racing in restricted room inside the final 100 metres.

CLIQUE (D Johnson) – Steadied away from heels passing the 200 metres. Unable to obtain clear running over the final 100 metres.

DALMATIA (J Riddell) – Held up near the 200 metres having to shift outwards across heels to obtain clear running.

MANOLO (L Hemi) - Contacted near the 100 metres.

BUSYBEINGFABULOUS (A Mudhoo) – Crowded over the concluding stages when SUNLIT LANE lay inwards away from AQUAOIR with BUSYBEINGFABULOUS then ducking away from the running rail unbalancing its rider who was dislodged close to the finishing line. A Mudhoo was attended to by ambulance personnel and stood down from his remaining ride with a medical clearance now required prior to riding next.

T Yanagida (RUSAVY) - Admitted a charge of careless riding in that he permitted his mount to shift inwards crowding LORD ESPERANZA which was forced inwards onto RUM which was checked near the 100 metres. After hearing submissions the Adjudicative Committee suspended his licence to ride in races from the conclusion of racing on Sunday 3 October until the conclusion of racing on Friday, 15 October, 8 national riding days.

Race 5 FASTTRACK INSURANCE 2000

KAHU ROCK (C Grylls) – Restrained to obtain cover after jumping from the outside barrier.

HUNTER PENCE (S Collett) – Crowded shortly after the start.

PEP TORQUE (C O'Beirne) – Over-raced in the early stages making the first turn awkwardly.

DOLCETTO (M McNab) – Steadled when placed in restricted room to the inside of SWORDS DRAWN (W Pinn) passing the 1200 metres. W Pinn will be spoken to regarding this incident.

W Pinn (SWORDS DRAWN) - Admitted a charge in that he struck his mount SWORDS DRAWN 6 times prior to the 100 metre mark with the Adjudicative Committee imposing a suspension of W Pinn's licence to ride in races from the conclusion of racing on Wednesday 6 October until the conclusion of racing on Wednesday 13 October, 5 national riding days & in addition imposed a fine of \$200.

Race 6 DUNDEEL AT ARROWFIELD HAWKE'S BAY GUINEAS (G2) 1400

WHISKEY (S Weatherley) - Jumped away awkwardly making contact with HOODLUM

DRUM MAJOR (B Rogerson) - Jumped away awkwardly crowding HOODLUM.

HOODLUM (L Allpress) - Contacted leaving the barriers before being further hampered when crowded. Steadied when improving onto heels near the 500 metres. Held up early in the final straight.

NEST EGG (D Turner) - Steadied shortly after the start when placed in restricted room.

MANA NUI (V Colgan) - Crowded 1100 metres. Over-raced in the middle stages.

SOLDIER BOY (K Hercock) - Crowded 1100 metres.

WESTERN SPRINGS (R Elliot) - Crowded 1100 metres. Required post-race veterinary treatment being 4/5 lame in the right foreleg being referred to the Waikato Equine Hospital for further evaluation. A veterinary clearance would now be required prior to WESTERN SPRINGS racing next.

KHUFU (M McNab) - Jumped away awkwardly. Commenced to over-race near the 1100 metres continuing to race fiercely for a distance. Held up early in the straight and continued to have difficulty obtaining clear running for the remainder of the race.

HOARD THE BOURBON (C Grylls) – Held up entering the final straight and did not obtain clear running until inside the final 200 metres.

EL VENCEDOR (D Johnson) – Hampered when weakening near the 150 metres when DRUM MAJOR (B Rogerson) shifted inwards abruptly after being struck with the whip. B Rogerson was advised to exercise care.

B Rogerson (DRUM MAJOR) - Admitted a charge of careless riding in that she permitted her mount to shift inwards near the 1100 metres crowding MANA NUI, SOLDIER BOY and WESTERN SPRINGS. After hearing submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Wednesday 6 October until the conclusion of racing on Friday 15 October, 7 National riding days.

Race 7 LIVAMOL FEED OPTIMISER 1600

SHEZATHINKA – Was declared a late scratching at 8.47am due to an error in medication administration which Trainer J Richards had advised Stewards had been inadvertently administered to the incorrect horse on race morning.

NO ROCK NO POP - J Kamaruddin replaced A Mudhoo (injured). Made contact with RAPID FALLS near the 300 metres.

CHASE (D Turner) - Crowded shortly after leaving the barriers.

CHEAPERTHANDIVORCE (V Colgan) - Slow away.

WILD MOOSE (J Riddell) - Made the first turn near the 1400 metres awkwardly. Had to be steadied to avoid heels near the 200 metres.

CROSS ROADS (L Hemi) - Had to be firmly restrained to avoid heels near the 1300 metres.

RUBY ROCKS (C Grylls) - Raced three wide without cover.

RAPID FALLS (M McNab) – Contacted near the 300 metres.

J Kamaruddin (NO ROCK NO POP) - Admitted a charge in that he failed to ride his mount out fully for fifth placing being fined \$300 by the Adjudicative Committee.

J Kamaruddin (NO ROCK NO POP) – Referred to the Rider Skills Review Panel due to Stewards concerns with the manner in which he used his whip near the 250 metres.

L Hemi (CROSS ROADS) – Admitted a charge of careless riding in that she angled her mount outwards when not sufficiently clear of WILD MOOSE which had to be steadied near the 200 metres. After hearing submissions the Adjudicative Committee suspended her licence to ride in races from the conclusion of racing on Saturday 9 October until the conclusion of racing on Friday 15 October, 4 national riding days.

J Richards - Admitted a charge related to SHEZATHINKA being scratched after the specified time due to an error in medication administration with the Adjudicative Committee imposing a fine of \$650.

Race 8 WINDSOR PARK PLATE (G1) 1600

LLANACORD (L Hemi) - Slow away.

SIRACUSA (D Johnson) - Restrained to obtain cover after jumping from the outside barrier. Following the race was confirmed to have bled from both nostrils following a veterinary inspection. SIRACUSA shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1,000 metres in the presence of a Veterinarian with a veterinary clearance provided.

MAUNA KEA (D Turner) - Restrained to obtain cover after jumping from an outside barrier.

PIERINA (M McNab) – Steadied to avoid heels near the 1400 metres. Steadied away from the heels of KATIE PERRIE near the 375 metres.

SPRING TIDE (S Macnab) – Commenced to over-race near the 1300 metres and shifted outwards making contact with PRISE DE FER. SPRING TIDE and PRISE DE FER then continued to come together and jostle for a distance. When questioned regarding performance rider was of the opinion that the mare was better suited to more rain affected footing.

PRISE DE FER (T Harris) – Contacted by SPRING TIDE near the 1300 metres then jostled with that runner for a distance.

Race 9 THREE WISE BIRDS SUPPORT LOCAL 1200

SIDE BY SIDE (S Weatherley) - Jumped away awkwardly.

REAL SLIM TRADIE (K Hercock) - Slow away.

SHEZZACATCH (L Allpress) - Slow away. Held up passing the 300 metres then having difficulty obtaining clear running until the concluding stages. Rider reported that her mount had lost its footing when pulling up after the finish with Club officials being made aware of this incident and shown available film footage.

LAVAGLO (M McNab) - Raced three wide without cover.

TAMAHINE (L Hemi) – Held up for a distance near the 200 metres when disappointed for a run to the inside of ROSE 'N' POWER then when being angled outwards across that runners heels inconvenienced SIDE BY SIDE near the 150 metres.

SIDE BY SIDE (S Weatherley) – Held up near the 300 metres and unable to obtain clear running until inside the final 100 metres.

MR UNIVERSE (R Elliot) – Held up over the concluding stages.

ROSE 'N' POWER (M Cameron) – Returned to the enclosure with blood present in the left nostril which upon veterinary inspection was due to a laceration in the nostril.
