<b>Race 8 - HOKONUI SUZUKI R65 1335M</b>
<b>B May</b> (PLAY THE FIELD) - Admitted a breach of Rule 638(2) in that he made a celebratory gesture prior to the winning post. After hearing submissions, the Adjudicator imposed a fine of \$250.

<b>Race 1</b>	<b>RICCARTON PARK FUNCTION CENTRE MAIDEN 1400m</b>
<p><b>STAN WITH ME</b> (D Bothamley) - Fractious in the barrier prior to the start and reared beginning very awkwardly unbalancing the rider losing considerable ground and momentum and then refused to hit out and was not persevered with from this point. The connections were advised that the gelding must barrier trial to Stewards satisfaction prior to racing next.</p> <p><b>BURGUNDY STAR</b> (B Murray) - Crowded shortly after the start losing ground when runners to either side shifted ground.</p> <p><b>ANCHOR ME</b> (T Comignaghi) - Began awkwardly losing ground.</p> <p><b>GALAXY POWER</b> (K Mudhoo) - Began awkwardly.</p> <p><b>SO AMUSED</b> (C Campbell) - Began awkwardly.</p> <p><b>JUST A GIRL</b> (T Newman) - Raced keenly in the early and middle stages.</p> <p><b>DICELAND</b> (S Wynne) - Raced keenly in the early and middle stages. Hampered near the 300 metres when DEMAND RESPECT lay outwards before being straightened.</p> <p><b>SASHA</b> (R Mudhoo) - Crowded and checked passing the 1000 metres.</p> <p><b>DA VINCI GIRL</b> (K Chowdhoo) - Raced ungenerously in the early and middle stages when being restrained. Became awkwardly placed on heels having to be steadied passing the 700 metres when MADAM MOSS (B May) shifted in when not fully clear. B May was advised to exercise greater care.</p> <p><b>DEMAND RESPECT</b> (S Spratt) - Raced three wide without cover for the majority of the race. Lay out passing the 300 metres having to be straightened by its rider.</p> <p><b>THERE YOU GO</b> (K Asano) - Blundered passing the 75 metres with the rider reporting the filly had changed strides at this point becoming briefly unbalanced.</p> <p><b>L Callaway</b> (ON MY SHOULDERS) - Defended a charge of careless riding in that he permitted ON MY SHOULDERS to shift in passing the 1000 metres which not sufficiently clear of SASHA which was crowded and checked. After</p>	

considering submissions the Adjudicator suspended L Callaway's licence to ride in races from the conclusion of racing on Friday 8 October until the conclusion of racing on Friday 15 October, 5 national riding days.

**Race 2**

**GROUP 1 RACEDAY PARTY 23 OCTOBER MAIDEN 1400m**

**IFITHAPPENSAGAIN** (J Lowry) - Declared a late scratching by Stewards at 11.40 am after being fractious on the way to the start with the rider having to dismount abruptly in the preliminary. The start was delayed approximately 5 minutes as a result. J Lowry was examined by St John Paramedics and found to have sustained a knee injury and was stood down from his remaining riding engagements. J Lowry was advised he must provide a medical clearance prior to riding next.

**ALLASERA** (K Williams) - Slow to begin then hampered losing ground. Steadied when crowded passing the 150 metres.

**CAPTAIN** (S Wynne) - Began awkwardly. Shifted outwards passing the 250 metres.

**PLEASURENPAIN** (L Callaway) - Hampered shortly after the start losing ground. Held up early in the final straight.

**LA COFRADIA** (S Spratt) - Crowded shortly after the start losing ground. Raced ungenerously in the early and middle stages. Held up early in the final straight.

**SERAPHIC** (D Danis) - Hampered shortly after the start losing ground.

**IRISH RED** (K Mudhoo) - Had to be steadied after becoming awkwardly placed on the heels of BENTLEY (T Comignaghi) which shifted in when insufficiently clear passing the 1050 metres. T Comignaghi was advised to exercise greater care in similar circumstances.

**ELIZABETH DARCI** (B Grylls) - Raced wide throughout.

**EIGHT BALL** (B Murray) - Raced four wide without cover throughout. Steadied passing the 250 metres when crowded by CAPTAIN.

**ROYAL WINGS** (K Chowdhoo) - Held up passing the 400 metres.

**PERFECT MOMENT** (T Jonker) - Held up for the majority of the final straight.

Trainer **L Vaughan** (ELIZABETH DARCI) – Issued with a warning after presenting ELIZABETH DARCI with blinkers which were not notified.

**Race 3**

**HAPPY RETIREMENT KEVIN & PAM HUGHES 1400m**

**ROYCE ROCA** (R Mudhoo) - Began awkwardly.

**VARDON ROAD** (K Williams) - Crowded shortly after the start losing ground.

**PETTY'S LEGACY** (B Grylls) - Began awkwardly.

**FETTERCAIRN** (S Wynne) - Crowded shortly after the start losing ground when runners either side shifted ground.

**ALL BLACK MAGIC** (B May) - Blundered shortly after the start.

**MEILA REI** (S Spratt) - Hampered shortly after the start losing ground. When questioned regarding performance the rider advised that the mare had not been comfortable in today's firmer track conditions. A post-race veterinary inspection did not reveal any obvious abnormalities.

**FLICKERING SHADOW** (K Asano) - Raced three wide without cover throughout.

**TAVILIGHT** (K Chowdhoo) - Had to be restrained when over racing for a distance passing the 800 metres. Jostled with **FETTERCAIRN** (S Wynne) passing the 500 metres when that runner shifted ground looking for clear racing room. S Wynne was advised to exercise greater care when shifting ground.

**CANDID CAMERA** (B Murray) - Over raced through the middle stages.

The track was upgraded to Good 3 following this race.

**Race 4** | **JON SNOW @ CLEARVIEW PARK MAIDEN 2YO 800m**

**REDMOND** (B May) - Proved difficult to load with the connections advised that the gelding was on a barrier manners warning. Improved onto heels having to shift out making the bend awkwardly when racing greenly passing the 500 metres.

**JAFFA** (R Mudhoo) - Slow to begin. Shifted out abruptly passing the 75 metres when endeavouring to find clear racing room.

**THIMBLE THEATRE** (B Grylls) - Began awkwardly losing ground.

**PEACEMAKER** (L Callaway) - Raced three wide without cover throughout.

**STIMULANT** (K Asano) – Inclined to lay out throughout the run home.

**Race 5** | **41 LOTS LIVE ON GAVELHOUSE.COM NOW 2000m**

**SULU SEA** (K Chowdhoo) - Slow to begin.

**HARLEEN QUINZEL** (B May) - Got its head up when being restrained to take cover in the early stages.

**JACK KNOWS BEST** (R Cuneen) - Crowded and steadied passing the 25 metres.

**YEAH RIGHT** (T Moseley) - Crowded and steadied passing the 25 metres.

**JACK BE QUICK** (M Taylor) - Held up early in the run home and raced in restricted room through the middle stages of the run home.

**HEY SOUL SISTER** (G Jogoo) - Held up early in the run home and raced in restricted room until passing the 100 metres.

**POINT SCORE** (K Williams) - Hampered when becoming awkwardly placed on the heels of **DARCEE QUE** passing the 200 metres and then having to be shifted across heels to find clear racing room near the 150 metres.

**ZAKUNDA** (T Comignaghi) - Shifted ground under pressure in the concluding stages

**VERMONT** (C Campbell) - When questioned regarding the apparent improved performance, the trainers advised that the mare had been racing well but at its last start had been ridden on the pace which did not suit and today was ridden with more patience and cover.

**C Campbell** (VERMONT) - Admitted a charge of careless riding in that he allowed VERMONT to shift inwards when not sufficiently clear of JACK KNOWS BEST and YEAH RIGHT which were both crowded and checked near the 25 metres. After hearing submissions, the Adjudicator suspended C Campbell's licence to ride in races from the conclusion of racing on Friday 8 October until the conclusion of racing on Sunday 17 October, 7 national riding days.

**T Comignaghi** (ZAKUNDA) - Admitted a charge of using the whip in 3 consecutive strides on her mount ZAKUNDA inside the final 100 metres. After considering submissions the Adjudicator imposed a fine of \$500.

**T Comignaghi** (ZAKUNDA) - Issued with a warning after allowing ZAKUNDA to shift in over the concluding stages dictating VERMONT inwards onto JACK KNOWS BEST and YEAH RIGHT passing the 50 metres.

**Race 6** | **INGLEWOOD STUD GUINEAS TRIAL 1400m**

The start was delayed approximately five minutes after several runners proved difficult to load.

**CLARA MONCRIEFF** (T Newman) - Slow to begin.

**NOVERRE** (J Laking) - Slow to begin. Shifted out passing the 300 metres to find clear racing room.

**FIREGLOW** (K Chowdhury) - Over raced in the early stages getting its head up when being steadied passing the 1000 metres. Continued to over race through the middle stages having to be steadied off heels passing the 850 metres.

**PALMETTO** (R Mudhoo) - Restrained to obtain cover shortly after the start. Shifted out to find racing room passing the 200 metres.

**FIELD OF GOLD** (K Asano) - Raced three wide without cover for the majority of the race.

**VENTURESOME** (T Comignaghi) - Crowded and had to steady passing the 1100 metres, with the trailing SORRENTO also having to be steadied at this point. Crowded and steadied passing the 150 metres when SORRENTO lay inwards and away from NOVERRE.

**SORRENTO** (B Grylls) - Steadied to avoid heels passing the 1100 metres and was then obliged to race wide from the 800 metres.

**EMANON** (S Toolooa) - Briefly steadied passing the 400 metres.

**S Wynne** (MACKENZIE LAD) - Admitted a charge of using the whip in two consecutive strides on her mount MACKENZIE LAD inside the final 100 metres. After considering submissions the Adjudicator imposed a fine of \$150.

**B Grylls** (SORRENTO) - Issued with a warning after allowing her mount to shift in when not sufficiently clear of VENTURESOME which was crowded and had to steady passing the 150 metres. In assessing this interference stewards took into account some outward movement from FIREGLOW.

**Race 7** | **NZB READY TO RUN SALE 17-18 NOVEMBER 1400m**

**JIN LU** (T Moseley) - Slow to begin. Held up early in the straight.

**TOP GHIA** (B Murray) - Slow to begin.

**NAMIBIA MISS** (S Wynne) - Began awkwardly then blundered losing ground. Held up in the early and middle stages of the run home only gaining clear racing room inside the final 100 metres after shifting across heels.

**THE GARRISON** (K Williams) - Hampered shortly after the start losing ground.

**SHOCK PROSPECT** (S Spratt) - Hampered shortly after the start losing ground. Stewards enquired into the ride, particularly concerning rider S Spratt's lack of vigour over the concluding stages. S Spratt advised that the mare had come to the end of its run and in her opinion was feeling the firm nature of today's track after she had pressured the gelding from the 400 metres. Nevertheless, Stewards reminded S Spratt of her obligation to ensure she rides her mounts out to the end of the race when circumstances permit.

**RUSSIAN FABLE** (S Toolooa) - Raced three wide without cover throughout. Hung in in the final straight.

**DIORADELLE** (C Campbell) - Steadied when weakening passing the 150 metres.

**B Murray** - Admitted a charge of failing to make the contract weight for GLORIOUS OCEAN and was replaced per above schedule, with the Adjudicator imposing a fine of \$200 under the Minor Infringement Schedule. B Murray was replaced by K Asano.

**GOODANYA** (T Moseley) - Slow to begin.

**CAMINO ROCOSO** (M Taylor) - Slow to begin. Began to over race passing the 900 metres and passing the 850 metres shifted out to avoid the heels of LIGHTNING JACK hampering MILFORD SOUND which was forced wider on the track.

**MILFORD SOUND** (K Williams) - Slow to begin. Raced keenly in the early and middle stages. Hampered passing the 900 metres and shifted wider on the track. Inconvenienced passing the 400 metres.

**WHALE SONG** (T Comignaghi) - Began awkwardly losing ground. Awkwardly placed on heels passing the 600 metres having to be steadied. When questioned regarding performance rider reported that the gelding had hung throughout and in her opinion had been feeling the firm nature of today's track.

**ALL ABOUT MAGIC** (S Wynne) - Blundered shortly after the start losing ground.

**GLORIOUS OCEAN** – Crowded shortly after the start having to be steadied and losing ground. Held up early in the straight.

**MARKUS AURELIUS** (J Laking) - Had difficulty finding clear running until the 150 metres.

**SUPREME KHAN** (R Mudhoo) - Began awkwardly losing ground.

**ZOLTAN** (T Moseley) - Slow to begin.

**OKAY PAL** (S Wynne) - Slow to begin then began to race fiercely passing the 1000 metres having to be heavily restrained away from heels for some distance. Continued to over race through the middle stages having to be further restrained. Held up in the early to middle stages of the run home and went to the line not fully tested by its rider.

**LONDON BOUND** (K Asano) - Raced wide throughout.

**MY WORLD** (K Chowdhoo) - Held up throughout the run home only gaining clear racing room inside the final 100 metres when shifted outwards by BENEICIAL.

**ROBINA JOY** (K Williams) - Crowded and checked when passing the 100 metres.

**MAKE BELIEVE** (K Mudhoo) - Crowded and hampered passing the 100 metres when inside runners shifted out.

**CHALLA** (S Toolooa) - Held up early in the run home gaining clear racing room inside the final 200 metres.

**BENEICIAL** (D Bothamley) – Held up in the run home and shifted out passing the 150 metres.

**D Bothamley** (BENEICIAL) – Defended a charge of careless riding alleging that he angled his mount BENEICIAL outwards passing the 150 metres dictating OUR WORLD onto ROBINA JOY which was checked and also hampering MAKE BELIEVE. After hearing evidence the Adjudicator upheld the charge and suspended D Bothamley’s licence to ride in races from the conclusion of racing on Friday 8 October until the conclusion of racing on Friday 15 October, 5 national riding days.

**Race 10** | **NZB READY TO RUN SALE 17-18 NOVEMBER OPEN HCP 2000m**

**ASATHOUGHT** (K Asano) - Began awkwardly.

**TAKE THE DEEL** (T Comignaghi) - Slow to begin.

**QUEEN SWEEP** (M Gestain) - Slow to begin.

**MADAM DE SOIR** (B Grylls) - Slow to begin.

**BEACHED AS BRO** (K Mudhoo) - Restrained from a wide draw to obtain cover shortly after the start.

**FULL FURY** (K Chowdhoo) - Steadied to avoid heels passing the 1800 metres and was obliged to race three wide through the early stages.

**S Wynne** (LINCOLN KING) – Miss Wynne initially admitted a breach of the excessive use of the whip rule in that she had struck her mount 6 times prior to the 100 metres. After hearing evidence and viewing films during the hearing stewards could not be conclusively satisfied that the final strike was outside the final 100 metres and duly withdrew the charge.

**M Gestain** (QUEEN SWEEP) – Issued with a warning for her whip use prior to the 100 metres.

**Race 11** | **RACECOURSE HOTEL & MOTOR LODGE 1600m**

**ZOULUMINOUS** (R Mudhoo) - Began awkwardly losing ground. Crowded and checked passing the 1200 metres. Held up early in the final straight.

**EL BEE JACK** (S Wynne) - Slow to begin.

**MISS CURIOUS** (K Chowdhoo) - Began awkwardly losing ground.

**FRANKIE THE FOX** (L Callaway) - Crowded shortly after the start losing ground.

**DAWN PARADE** (K Asano) - Began awkwardly shifting out losing ground. Had to steady with the rider becoming unbalanced passing the 500 metres when awkwardly placed on heels and over racing. Lay in under pressure in the straight.

**CHITTER CHAT** (B May) - Crowded shortly after the start making contact with DEELS DONE.

**DEELS DONE** (C Barnes) - Buffeted shortly after the start when inside runners shifted out.

**LEITRIM LAD** (M Gestain) – Dictated inwards passing the 1100 meters then over raced in the middle stages having to be steadied away from heels.

**BRONTE BEACH** (B Grylls) - Unable to find clear running for the majority of the final straight.

**M Taylor** (SAIGON HOT NIGHT) - Admitted a charge of careless riding in that she permitted SAIGON HOT NIGHT to shift in dictating LEITRIM LAD inwards onto ZOULUMINOUS which was crowded and checked passing the 1100 metres. After considering submissions the Adjudicator suspended M Taylor's licence to ride in races from the conclusion of racing on today until the conclusion of racing on Wednesday 13 October, 6 national riding days.
