RACE COMMENTS	
Race 1	KNOTTINGLY FARM MAIDEN HURDLE (3100 metres)
<p>LIZZED (B Lammas) - Retired from the race prior to jumping the third to last fence. When questioned regarding performance the rider advised that the gelding had been unsuited by today's track conditions.</p> <p>MATARO (N Downs) - Slow away. Jumped indifferently in the early stages.</p> <p>TAHUROA HEIGHT (L Douglas) - Put in a poor jump at the fourth fence. Jumped indifferently throughout.</p> <p>N Downs (MATARO) - Admitted a charge of using his whip in two consecutive strides on his mount MATARO near the 300 metres. After considering submissions the Adjudicative Committee imposed a fine of \$500.</p>	
Race 2	TE AROHA JOCKEY CLUB MAIDEN HURDLE (3100 metres)
<p>The field was directed around the hurdle near the 1000 metres on the second occasion as the fallen rider was being attended to by the on-course Doctor.</p> <p>BOTTI (S Fannin) – Jumped away awkwardly. Jumped indifferently throughout.</p> <p>JAKKI SPARROW (G Walsh) - Jumped away awkwardly. Hampered after jumping the first fence by OUR CRAFTSMAN which shifted in slightly. Misjudged the second fence and landed awkwardly dislodging its rider who was attended to by the on-course Doctor before being transferred to Waikato Hospital. G Walsh was stood down from his remaining rides.</p> <p>ELUSIVE ACE (S Karnicnik) – Retired from the race prior to jumping the third to last fence. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p>	
Race 3	PIAKO RURAL SERVICES STEEPLECHASE (3500 metres)
<p>BEAU GESTE (D Parker) - Put in a poor jump at the first fence. Hampered jumping the third fence. Badly hampered by the fallen runner after jumping the fence near the 1200 metres. Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary examination which revealed lacerations inside the nostrils and a laceration to the right hind leg.</p> <p>DAL KILCHOAN (E Farr) - Fell after jumping the fence near the 1200 metres dislodging its rider who was uninjured. Underwent a post-race veterinary examination which revealed a minor laceration in the right nostril.</p> <p>MY TOMMY (L Douglas) - Badly hampered by the fallen runner after jumping the fence near the 1200 metres with the rider losing the use of his left stirrup iron before retiring the gelding from the race prior to jumping the fence near the 1000 metres. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p>FLYINGWITHOUTWINGS (N Downs) – Knuckled after jumping the final fence.</p> <p>EL LUCHADOR (S Phelan) – Put in a poor jump at the final fence.</p> <p>HEISTHEONE (S O'Malley) – Lost the right hind plate during the running.</p> <p>TELL ME MORE (S Karnicnik) - Pulled up prior to jumping the final two fences.</p>	
Race 4	PAUL BIBBY MEMORIAL GREAT NORTHERN HURDLE (4200 metres)

This race ran approximately 6 minutes late due to a breakdown of the tractor which moves the starting gates.

ALFIE DEE (B Lammas) – Was inclined to run its fences down throughout.

CURIOUS GEORGE (L Douglas) – Shifted outwards passing the 1350 metres making contact with CHIEF SEQUOYAH which was contacted and forced wider.

CHIEF SEQUOYAH (S O'Malley) – Contacted and forced wider passing the 1350 metres.

KAHARAU (E Farr) - Misjudged the fence near the 1100 metres and fell, dislodging its rider. E Farr was attended to by the on-course Doctor before being transferred to Waikato Hospital for further assessment. E Farr was stood down from her remaining ride. Was immediately attended to by the on-course veterinarian with the horse ambulance being deployed and was humanely euthanised after it was found to have fractured its right foreleg.

DR HANK (S Fannin) – Hit the second to last fence.

FANTASY FLIGHT (N Downs) – Misjudged the final fence.

S Phelan (THE COSSACK) - Admitted a charge in that he made a celebratory gesture prior to the winning post. After considering submissions the Adjudicative Committee imposed a fine of \$200.

Race 5	DIPROSE MILLER GREAT NORTHERN STEEPLECHASE (6200 metres)

TITLETATTLE (L Douglas) - Slow to begin. Jumped indifferently throughout. Retired from the race prior to jumping the fence near the 600 metres. Underwent a post-race veterinary examination which did not reveal any abnormality.

EION (S O'Malley) – Lost the right front plate during the running.

LACUSTRE (C Thornton) - Misjudged the fence near the 200 metres on the second occasion and fell. C Thornton was attended to by the on-course Doctor before being transferred to Waikato Hospital for further assessment. Underwent a post-race veterinary examination which revealed minor lacerations to the left hind leg and foreleg.

MANDALAY (D Parker) - Retired from the race prior to jumping the final two fences. Underwent a post-race veterinary examination which did not reveal any abnormality.

DELEGATE (N Downs) – Put in a poor jump at the fence near the 1500 metres on the third occasion.

All remaining races were put back one race due to a rider being airlifted to Waikato Hospital, with the last race being scheduled to run at 6.01 pm.

ALFIE OUR MATE (C Barnes) – Slow away before being further hampered when crowded. Over-raced in the middle stages.

PARIS RUBY (S Collett) – Jumped away awkwardly.

MODESTY (S Weatherley) - Jumped away awkwardly then being further hampered when crowded.

THE BOUQUET SLAYER (B Grylls) - Hampered shortly after the start.

SOLID IMPACT (J Riddell) – Raced three wide without cover throughout.

STUNGUN (W Pinn) - Had difficulty obtaining clear running for a majority of the final straight.

B Rogerson (TAVIROCK) - Spoken to regarding her actions in the barrier stall when her mount became fractious.

Race 7 | **APPARELMASTER WAIKATO 1400**

KARALINO (C Grylls) - Hampered shortly after the start losing ground.

AERO DE PARIS (E Leighton) – Began awkwardly laying in. Held up early in the final straight.

JUSTASKME (C Jones) - Began awkwardly losing ground. When questioned regarding performance rider advised that the gelding had been unsuited by today's track conditions.

MANRICO (T Newman) – Raced three wide without cover throughout.

Race 8 | **CLEAN MY OFFICE SPACE 1500**

MRS BIG (C Dell) - Slow away.

INITIATIVE (A Goindasamy) - Slow away.

MIGHTY CONNOR (S McKay) - Slow away.

PASSWORD (S Spratt) - Raced three wide without cover throughout. Steadied when placed in restricted room approaching the 200 metres when runners either side shifted ground.

GALLARDO (K Asano) - Raced keenly in the middle stages.

BERGAMO FOX (J Kamaruddin) - Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection BERGAMO FOX was confirmed to have bled. BERGAMO FOX shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

MAKZABEEL (W Pinn) – When questioned regarding performance the rider could offer no excuse.

Race 9 | **RYAN BRADLEY BAYLEYS COMMERCIAL 2200**

LEICA WARRIOR (J Fawcett) - Had to be firmly restrained for a distance to avoid heels near the 1400 metres then continued to over-race through the middle stages. Improved onto heels passing the 300 metres having to be steadied.

CERYS (T Yanagida) - Slow to begin.

LANDGRAVE (J Riddell) - Held up rounding the final bend before improving into a marginal run passing the 400 metres racing in restricted room for a distance.

BO JACKSON (C Grylls) - Lay in when placed under pressure throughout the final straight.

K Fursdon (IFFRAAJINATOR) – Issued with a warning for presenting IFFRAAJINATOR to race in visor blinkers which were not notified.

W Pinn (MR BAZAMOUR) - Issued with a warning for weighing in over the weight at which he weighed out at. Spoken to regarding his actions in the barrier stall when his mount became fractious.

Race 10 | **BRENDON & LYNN BRADLEY BAYLEYS COMMERCIAL 1400**

BENTAYGA (S Collett) – Began awkwardly losing ground. Raced keenly in the early to middle stages.

CORINNE (B Grylls) - Began awkwardly.

TAVIDORA (S Weatherley) – Slow to begin. Held up for a majority of the final straight.

INCA WARRIOR (W Pinn) – Raced three wide without cover throughout. Inconvenienced just prior to the winning post by TAVIDORA which shifted inwards. S Weatherley was advised to exercise care in similar circumstances.

NEW DAWN (K Asano) – Raced wide without cover throughout.

TELLMESOMETHINGBOY (T Thornton) – Held up until passing the 200 metres.

RUN FOR COVER (E Leighton) – Lay out when placed under pressure in the final straight.

FOUR QUEENS (M McNab) – Held up early in the final straight.

M McNab (FOUR QUEENS) - Admitted a charge of using the whip in three consecutive strides on his mount FOUR QUEENS inside the 100 metres. After considering submissions the Adjudicative Committee imposed a fine \$150.
