#### **GENERAL**

BB Hong was permitted to ride **LINCOLN DREAMER** in Race 6 at 1 kilo over the carded weight due to there being no other available rider.

#### **RACE COMMENTS**

#### Race 1 SINCLAIR TRANSPORT & ADVANCE AGRICULTURE MAIDEN (1200 metres)

MIANNA (B May) - Began awkwardly. Raced wide throughout.

**THE LAST THYME** (K Williams) - Shifted out abruptly as the start was made crowding outside runner. Raced three-wide without cover through the early and middle stages. Crowded and had to be steadied passing the 150 metres.

THE BOLD LIONESS (R Mudhoo) - Crowded at the start losing ground.

**LOCHNABERRY** (G Jogoo) - Slow to begin. Raced greenly in the final straight and ducked outwards passing the 150 metres hampering BOB MARLIE and JIMILICIOUS. Shifted ground passing the 75 metres again hampering BOB MARLIE. G Jogoo was advised to exercise greater care and straighten his mount sooner than he did on this occasion.

MOONFLOWER (K Kwo) - Steadied briefly passing the 950 metres to take a trailing position.

**SCHEMER** (S Khetoo) - Lay outwards rounding the final bend.

**BOB MARLIE** (K Mudhoo) - Lay inwards early in the run home having to be straightened. Hampered passing the 150 metres. Again hampered near the 75 metres.

**JIMILICIOUS** (J Laking) - Hampered passing the 150 metres.

**J Lowry** (LEROY) - Issued with a warning when allowing his mount to shift inwards under pressure passing the 150 metres crowding THE LAST THYME which had to be steadied. When assessing this penalty, Stewards were mindful of some outwards movement from THE RADIANT ONE at this point.

#### Race 2 RYAL BUSH TRANSPORT & NIGHTCAPS CONTRACTING 1200

**ZAC BLACK** (S Khetoo) - Began awkwardly losing ground.

**THE GIFT** (S Toolooa) - Began very awkwardly losing ground. When asked to comment on the performance rider reported that after getting back in the early stages the mare had found it difficult to make ground on a fast tempo and would take natural benefit from today's first up run.

WAIMATE BILL (A Bohorun) - Slow to begin.

**HE'S MI BROTHER** (G Jogoo) - Slow to begin.

**TAP 'N' GO** (T Moseley) - Held up for clear racing room late in the run home.

**GRAND EXPRESS** (T Comignaghi) - Held up early in the run home and then had some difficulty obtaining clear racing room for the remainder of the home straight.

**RUBY ROYALE** (C Johnson) - When asked to comment on the performance rider advised that after getting back on a fast tempo the mare had only finished the race off fairly over the concluding stages.

**K Williams** - Admitted a charge of using the whip in two consecutive strides on DREAMING EASY inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$170.

Following the running of this race the official track conditions were upgraded to Dead 6.

#### Race 3 WASHRITE & AB LIME & H.E.N BATT & SON 1600

**NESTA** (A Bohorun) - Over-raced in the early stages.

THE MOLE (T Comignaghi) - Raced three-wide without cover through the early and middle stages.

**MASTER LINCOLN** (C Johnson) - Lost contact with the body of the field through the middle stages despite the efforts of its rider.

**COLOUR ME RED** (S Wynne) - Raced wide without cover from the 800 metres.

**SADLER'S LASS** (T Moseley) - When asked to comment on the performance rider advised he had been under pressure turning for home and could offer no tangible excuse for the mare which had only battled over the concluding stages.

**S Khetoo** (FULL FURY) - Issued with a warning (in the presence of the Riding Mentor) under Rule 638(3)(f)(ii) when using his whip with an action which raised the Rider's arm above shoulder height.

### Race 4 HYDE LANDSCAPING & TRENZ HOMES MAIDEN 1400

**PROBELLA** (K Mudhoo) - Began awkwardly losing ground and was further hampered when ROCK SHOW shifted out. Rider reported the filly had raced greenly throughout.

GALAXY PRINCESS (A Bohorun) - Raced three-wide without cover throughout.

**OPHIR GOLD** (J Laking) - Raced three-wide with cover throughout.

**ROCKSHOW** (G Jogoo) - Raced greenly for the majority of the event. Briefly held up on entering the home straight.

**EBONY MAGIC** (R Mudhoo) - Had to be restrained when becoming awkwardly placed near the 450 metres.

CHEYENNE DREAMS (T Comignaghi) - Held up briefly in the early stages of the run home.

**COSY NOOK** (S Wynne) - Rider reported the gelding had been galloped on during the running. Underwent a post-race veterinary examination which revealed some superficial abrasions to a hind leg.

**WING IT** (K Kwo) - Connections requested a post-race Veterinary examination of the gelding which revealed some lameness in the left hind leg. WING IT was stood down pending a veterinary clearance prior to racing next.

**S Wynne** - Admitted a charge of using the whip in three consecutive strides on COSY NOOK inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$300.

**T Comignaghi** - Admitted a charge of using the whip in two consecutive strides on CHEYENNE DREAMS inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of her license to ride in races from the conclusion of racing on 16<sup>th</sup> October until the conclusion of racing on 23rd October, 5 National riding days and in addition imposed a fine of \$100.

## Race 5 COMMERCIAL HOTEL & COUNTRY JEWEL WINTON CUP (1400 metres)

**RIVIERA ROCK** (J Laking) - Refused to jump away with the field losing its chance. Connections were advised the gelding would be required to barrier trial prior to racing next.

**THE GROWLER** (T Comignaghi) - Had some difficulty obtaining clear running early in the run home having to change ground passing the 150 metres.

Following the running of this race Stewards sought a Ruling from the Adjudicative Committee as to whether KING COUGAR had gained an unfair advantage when anticipating the start and forcing the starting gates open just prior to the dispatch. After viewing the footage and hearing evidence from the Stewards, Starter Mr S Batt and Trainer S Tyler the Adjudicative Committee ruled KING COUGAR had received an unfair advantage and was subsequently declared a non-runner pursuant to Rule 632(2).

**S Wynne** - Admitted a charge of using the whip in two consecutive strides on FIRODEN inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$500.

#### Race 6 O'MEARA CRUTCHING & TRAVELLERS REST TAVERN 1400

The start of this event was delayed approximately 4 minutes due to the enquiry in the previous race.

**CHOICE DU JEU** (K Williams) – Underwent a pre-race veterinary inspection and was cleared to start after the rider had reported the mare had felt indifferent in its action in the preliminary. Crowded at the start losing ground.

FLY WITHOUT WINGS (A Bohorun) - Slow to begin.

**SAVEZAR** (K Mudhoo) - Began awkwardly losing some ground.

**ROSEY POSEY** (S Wynne) - Shifted out abruptly at the start crowding outside runners. Had to be severely restrained off heels near the 500 metres.

**MIRADELLO** (T Comignaghi) - Crowded at the start losing ground. Awkwardly placed near the 300 metres when held up, only gaining clear running inside the 200 metres.

**TROUBLE** (G Jogoo) - Steadied near the 600 metres when improving quickly on to heels.

**NEVER QUITZ** (T Moseley) - Made the bend near the 500 metres awkwardly with the rider reporting the mare had reacted badly and gone off stride when briefly placed in restricted room on the point of the turn, getting its head up and coming back quickly on to ROSEY POSEY which had to be firmly restrained.

**SYMPATHIQUE** (R Mudhoo) - Raced wide without cover for the majority of the event. Contacted from the inside passing the 400 metres.

**LINCOLN DREAMER** (BB Hong) – Had to be firmly restrained near the 400 metres when improving quickly onto the heels of the runner in front who was also being firmly restrained, and shifted outwards abruptly forcing SYMPATHIQUE outwards on to GERRY JOYCE.

**GERRY JOYCE** (S Toolooa) - Heavily contacted by an inside runner near the 400 metres with rider S Toolooa becoming badly unbalanced and losing the use of both irons for the remainder of the race.
