### RACE COMMENTS

**Race 1** | **CHAMPAGNE PRINCESS 1550**

**ENCHANTED ELLE** (E Leighton) – Jumped away awkwardly.

**EXPLOSIVE MISS** (A Goindasamy) - Over-raced in the early and middle stages.

**CATHAY EMPRESS** (M McNab) – Over-raced in the middle stages. Held up entering the final straight.

| <b>Race 2</b>   | <b>CAMBRIDGE EQUINE HOSPITAL 1550</b>                              |
| <p><b>GOODO JO</b> (D Danis) – Slow to begin. Lay in when placed under pressure in the final straight.</p> <p><b>SIETE</b> (R Beemud) - Slow to begin.</p> <p><b>THE HITMAN</b> (S Collett) - Raced wide in the early stages before improving forward to lead near the 1100 metres.</p> <p><b>THE NIGHT KING</b> (C Grylls) – Had to be steadied when racing keenly passing the 1150 metres. Had difficulty obtaining clear running entering the final straight, then lay in passing the 250 metres becoming awkwardly placed on heels.</p>   |  |
| <b>Race 3</b>   | <b>GO RACING BUYING EUROPEAN STAYERS THIS MONTH 1550</b>           |
| <p><b>BOUFFANT</b> (C Lindsay) - Slow to begin. The trainer reported that the mare had got its tongue over the bit during the running.</p> <p><b>VULTURE STREET</b> (E Leighton) - Slow to begin. Had some difficulty obtaining clear running early in the final straight.</p> <p><b>FELIX FAURE</b> (E McCall) – Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary examination which revealed lacerations inside the nostril.</p> <p><b>INTO THE DEEP</b> (S Collett) - Returned to the enclosure with blood present in the right nostril. Underwent a post-race veterinary examination which deemed the gelding to have bled. INTO THE DEEP shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.</p> <p><b>SCAGLIONI</b> (T Newman) - Improved onto heels approaching the 200 metres having to be firmly restrained before shifting outwards to improve.</p> |  |
| <b>Race 4</b>   | <b>BOSTONIAN 1300</b>  |
| <p><b>SHARK BITE</b> (B Grylls) – Placed in restricted room shortly after the start having to be steadied. Over-raced through the middle stages.</p> <p><b>CHAMPAGNES ON ME</b> (T Newman) - Had difficulty obtaining clear running until near the 150 metres.</p> <p><b>USURER</b> (R Elliot) - When questioned regarding performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.</p>  |  |
| <b>Race 5</b>   | <b>MARSH RACING 2021 LEADING TRAINER ON POLYTRACK 1300</b>         |
| <p><b>ACQUITTAL</b> (R Beemud) - Began awkwardly losing ground.</p> <p><b>ELUSIVE CAPITAL</b> (M Alam) - Began awkwardly then hampered shortly after having to be steadied. Had to be steadied after becoming awkwardly placed on heels passing the 800 metres.</p> <p><b>EASY</b> (L Satherley) - Raced greenly when placed under pressure in the final straight.</p> <p><b>PORTOFINO</b> (R Elliot) - Had to be firmly restrained when placed in restricted room passing the 50 metres to the outside of EASY which shifted out and away from LILY'S LADY which had shifted out slightly. Contributing was slight inward movement from RIP VAN GOGH. When assessing the incident Stewards could not find one rider culpable for the interference with L Satherley being advised to exercise care in similar circumstances.</p>  |  |
| <b>Race 6</b>   | <b>ASHVIN GOINDASAMY 2021 LEADING APPRENTICE ON POLYTRACK 1300</b> |
| <p><b>RICH GIRL</b> (D Johnson) - Began awkwardly.</p>  |  |

**WAIHI WARRIOR** (A Goindasamy) – Began awkwardly. Raced in restricted room for a distance having to be steadied approaching the 1000 metres. Held up for the majority of the final straight.

**LADY PERFORMER** (J Fawcett) - Slow to begin. Improved onto heels passing the 500 metres having to be steadied then was held up until shifting outwards passing the 250 metres.

**KWAUSSIE GIRL** (C Grylls) – Raced three wide without cover throughout.

**ELLE AYE LADY** (M McNab) - Had difficulty obtaining clear running early in the final straight.

**LITTLE JOE** (B Grylls) - Contacted passing the 50 metres by KWAUSSIE GIRL which shifted out slightly.

**M McNab** (ELLE AYE LADY) - Reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit him to do so.

**M Alam** (MR RAINBOW) - Admitted a charge in that he struck his mount MR RAINBOW six times prior to the 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$250.

**Race 7** | **LYNSEY SATHERLEY 2021 LEADING RIDER ON POLYTRACK 970**

**VALADAMS** (S Weatherley) - Slow to begin. Unable to obtain clear running throughout the final straight.

**SHOW ME CHAMPAGNE** (J Kamaruddin) - Slow to begin.

**NUHAKA** (C Lindsay) - Crowded shortly after the start having to be steadied. Raced wide without cover throughout.

**TREE OF LIFE** (D Johnson) – Crowded shortly after the start having to be steadied.

**OVER TO YOU** (T Newman) – Raced three wide without cover throughout.

**ALBY PARK** (J Fawcett) - Had difficulty obtaining clear running early in the final straight before improving into a marginal run approaching the 100 metres which failed to eventuate having to be steadied, then was held up for the remainder of the race.

**OH NO NO NO** (R Elliot) – Held up rounding the final bend before shifting outwards entering the final straight to obtain clear running.

**PAPENHUYZEN** (C Grylls) - Lay in when placed under pressure in the final straight then had to be steadied when placed in restricted room passing the 100 metres to the inside of SHOW ME CHAMPAGNE which shifted in abruptly after being struck with the whip before being straightened by its rider. J Kamaruddin was advised to exercise care in similar circumstances.

**Race 8** | **ANDREW CAMPBELL FAREWELL 2000**

**DUSKY EYES** (B Grylls) - Slow to begin.

**KING ZAZU** (M McNab) – Raced keenly through the middle stages. Underwent a post-race veterinary examination which did not reveal any abnormality.

**FERDINAND** (D Johnson) – Raced three wide without cover throughout.

**IMPLICIT** (T Newman) – Held up rounding the bend and early in the final straight.

**D Johnson** (FERDINAND) - Admitted a charge in that she struck her mount FERDINAND in two consecutive strides over the concluding stages. After considering submissions the Adjudicative Committee imposed a fine of \$300.
