Race 8 – SARAH SEARANCKE CATERING 1400

RACE COMMENTS

Race 1 | **TARANAKI STEELFORMERS MDN 2000M**

ZUMA ROCK (L Kauri) - Began awkwardly.

TWENTYONEBLACK (R Hannam) - Raced greenly in the early stages. Commenced to give ground from 850 metres and was not persevered with in the final straight. A post-race veterinary examination was clear. Connections were advised that the gelding must trial to the satisfaction of the stewards prior to its next start. P Didham advised that TWENTYONEBLACK would not be persevered with as a racing proposition.

R Elliot (REGAL LION) - Was unable to make the weight for REGAL LION being 1 kilo over so was fined \$200 under the Minor Infringement Schedule. S Macnab replaced R Elliot.

The track was downgraded to Slow 7 retrospective to race 1 following showers.

Race 2 | **TARANAKI ASSOCIATED CLEANERS 1100**

LIGHTNING FIELD (N Parmar) - Slow away.

LORD VALENTINE (L Allpress) - Restrained to the rear shortly after the start.

THE PANTHER (M McNab) - Held up shortly before entering the final straight.

AVONALLO (J Kamaruddin) - Rider advised the gelding failed to handle the existing track conditions. Underwent a post-race veterinary examination which was clear.

Race 3 | **COMCAT5 MDN 1200M**

MIDNIGHT SPECIAL (M McNab) - Over raced in the early stages and when being steadied off heels shifted out and bumped with BUGATTI. M McNab was advised to exercise greater care when shifting ground.

BUGATTI (C Grylls) - Bumped for a short distance near the 800 metres.

TWOMINUTESINHEAVEN (A Mudhoo) - Over raced approaching the 800 metres having to be steadied.

SWEET KARMA (D Montes de Oca) - Shifted in approaching the 800 metre bend when not the required distance clear of TWOMINUTESINHEAVEN which was over racing and had to be steadied. D Montes de Oca was shown footage of his ride in the presence of the Riding Master and advised to exercise care.

HENRY JAMES (S Macnab) - Had to be steadied off heels near the 700 metres.

PASHAMALA (F Lazet) - Raced greenly throughout and hung inwards in the home straight.

LORD DONOVAN (L Allpress) - Held up in the early stages of the home straight behind the tiring DURBAN WAY until near the 175 metres.

DOUGLAS BLACK (A Goindasamy) - Held up throughout the home straight.

HIGHBORN (J Kamaruddin) - Held up briefly making the final bend.

Race 4 | **OCEAN EMPEROR @WEOWNA PARK 3YO**

AND WE DANCED (L Allpress) - Restrained to the rear shortly after the start. When questioned L Allpress advised AND WE DANCED travelled well in the early and middle stages but came to the end of its run inside the 200 metres where the filly commenced to lay in under pressure. L Allpress was of the opinion AND WE DANCED would improve with the run.

Race 5

BUDDY MARVELLOUS (F Lazet) - Slow away. Over raced near the 800 metres.

RAGGY ANN (A Mudhoo) - Began awkwardly.

BLUE CHOIX (S Macnab) - Raced wide throughout. Over raced early and middle stages. Underwent a post-race veterinary examination which was clear.

M Singh (LATIN QUARTER) - Was spoken to with regard to using his whip on a runner out of contention.

Race 6 | **STELLA ARTOIS 1600**

SLIM (J Mudhoo) - Raced wide throughout.

ALL THAT JAZZ (A Mudhoo) - Began awkwardly.

LORD SPENCER (S Macnab) - Held up final turn.

GOBUYIT (L Allpress) - Lay outwards final turn.

SHEZ EKSTRA (R Hannam) - When questioned into the performance rider advised the mare would be better suited to more rain effected going.

RACE 7 | **LANDMARK HOMES 1950**

SHOWBOURNE (A Mudhoo) - Over raced through the middle stages. When questioned rider advised the mare was unsuited to the conditions under foot today.
