Race 1 - WAIKATO PRINTING COMPANY 1600

WORDSWORTH (J Riddell) – Trainer Ms M Falconer advised Stewards WORDSWORTH underwent a veterinary examination on Tuesday 26 October, which revealed no abnormalities. M Falconer further advised the gelding has now been sent for a spell.

Race 6 MATAMATA VETERINARY SERVICES SOLILOQUY STAKES (G3) (1400 metres)

MILLEFIORI (J Kamaruddin) – Trainer Mr J Richards reported to Stewards he was satisfied with the post-race condition of MILLEFIORI, however, the filly has now been sent for a spell.

Race 7 FAIRVIEW MOTORS MATAMATA 1400

AERO DE PARIS (M McNab) – Co-trainer Mr A Scott advised Stewards the stable was satisfied with the post-race condition of gelding; however, AERO DE PARIS has now been sent for a spell.

RACE COMMENTS

Race 1 BETH DAWSON POWERS REALTY MAIDEN (1200 metres)

SOCIAL DISTANCE (E Leighton) – Began awkwardly losing ground.

STARS 'N' CREAM (T Yanagida) - Was inclined to lay out in the final straight.

MOOVIT ONOVA (M McNab) - When questioned regarding performance rider advised that the gelding had never travelled well, being a beaten runner a long way out and was unable to offer any excuse. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

T Yanagida (STARS 'N' CREAM) – Spoken to regarding his whip use on a runner that was clearly winning.

Race 2 NZB INSURANCE PEARL SERIES RACE (1200 metres)

HALF OF NOTHING (T Yanagida) - Slow to begin. Had to be steadied when becoming awkwardly placed on heels near the 250 metres.

MISTRESS MINX (E Leighton) - Slow to begin. Held up in the straight only obtaining clear running near the 50 metres.

SUSSEX (N Parmar) – Raced wide without cover throughout. Lay out rounding the final turn and in the straight dictating SOCIALIGHTS outwards inconveniencing HALF OF NOTHING which had to steady near the 250 metres. When questioned rider was satisfied with the mare's performance after being caught wide. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

SOCIALIGHTS (O Bosson) - Raced wide early. Dictated wider in the straight.

CANNSEA CLEARLY (V Colgan) – Held up rounding the final turn and early in the straight having to shift ground to obtain clear running passing the 300 metres.

IGOTTADOITMYWAY (B Grylls) – Had to be steadied just short of the finishing line when placed in restricted room.

LADY DE WINTER (J Kamaruddin) - Steadied when improving onto heels passing the 600 metres.

J Kamaruddin (LADY DE WINTER) - Reminded of his obligation to ride his mounts out fully to the finish.

Race 3 CONTRIBUTER STANDING AT MAPPERLEY STUD (1200 metres)

MANRICO (N Parmar) – Contacted leaving the barriers losing ground.

Race 4 LEE STRINGER POWERS REALTY MAIDEN (1300 metres)

THE FIRST LINK (J Fawcett) - Jumped away awkwardly. Over-raced when being restrained for a distance passing the 1100 metres. Held up near the 400 metres continuing to have difficulty obtaining clear running until shifting ground back to the inside passing the 200 metres.

TU MEKE POTAE (E Leighton) - Raced three wide without cover throughout. Lay out under pressure in the final straight.

MACROS (N Parmar) - Raced wide early.

CALVETTO (C Grylls) - When questioned regarding performance rider advised that the gelding had failed to handle today's heavy track conditions.

TUMBRIL (V Colgan) - Contacted shortly after leaving the barriers having to be steadied when forced across the heels of MOLLYS GAME losing ground.

DEGREEOFINNOCENCE (J Kamaruddin) - Raced four wide without cover through the early stages.

BEAU ARCHERS ROSE (M Sanson) – Raced three wide without cover throughout.

OFFENDED (S McKay) - Jumped away awkwardly making contact then having to be steadied losing ground. Improved onto the heels of LITTLE JOE which shifted out near the 100 metres.

LITTLE JOE (B Grylls) – Had to shift ground when improving onto the heels of OFFENDED near the 100 metres.

MOLLYS GAME (T Yanagida) – Lay out crossing the junction onto the course proper near the 1450 metres hampering INVIALO.

INVIALO (A Goindasamy) – Hampered near the 1450 metres.

MASTER ORTEGA (M McNab) - When questioned regarding performance rider advised that the colt had failed to handle today's heavy track conditions.

BEFRANKLIN (O Bosson) - Commenced to give ground from the 600 metres and was not persevered with in the final straight. When questioned regarding performance rider was unable to offer any excuse. Underwent a post-race veterinary inspection which found the gelding to have a poor rate of recovery with high respiratory and heart rates.

S McKay (OFFENDED) - Admitted a charge in that he struck his mount six times prior to the 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 6 TEAM BRADLEY BAYLEYS COMMERCIAL HANDICAP (1600 metres)

THEBEASTFORTHEEAST (J Fawcett) – Began awkwardly.

JOY ALONE (M McNab) - Commenced to race greenly when placed under pressure making brief contact near the 300 metres with SHE'S A MANEATER, then made contact again approaching the 200 metres.

SHE'S A MANEATER (J Kamaruddin) - Made contact with JOY ALONE near the 300 metres and again near the 200 metres, being inclined to shift ground under pressure.

Race 7

PRH TRANSPORT TROPHY (1600 metres) (Listed Race)

BATTLE TIME (J Fawcett) – Had to be restrained off heels passing the 1200 metres when racing keenly.

TANNAHILL (E Leighton) - Raced three wide without cover. When questioned regarding performance rider advised that the gelding had become quite worked up prior to the race and was further of the opinion that it had failed to handle today's track conditions. Underwent a post-race veterinary inspection which found the gelding to be 1/5 lame in the left hind leg.

E Leighton (TANNAHILL) - Admitted a charge in that she weighed in .8 kilograms heavier than she weighed out at. After considering submissions the Adjudicative Committee imposed a fine of \$200.

Race 8 MILLS REEF HANDICAP (2100 metres)

MODESTY (E Leighton) - Began awkwardly. Became awkwardly placed near the heels of MR BIG near the 900 metres which in turn was steadying off the heels of MISS ONAKI. MODESTY then shifted outwards when being steadied making contact with CINNAMON STAR which then lay back in making further contact with MODESTY.

UNCLE TERRY (S McKay) – Over-raced in the early stages when being restrained and made the first bend awkwardly.

TOUCH THE CLOUDS (A Goindsamy) - Briefly steadied near the 1800 metres when IFFIE SHOWS shifted inwards when not fully clear. J Fawcett was advised to exercise care.

MR BIG (M Sanson) - Over-raced for a distance passing the 1600 metres.

CINNAMON STAR (M Cameron) - Hampered when contacted near the 900 metres.

GLOBAL CURRENCY (M McNab) - Lay inwards early in the straight.

MISS ONAKI (C Grylls) - When questioned regarding performance rider advised that the mare had travelled well enough but had been quickly beaten when placed under pressure near the 400 metres and was unable to offer any excuse. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.
