#### RACE COMMENTS

##### Race 1 GREYMOUTH STAR MAIDEN (1500m)

**WANNABE 'N' VEGAS** (T Comignaghi) - Taken back from a wide draw to obtain cover. Had a tendency to lay inwards in the home straight. When asked to comment on the performance the rider advised that she was obliged to get back from a wide draw and found it difficult to make ground on a good tempo over the concluding stages.

##### Race 2 FRANK MCLAUGHLIN MEMORIAL MAIDEN (1500m)

**VELARDE** (T Moseley) - Began awkwardly.

**EMPRESS QI** (S Macnab) - Began awkwardly losing some ground.

**POITIN** (F Lazet) - Crowded leaving the barriers.

**KENKI** (J Laking) - Slow to begin (3L).

**THE BOUQUET SLAYER** (L Callaway) - Raced wide in the early stages. Steadied when placed in restricted room near the 100 metres.

**SAHARA EXPRESS** (T Comignaghi) - Raced three-wide without cover from the 800 metres.

##### Race 3 VERNON & VAZEY TRUCK PARTS MAIDEN (1100m)

**FAH LUN** (A Balloo) - A Balloo replaced J Laking as the rider due to a communication error. Slow to begin. Badly hampered going into the bend near the 950 metres.

**CATS IN THE CRADLE** (S Macnab) - Fractious in its barrier stall. Badly hampered going into the bend near the 950 metres. Reported by trainer P Harris to be showing signs of soreness on return to the stabling area. A post-race Veterinary examination revealed the filly to have a suspected tendon injury to the left fore leg. Trainer P Harris was advised that a Veterinary clearance would be required prior to the filly racing next.

**COUNTRY CHEDDAR** (T Comignaghi) - Slow to begin. Attempted to run off going into the first turn near the 950 metres badly hampering EASYRIDER, CATS IN THE CRADLE and FAH LUN. Continued to race very ungenerously, proving a very difficult ride and being retired from the race approaching the 400 metres. Continued to prove difficult to control running off rounding the final turn and dislodging rider T Comignaghi who was uninjured in this incident. Connections were advised that the mare must barrier trial on at least two occasions to the Stewards satisfaction prior to resuming racing.

**DENY** (K Mudhoo) - Slow to begin. Raced greenly in the final straight and had to be steadied off heels passing the 75 metres.

**EASYRIDER** (K Chowdhoo) - Badly hampered going into the bend near the 950 metres.

**BODYGUARD** (L Callaway) - Became awkwardly placed on heels near the 200 metres having to be steadied.

##### Race 4 GREYMOUTH BUSINESSES SPRINT (1100m)

**STREET FIGHTIN MAN** (J Laking) - Raced three-wide without cover.

**WALKTHISSWEY** (K Chowdhoo) - Had to be firmly restrained when improving onto heels over the concluding stages.

<b>Race 5</b>	<b>GO RACING BUYING @ MAGIC MILLIONS THIS MONTH (1100m)</b>
<p><b>CROP</b> (R Mudhoo) - Very slow to begin (4L).</p> <p><b>TAP 'N' GO</b> (L Callaway) - Raced three-wide without cover until passing the 700 metres.</p> <p><b>HE'S READY</b> (K Chowdhoo) - Held up for a short distance rounding the final turn until near the 200 metres.</p> <p><b>GAS MONKEY</b> (F Lazet) - Inclined to lay inwards in the final straight and was inconvenienced near the 175 metres.</p> <p><b>K Mudhoo</b> (CHARMAINE'S DREAM) - Issued with a warning when angling his mount outwards passing the 175 metres when not fully clear of GAS MONKEY which had to be steadied.</p>	
<b>Race 6</b>	<b>JACK CURRAGH MEMORIAL (1500m)</b>
<p>Trainer <b>J Burrows</b> (MAIDINTHEMIST) Admitted a charge in that she presented this runner in racing plates that were in an unsatisfactory condition and was fined \$150 under the Minor Infringement Schedule.</p> <p><b>MAIDINTHEMIST</b> (S Toolooa) - Late scratching at 3.04pm by order of the Stewards after being presented with racing plates that were in an unsatisfactory condition.</p> <p><b>BOSTON STRONG BOY</b> (T Comignaghi) - Jumped in the air at the start and was slow away as a result. When asked to comment on the performance rider could offer no tangible excuse.</p> <p><b>EXQUISITE PEARL</b> (T Moseley) - Made the first turn awkwardly when racing keenly. Inconvenienced passing the 50 metres when SHOWBOURNE (R Mudhoo) lay outwards under pressure. R Mudhoo was advised he must straighten his mounts sooner than he did so on this occasion.</p> <p><b>SHOWBOURNE</b> (R Mudhoo) - Lay outwards under pressure over the concluding stages.</p> <p>Following the running of this race apprentice rider <b>F Lazet</b> reported she was suffering from a hand injury. Miss Lazet was examined by the on-course Paramedics and stood down from her remaining riding engagements today with replacement riders as per the Summary above. Miss Lazet was referred to Greymouth Hospital for further examination and was advised a medical clearance would be required prior to her resuming riding.</p>	
<b>Race 7</b>	<b>WESTLAND RACING CLUB MISS SCENICLAND STAKES (1500m)</b>
<p><b>PURE CLASS</b> (A Balloo) - Slow to begin. Connections advised the mare may not have appreciated today's firmer track conditions. A post-race Veterinary examination revealed no obvious abnormality.</p> <p><b>OH NO NO NO</b> (L Callaway) - Over-raced when being restrained in the early stages and shifted outwards to avoid the heels of SEVERINE near the 900 metres, inconveniencing MAMMA SANS.</p> <p><b>MAMMA SANS</b> (T Moseley) - Inconvenienced near the 900 metres.</p> <p><b>SAVANAH BELLE</b> (R Mudhoo) - Restrained to obtain cover in the early stages after jumping from a wide barrier. Steadied away from heels near the 900 metres when over-racing. Raced wide from the 800 metres.</p> <p><b>REDGUM</b> (K Mudhoo) - Restrained to obtain cover in the early stages after jumping from a wide barrier. Got its head up on several occasions when making the bend near the 800 metres awkwardly.</p>	

**K Williams** (ALL ABOUT MAGIC) - Admitted a charge of using the whip in two consecutive strides on her mount near the 50 metres. After considering submissions the Adjudicative Committee imposed a fine of \$500.

**Race 8** | **RECREATION HOTEL GREYMOUTH CUP HANDICAP (2000m)**

**MONDORANI** (S Macnab) - Slow to begin.

**WANNABE 'N' PARIS** (K Chowdhoo) - Had to be steadied off heels near the 1600 metres.

**HUSK** (K Williams) - Raced wide without cover until near the 1500 metres. Finished in a distant last placing with a post-race Veterinary examination of the gelding revealing no obvious abnormality.

**CAMINO ROCOSO** (J Laking) - Raced wide from the 800 metres.

**ALJAY** (R Mudhoo) - Observed to have blood present in its mouth on return to the stabling area with a post-race Veterinary examination revealing the gelding to have a minor laceration to its tongue.

**Race 9** | **GREG DALY REAL ESTATE (2000m)**

**VENETO** (L Calloway) - Stewards granted permission for L Calloway to ride this mare 2kgs over the contracted weight due to no other rider being available.

Trainer **K Myers** (LUCKY VIKING) Issued with a warning when presenting this gelding without the notified visor blinkers.

**NADEEMS DREAM** (T Moseley) - Underwent a pre-race Veterinary examination after contacting the gate when leaving the birdcage and was cleared to race.

**CHICA BONITA** (K Chowdhoo) - Slow to begin (4L).

**OCEANS AWAY** (C Johnson) - Raced keenly through the early stages before improving forward.

**ARE YOU CEREAL** (K Williams) - Over-raced in the early stages and got its head up when being steadied to avoid the heels of AMAZON GODDESS when both these runners shifted ground passing the 1600 metres As a consequence of this incident the trailing LUCKY VIKING also had to be restrained. Improved quickly on to heels passing the 700 metres and when being shifted out to avoid those heels made firm contact with TANTALEE.

**LUCKY VIKING** (S Macnab) – Had to be restrained passing the 1600 metres to avoid heels.

**TANTALEE** (R Mudhoo) - Raced wide in the early to middle stages. Buffeted near the 700 metres.

**K Williams** (ARE YOU CEREAL) - Issued with a warning when angling her mount outwards making firm contact with TANTALEE near the 700 metres.
