**SUPPLEMENTARY****Waikouaiti Racing Club - Saturday, 15 January 2022****Race 3 PROPERTY BROKERS 1200m**

**DARCI PALMER (K Chowdhoo)** – Trainer Mr S Marsh advised Stewards, on return to the stable DARCI PALMER underwent a veterinary examination which included x-rays and blood tests which revealed no abnormalities. S Marsh further advised it is his intention to continue on with the gelding's current preparation.

**RACE COMMENTS****Race 1****RICCARTON PARK FUNCTION CENTRE MAIDEN 2000m**

**KENKI** (J Laking) - Slow to begin.

**PRINCESS NALA** (T Jonker) - Began awkwardly losing ground.

**IDLE LADY** (T Comignaghi) - Began awkwardly shifting outwards making contact with RED SUNDAY.

**RED SUNDAY** (C Johnson) - Contacted on jumping.

**PENTESLA** (T Moseley) - Taken back from a wide draw to obtain cover.

**GRANDILOQUENT** (K Williams) - Over raced when being restrained in the early stages. Jumped the crossing at the 1800 metres. When questioned regarding performance rider could offer no excuse. A post race veterinary examination revealed a slow recovery rate.

**DICELAND** (R Mudhoo) - Over raced in the early stages then three wide without cover for the majority of the event.

**FORT WILLIAM** (B Murray) - Gave ground passing the 500 metres and was not persevered with in the final straight. When questioned regarding performance rider could offer no excuse. A post race veterinary examination did not reveal any obvious abnormality.

**T Comignaghi** (IDLE LADY) - Admitted a charge in that she struck her mount IDLE LADY 7 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of T Comignaghi's licence to ride in races from the conclusion of racing on Saturday 29 January until the conclusion of racing on Thursday 10 February, 7 national riding days, and in addition imposed a fine of \$200.

**D Montes de Oca** (ROYAL KHAN) - Admitted a charge in that he struck his mount ROYAL KHAN 6 times prior to the 100 metre mark and used his whip with an action which raised the rider's arm above shoulder height on two occasions near the 100 metres. After considering submissions the Adjudicator imposed a suspension of D Montes de Oca's licence to ride in races from the conclusion of racing on Saturday 29 January until the conclusion of racing on Wednesday 9 February, 6 national riding days.

**Race 2****PUNTERS CHALLENGE 9 APRIL MAIDEN 1600m**

**POSER** (K Asano) - The start was delayed when POSER became very fractious in its barrier and was removed to undergo a pre-race veterinary inspection. POSER was subsequently late scratched at 1.59pm on veterinary advice. Trainer A Carson was advised that POSER is required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**SNITZEL VANCUMB** (D Bothamley) - Began awkwardly losing ground then being further hampered shortly after.

**SANTIAGO MISS** (K Mudhoo) - Began awkwardly shifting inwards making contact with MIANNA.

**MIANNA** (T Comignaghi) – Contacted leaving the barriers.

**SWEET LILLY** (G Jogoo) - Began awkwardly losing some ground. Over raced in the middle stages.

**TAWHIRIMATEA** (J Laking) - Crowded shortly after the start losing ground when DRUMISLE lay outwards with SNITZEL VANCRUMB also being hampered as a result.

**EMPRESS QI** (L Callaway) - Raced very wide throughout.

**CRAVING** (A Balloo) - Raced three wide without cover.

**THE UNNAMED FEELING** (T Moseley) - Steadied when placed in restricted room near the 250 metres.

**BB Hong** (ZAWEEELA) – Admitted a charge in that he struck his mount ZAWEEELA 10 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of BB Hong’s licence to ride in races from the conclusion of racing on Saturday 22 January until the conclusion of racing on Saturday 5 February, 6 national riding days.

**Race 3** | **KARAKA 2022 7 – 12 MARCH MAIDEN 1200m**

**DUBAI LADY** (K Williams) - Bounded at the start losing ground.

**HEADS UP** (G Jogoo) - Began awkwardly losing ground. Over raced in the early stages having to be restrained off heels passing the 1100 metres. Inconvenienced near the 400 metres when REPUTABELLE which was shifting outwards to obtain clear running was taken out further by SHOW US PLENTY.

**SHOW US PLENTY** (Y Atchamah) - Lay inwards under pressure in the straight hampering WHATA SHAMBLES near the 100 metres. Rider Y Atchamah was advised to exercise care.

**Race 4** | **PETER & HELEN CORDNER MAIDEN 1200m**

**SWISS ‘N’ GIGGLES** (B Murray) - Reared as the start was effected with the rider making contact with the structure of the starting gates and as a result began very awkwardly losing ground. B Murray was attended to by ambulance personnel following the race for a minor neck injury and was able to fulfil his remaining engagement.

**CHAMONIX** (A Balloo) - Slow to begin.

**LIPA MALA** (K Williams) - Shifted outwards abruptly at the start crowding outside runners.

**SPORT MODE** (C Johnson) - Jumped away awkwardly losing ground.

**GREEN EGGS AND HAM** (S Toolooa) - Crowded shortly after the start losing ground.

**AREYOUOKAY** (B May) - Crowded shortly after the start losing ground.

**TADITA** (K Asano) - Shied and shifted outwards abruptly passing the 200 metres hampering COPY THAT and POSTCODE ENVY.

**COPY THAT** (K Chowdhoory) - Hampered passing the 200 metres and made contact with POSTCODE ENVY as a result unbalancing both runners.

**POSTCODE ENVY** (T Comignaghi) - Hampered and unbalanced passing the 200 metres when contacted.

**IN VEGAS** (K Mudhoo) - Hampered passing the 200 metres when SAVVY BOY (D Montes de Oca) shifted outwards. D Montes de Oca was advised to exercise greater care.

**Race 5** | **A & L BROWNE BLOODSTOCK 1200m**

**HARLEEN QUINZEL** (B May) - Slow to begin. Inconvenienced approaching the 200 metres.

**LOVEBUG** (T Comignaghi) - Slow to begin then further hampered shortly after when CEDDY SMITH shifted outwards abruptly. Rider reported that the mare had felt indifferent in its action. A post-race veterinary inspection revealed signs of tying up. Stewards will follow up with connections in coming days.

**CEDDY SMITH** (D Montes de Oca) - Shifted outwards abruptly at the start.

**FAME SHINES** (L Callaway) - Had some difficulty obtaining clear running early in the straight and was inclined to lay in then being hampered approaching the 200 metres when SELFIE shifted outwards.

**OUR ROSETTE** (K Chowdhoo) - Held up passing the 400 metres. Eased down over the concluding stages with the rider unable to offer any excuse when questioned regarding performance.

**SELFIE** (K Mudhoo) - Held up passing the 300 metres and when shifting ground near the 200 metres hampered FAME SHINES which had to be steadied away from heels.

**K Mudhoo** (SELFIE) - Issued with a warning after permitting SELFIE to shift outwards when not sufficiently clear of FAME SHINES which was hampered near the 200 metres.

**Race 6** | **FORD CONTRACTING 1400m**

Following the running of this race Stewards requested a ruling from the Adjudicator as to whether **LINEDANCEKING**, **STRIKE FORCE** and **FEELIN' FANCY** had been denied a fair start. After viewing films and hearing submissions all three runners were declared non-starters. The starter was spoken to regarding starting procedures and in particular the need to ensure that a definitive all clear is always received prior to depressing the start button.

**LINEDANCEKING** (A Balloo) - Got its head down attempting to escape under the barriers prior to the start with the rider dismounting. A short time afterwards the start was effected whilst LINEDANCEKING was still riderless. LINEDANCEKING was subsequently declared a non-starter by the Adjudicator with all bets to be refunded. Trainer S Woodsford was advised that a warning will be placed against LINEDANCEKING for its barrier manners.

**STRIKE FORCE** (J Laking) - Deemed to have been denied a fair start by the Adjudicator, being in an adjacent stall to the riderless LINEDANCEKING and accordingly was declared a non-starter with all bets to be refunded.

**FEELIN' FANCY** (K Chowdhoo) - Deemed to have been denied a fair start by the Adjudicator, being in an adjacent stall to the riderless LINEDANCEKING and accordingly was declared a non-starter with all bets to be refunded.

**YAMUNA** (S Toolooa) - Slow away.

**HEE'S OUR SECRET** (T Moseley) - Slow away.

**HARBOURSIDE** (K Williams) - Over raced when being restrained near the 1100 metres.

**Race 7** | **SPEIGHT'S 2000m**

**COLORADO MISS** (A Balloo) - Slow to begin.

**SAIGON HOT NIGHT** (K Mudhoo) - Slow to begin.

**TOO FERLAXED** (K Asano) - Began awkwardly. Steadied when placed in restricted room to the inside of VAGUE near the 250 metres then shifting outwards across the heels of that runner to obtain clear running.

**OCEANS AWAY** (C Johnson) - Over raced through the early to middle stages.

**POLAR NIGHT** (T Comignaghi) - Over raced in the middle stages. Briefly held up early in the straight.

**LETSBRINGITON** (G Jogoo) - Lay in throughout the run home having to be straightened on a number of occasions and not able to be ridden out fully by its rider.

**Race 8**

**RACECOURSE HOTEL & MOTOR LODGE 1600m**

**SKAABOOM** (L Callaway) - Slow to begin.

**JUST A PROMISS** (T Jonker) - Began awkwardly.

**VULTURE STREET** (K Williams) - Slow to begin.

**SECOND THOUGHT** (K Mudhoo) - Bounded at the start and lost some ground.

**MISTLETOE** (C Johnson) - Crowded and contacted being forced inwards onto MAIDINTHEMIST passing the 1450 metres.

**MAIDINTHEMIST** (R Mudhoo) - Contacted passing the 1450 metres and forced inwards. Checked approaching the 200 metres when CHEEKINI lay inwards despite the efforts of its rider and SHOCK PROSPECT shifted outwards when weakening. VARDON ROAD had to be checked to avoid the heels of MAIDINMIST as a result.

**CHEEKINI** (D Montes de Oca) - Hampered near the 1450 metres. Lay inwards in the final straight having to be corrected by its rider on numerous occasions.

**VARDON ROAD** (B Murray) – Got its head up when racing ungenerously having to be steadied passing the 1000 metres. Checked to avoid heels near the 200 metres.

**ROYAL WINGS** (K Chowdhoo) – Held up early in the straight.

**SURE IS** (T Comignaghi) – When questioned regarding performance rider advised that in her opinion at this stage in its career the mare is better suited to more rain affected footing.

**BB Hong** (SHE'S RECOMMENDED) - Issued with a warning after permitting his mount SHE'S RECOMMENDED to shift inwards when not sufficiently clear of AMAZON GODDESS which was dictated inwards passing the 1400 metres.

**A Balloo** (AMAZON GODDESS) - Admitted a charge of careless riding in that he angled his mount AMAZON GODDESS inwards when not sufficiently clear of MISTLETOE and MAIDINTHEMIST which were contacted and buffeted near the 1450 metres with CHEEKINI being hampered as a result. After considering submissions the Adjudicator imposed a suspension of A Balloo's licence to ride in races from the conclusion of racing on Saturday 29 January until the conclusion of racing on Thursday 10 February, 7 national riding days.

**D Crozier** (JUST A PROMISS) – Issued with a warning after presenting JUST A PROMISS without an item of notified gear (Tongue Tie).
