RACE COMMENTS				
Race 1	NZB INSURANCE PEARL SERIES MAIDEN RACE (1200 metres)			
RISING ROYAL (T Newman) – Slow away.				

REDELLA (R Elliot) - Jumped away awkwardly.

MOVIN' ON (M Hashizume) – Raced three wide without cover throughout.

CARAMELLA (W Pinn) - Had to shift outwards passing the 350 metres to obtain clear running.

SILVERINA (M McNab) – Held up until passing the 250 metres.

ARABIA (J Kamaruddin) - Held up until passing the 200 metres.

TAKING MY TIME (L Satherley) – When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions.

Race 2 WESTBROOK CELLAR DOOR WAIMAUKU MAIDEN (1600 metres)

HEGREATHASS (M McKay) - Jumped away awkwardly.

DROVERS YARN (D Danis) - Jumped away awkwardly contacting CASPER. Raced greenly when placed under pressure in the final straight.

CASPER (E Nicholas) - Contacted leaving the barriers then being restrained to obtain cover. Inconvenienced approaching the 200 metres by DROVERS YARN which shifted outwards when racing greenly.

ZIPPILLY (R Elliot) – Slow away. Had to shift outwards passing the 200 metres to obtain clear running.

KAWEROA (C Barnes) - Commenced to over-race when being restrained approaching the 1200 metres then racing very ungenerously for the remainder of the back straight.

LUCA DELI (M McNab) - Briefly held up entering the final straight.

POZZI VIBE (A Goindasamy) - When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions.

Race 3 NZB INSURANCE PEARL SERIES RACE (1200 metres)

THIMBLE THEATRE (C Grylls) – Crowded leaving the barriers losing ground. Made the bend near the 900 metres awkwardly. When questioned regarding the performance the rider advised that the filly had failed to handle today's track conditions.

BELLA TIVACI (T Newman) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

SPIRITED CHARM (B Grylls) – Jumped away awkwardly. Inconvenienced passing the 200 metres.

SHEZ CLASS (M Hashizume) – Raced three wide without cover. Lay out rounding the final turn and in the straight.

FAIRSHARE (S Spratt) – Raced keenly when being steadied in the early stages.

MISS FIREHAWK (M McNab) – When questioned regarding the performance the rider advised that the filly had failed to handle today's track conditions.

Race 4THE SAM PEREZ MEMORIAL MAIDEN (1200 metres)ROOFTOP (C Grylls) - Slow away.

TAZIMOTO (K Hannan) – Jumped away very awkwardly losing ground.

KERIKERI (A Calder) - Improved onto heels passing the 750 metres having to be steadied.

AQUA MAN (A Lawson-Carroll) - Lay out when placed under pressure in the final straight.

STUNGUN (L Satherley) - Raced in restricted room passing the 150 metres. Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection STUNGUN was confirmed to have bled. STUNGUN shall not be ridden in exercise for a period of two months or start in any Race of Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

Race 5 EMERALD GLEN BLOODSTOCK (1400 metres)

SPEAK YOUR MIND (A Calder) - Slow away.

TUTUKAKA (L Innes) - When questioned regarding the performance the rider could offer no excuse however was of the opinion that the gelding would derive benefit from today's race having not raced since 19 February.

Race 6

AVONDALE SUNDAY MARKETS (1400 metres)

HELSINKI (A Goindasamy) - Slow away. When questioned regarding the performance the rider advised that after beginning poorly the mare had settled further back than intended and had run on fairly in the straight, adding that in his opinion HELSINKI would benefit from a step up in distance.

ROCKWITHATTITUDE (E Nicholas) - Inconvenienced passing the 200 metres.

Race 7 REMEMBERING ANZAC (1400 metres)

VERSTAPPEN (S Spratt) - Underwent a pre-race veterinary check after becoming fractious in the barriers and was declared fit to start.

THE REAL TEST (N Parmar) - Jumped away awkwardly losing ground.

RISING RANSOM (R Beemud) – Slow away.

PARISIAN (B Rogerson) – Over-raced in the early and middle stages.

BRIAN LAMONT (B Grylls) - Inconvenienced approaching the 100 metres after THE REAL TEST shifted out slightly.

ROCCIA (S McKay) - Inconvenienced entering the final straight by RISING RANSOM which was shifting out to obtain clear running. Lay in when placed under pressure in the final straight. When questioned regarding the performance the rider advised that the mare had failed to handle today's track conditions.

Race 8 GIBSON FAMILY REUNION (1200 metres)

MAGDALA (N Parmar) - Jumped away awkwardly losing ground.

OSELETA (M McNab) – Slow away.

Race 9 NZB INSURANCE PEARL SERIES MAIDEN RACE (1600 metres)

ALCYON (R Beemud) - Crowded leaving the barrier losing ground.

TANZANITE ROSE (J Kamaruddin) – Jumped away awkwardly making contact.

CALLISSIDENT (W Pinn) - Jumped away awkwardly making contact. Lay out when placed under pressure in the final straight.

JAKKALNUTS (M Hashizume) - Raced greenly in the final straight then shifted out abruptly just prior to the winning post.

W Pinn (CALLISSIDENT) - Admitted a charge in that he struck his mount CALLISSIDENT six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.
