GENERAL	
Following an inquiry into the official result of placings in Race 3 where a dead heat was declared by the Judge between AUNT CINDY (2) and ROW OF EIGHTS (9), Judge C Harrison defended a charge in that he had failed to place AUNT CINDY and ROW OF EIGHTS according to the order in which their noses had reached the winning post. After	

considering all evidence and submissions the Adjudicator found the charge to be proven with a decision on penalty being reserved. Due to this error being detected subsequent to the declaration of the Official Result of Placings, under the provisions of Rule 641(5) Official Placings are now unable to be amended.

#### RACE COMMENTS

##### Race 1 | L.J. HOOKER GROUP SPRINT MAIDEN 1200m

Trainer **P Collins** (MORRIE) - Issued with a warning after presenting MORRIE with gear that was unnotified, namely blinkers.

**JAMIESON'S TIPPLE** (C Johnson) - Trainer A Frye inadvertently declared pre-race ear plugs rather than pre-race ear covers. This information was disseminated prior to the race. Began awkwardly.

**OPIHI COMMANDER** (C Barnes) - Slow to begin.

**ARCHERFIELD** (A Balloo) - Began awkwardly shifting inwards crowding inside runners.

**CRUZING DELBOY** (T Moseley) - Crowded leaving the barriers. Was inclined to over race in the early stages getting its head up and making the first bend awkwardly.

**EASYRIDER** (K Chowdhoo) - Raced three wide without cover throughout.

**A Balloo** (ARCHERFIELD) - Admitted a charge in that he struck his mount ARCHERFIELD 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$250.

##### Race 2 | BEQUEATH FROM EST. PAT HARTNETT 1200m

There was a delay to the start of this race when **HOMBRE** proved very difficult to load and was eventually declared a late scratching on veterinary advice at 12.29 after being injured when becoming fractious during the loading process. The connections were advised that HOMBRE must now barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

Trainer **R Ayton** (GRANITE RIDGE) - Issued with a warning after presenting GRANITE RIDGE without notified gear (blinkers).

**TADITA** (C Johnson) - Shifted outwards abruptly at the start crowding outside runners.

**FIONNUALA** (K Kwo) - Crowded and buffeted at the start.

**SOPHISTICAL** (K Mudhoo) - Crowded and buffeted at the start. Raced three wide without cover in the early stages.

**LORNA DOON** (T Comignaghi) - Crowded and buffeted at the start.

**MAKE BELIEVE** (S Toolooa) - Lay out badly rounding the final bend.

**RUSSIAN FABLE** (M Taylor) - Was inclined to lay in under pressure in the straight.

**CLOONEY** (R Cuneen) - When questioned regarding performance rider advised that the gelding had not felt comfortable in today's track conditions.

##### Race 3 | NZB INSURANCE PEARL SERIES RACE MAIDEN F&M 1200m

**SISTER SARAH** (S Toolooa) - Slow to begin.

**SWISS 'N' GIGGLES** (M Taylor) - Bounded at the start losing some ground. Further hampered shortly after the start. Raced very wide into the first bend and then raced wide without cover for the remainder of the race.

**INDI NINDY** (T Jonker) - Slow to begin.

**MOVIE STAR** (J Laking) - Began awkwardly shifting outwards further hampering SWISS 'N' GIGGLES. Had to be steadied passing the 1100 metres.

**ROW OF EIGHTS** (T Comignaghi) - Crowded and had to be steadied passing the 1100 metres. Made the bend near the 900 metres awkwardly getting its head up when being steadied to avoid heels.

**B Murray** (AUNT CINDY) - Admitted a charge of careless riding in that he permitted his mount AUNT CINDY to shift inwards when not sufficiently clear of MOVIE STAR which was dictated into the line of ROW OF EIGHTS which was crowded and checked passing the 1100 metres. After considering submissions the Adjudicator imposed a suspension of B Murray's licence to ride in races from the conclusion of racing on Saturday, 7 May until the conclusion of racing on Sunday, 15 May, 6 national riding days.

Following an inquiry into the official result of placings where a dead heat was declared by the Judge between AUNT CINDY (2) and ROW OF EIGHTS (9), Judge C Harrison defended a charge in that he had failed to place AUNT CINDY and ROW OF EIGHTS according to the order in which their noses had reached the winning post. After considering all evidence and submissions the Adjudicator found the charge to be proven with a decision on penalty being reserved. Due to this error being detected subsequent to the declaration of the Official Result of Placings, under the provisions of Rule 641(5) Official Placings are now unable to be amended.

**TAKE A RISK** (T Moseley) - Slow to begin.

**DORIS DIOR** (C Campbell) - Slow to begin before being crowded shortly after the start losing further ground. Held up rounding the bend and when looking for clear running contacted GLADROY near the 375 metres and continued to be held up until passing the 325 metres.

**OUR ROSETTE** (K Chowdhooory) - Bounded at the start.

**LOVEBUG** (C Barnes) - Bounded at the start.

**CAUSE CELEBRE** (D Montes de Oca) - Raced three wide without cover in the early stages.

**POWER OF THE KITTY** (W Papier) - Improved wide rounding the final bend.

**GLADROY** (J Lowry) - Contacted passing the 375 metres. When questioned regarding performance rider advised that the gelding may have held its breath during the running but had still been disappointing.

**JIMINY CRICKET** (B May) - Slow to begin.

**OWEN PATRICK** (J Laking) - When questioned regarding performance rider advised that the gelding had felt disinterested. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**LETZ'AV BUBBLES** (C Barnes) - Late scratched at 2.40pm after bolting for a full lap of the track during the preliminary.

**BARRETT** (S Toolooa) - Slow to begin. Over raced in the early stages having to be severely restrained to avoid heels near the 1300 metres. Continued to race keenly through the middle stages.

**HEY SOUL SISTER** (C Johnson) - Crowded at the start losing ground.

**ROYCE ROCA** (C Carmine) - Raced three wide without cover for the majority of the race.

**JUSTABELLE** (L Callaway) - Raced fiercely and got its head up when being restrained to avoid heels for a distance passing the 1400 metres and continued to over race through the middle stages.

**AWATANE** (J Lowry) - When questioned regarding performance rider could offer no excuse advising that the gelding had been disappointing. Underwent a post race veterinary examination which found the gelding to have a slow rate of recovery with a high heart rate.

**Race 7 PHAR LAP 3YO 1600m**

**THE COMPOSER** (T Moseley) - Over raced in the early and middle stages getting its head up on a number of occasions. When questioned regarding performance rider advised that in its race day debut today the gelding had over raced and was then unable to finish the race off.

**DREMUS** (T Comignaghi) - Raced three wide without cover in the early and middle stages before improving forward to sit outside the leader.

**DEGREEOFINNOCENCE** (C Barnes) - Raced greenly for a short distance passing the 700 metres. Lay in over the concluding stages with the rider swapping the whip to the left hand.

**BAD FLAMINGO** (S Toolooa) - Held up early in the run home only gaining clear racing room passing the 250 metres.

**Race 8 EQUINE VETERINARY SERVICES MAIDEN 1600m**

**NELLIE GREY** (B May) - Slow to begin.

**CHOICE MOMENT** (L Callaway) - Slow to begin.

**TIRATORE** (K Chowdhooory) - Over raced badly in the early stages getting its head up on a number of occasions and making the bend near the 1400 metres awkwardly. Continued to over race through the middle stages.

**PACKING TAVI** (C Carmine) - Raced three wide without cover throughout.

**PRIMA DONNA** (C Johnson) - Raced wide throughout.

**KRYSTALSBAR** (B Murray) - Not persevered with from the 800 metres, with the rider reporting that the bit had displaced through the gelding's mouth.

**ENOUGH SAID** (J Laking) - Held up near the 300 metres and had difficulty obtaining clear running until inside the final 100 metres.

**Race 9 MCINTOSH CATERING STAYERS 2200m**

Trainer **L Stewart** (VAGUE) - Issued with a warning after presenting VAGUE without the notified pre-race ear covers.

**TOO FERLAXED** (T Moseley) - Slow to begin.

**HILLERSDEN** (C Carmine) - Slow to begin. Raced keenly for a distance passing the 1500 metres.

**EKSTREMEMISS** (G Jogoo) - Slow to begin.

**THISTLE** (C Campbell) - Began awkwardly. Raced three wide without cover for the majority of the race.

**SUPER TAP** (C Johnson) - Raced three wide without cover in the early stages.

**RED SUNDAY** (K Chowdhoo) - Had to shift ground outwards passing the 225 metres to find clear racing room.

**FAME SHINES** (D Montes de Oca) - When questioned regarding performance rider advised that the gelding had been making abnormal breathing noises. A post race veterinary examination revealed a slow recovery rate.

**CAGE PHYTA** (C Barnes) - Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection CAGE PHYTA was confirmed to have bled. CAGE PHYTA shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

**Race 10**

**NIGHT 'N DAY PARK MAIDEN 2200m**

**JAXX BE NIMBLE** (C Barnes) - Over raced through the early to middle stages, raced three wide without cover for the final 1000 metres.

**WHILE YOU'RE THERE** (K Chowdhoo) - Slow to begin then further hampered losing ground when runners to either side shifted ground.

**PRINCESS NALA** (T Jonker) - Crowded shortly after the start losing ground. Over raced in the early stages before being allowed to stride forward and sit outside the leader.

**EULOGY SHOW** (K Mudhoo) - Raced three wide without cover in the early stages.

**SHOW US PLENTY** (T Comignaghi) - Raced wide without cover through the early and middle stages.

**CHAMONIX** (C Carmine) - Raced keenly for a distance passing the 1400 metres due to the lack of tempo.

**EXTREME POWER** (J Laking) - Under pressure from the 600 metres with the rider reporting that the gelding had failed to finish the race off and had been disappointing.
