<b>GENERAL</b>
Rider O Bosson was fined \$100 under the minor infringement schedule after failing to make the weight on FLORENCENIGHTNGALE and SAVITO.
Races 3 and 4 were put back due to road works enroute to the course with Race 3 being scheduled to run at 12.31 pm and Race 4 being scheduled to run at 1.01 pm.
Following a fall in Race 3, rider T Newman was taken to hospital for observation with a suspected wrist injury and was stood down from her engagements for the remainder of the day.

<b>RACE COMMENTS</b>
<b>Race 1</b>   <b>T W MOORE MAIDEN HIGHWEIGHT (1950 metres)</b>
<b>ACAPULCO</b> (K Macnab) – Began awkwardly. Had to be steadied after improving onto heels passing the 1700 metres. Raced wide without cover for the majority of the race.
<b>RITESAIDZED</b> (S O’Malley) – Restrained from a wide barrier in the early stages to obtain cover. Improved onto heels passing the 250 metres having to be steadied.
<b>SMUG</b> (D Parker) – Commenced to over-race passing the 1700 metres.
<b>TE ATATU MEMPHIS</b> (B Donoghue) - Raced three wide without cover for the majority of the race.
<b>IZYMYDAAD</b> (S Karnicnik) – Steadied when placed in restricted room to the inside of SMUG which shifted in slightly passing the 850 metres.
<b>PACHECO</b> (C Chipperfield) - Crowded and checked passing the 1450 metres.
<b>CASHEL</b> (A Roustoby) - Crowded and checked passing the 1450 metres. Lay out onto heels having to be steadied passing the 600 metres.

**B Donoghue** (TE ATATU MEMPHIS) - Admitted a charge of careless riding after he permitted his mount TE ATATU MEMPHIS to shift inwards when not sufficiently clear of PACHECO and CASHEL which were both crowded and checked near the 1450 metres. After considering submissions the Adjudicative Committee imposed a suspension of B Donoghue's licence to ride in races from the conclusion of racing on Saturday 7 May up to and including racing on Thursday 12 May, 1 national riding day.

**C Chipperfield** (PACHECO) – Issued with a warning after using the whip in two consecutive strides near the 75 metres.

**S Karnicnik** (IZYMYDAAD) - Admitted a charge in the he struck his mount IZYMYDAAD eight times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$500.

**BULLITT** (A Roustoby) - Slow to begin.

**ZENNTARI** (D Parker) – Slow to begin.

**JABELLA** (E Farr) - Made firm contact with the running rail becoming unbalanced near the 1600 metres.

**LATE TO THE PARTY** (B Donoghue) – Improved onto heels passing the 1450 metres having to be steadied. Held up entering the final straight.

**KHAN HUNTER** (H McNeill) - Raced three wide without cover for the majority of the race.

**MANINTHESKY** (K Macnab) - Had to shift inwards entering the final straight to obtain clear running.

**S O'Malley** (ULAANBAATAR) - Spoken to for raising his arm above shoulder height when using the whip in the final straight.

**A Roustoby** (BULLITT) - Issued with a warning after he struck his mount BULLITT six times prior to the 100 metre mark with the Stewards taking into account his clear recent record with regard to any breach of a whip rule.

<b>Race 3</b>	<b>LASER ELECTRICAL ROTORUA MAIDEN 3YO (1230 metres)</b>

**FELICITY THEN** (A Calder) - Delayed the start when proving fractious in its preliminary. Slow to begin. Over-raced in the early and middle stages. Contacted and unbalanced passing the 50 metres.

**CARMENERE** (R Elliot) - Commenced to buck shortly after the start losing its chance. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**CANDYCANE** (J Fawcett) - Slow to begin.

**AGLIANICO** (L Innes) - Following the race the filly received treatment for a laceration to the right hind tendon.

**CHA DES** (M Cameron) – Held up until passing the 200 metres. Hampered by the fallen runner passing the 50 metres.

**ELUSIVE ANNIE** (T Newman) - Clipped a heel and fell passing the 50 metres, hampering CHA DES. Underwent a post-race veterinary examination which revealed a laceration inside the right nostril and minor abrasions to the left fore heel bulb and left hind hock.

**SANTENAY** (N Parmar) - Had some difficulty obtaining clear running early in the final straight before being denied clear running after attempting to improve into a marginal run passing the 50 metres having to be steadied.

**N Parmar** (SANTENAY) - Admitted a charge of careless riding in that he permitted his mount SANTENAY to shift outwards when not sufficiently clear forcing ELUSIVE ANNIE outwards striking the heel of FELICITY THEN and falling near the 50 metres. After considering submissions the Adjudicative Committee imposed a suspension of N Parmar's licence to ride in races from the conclusion of racing on Saturday 30 April up to and including racing on Saturday 28 May, 4 weeks.

**Race 4** | **HAVE YOUR FUNCTION AT ARAWA PARK MAIDEN 3YO 1230**

**SHE'S A SHOWOFF** (J Kamaruddin) – Began awkwardly losing ground.

**PEARLS A SINGER** (D Danis) - Lay out rounding the bend near the 800 metres becoming awkwardly placed on heels having to be steadied. Crowded when weakening passing the 250 metres.

**MOLL OF PENTIRE** (L Sutherland) - Steadied when placed in restricted room approaching the 400 metres.

**SAVITO** (M McNab) - Held up until shifting outwards passing the 225 metres.

**ELECTRIC TIME** (E Nicholas) – Lost the right hind plate during the running.

**E Nicholas** (ELECTRIC TIME) - Issued with a warning after permitting her mount to shift outwards when not sufficiently clear of PEARLS A SINGER which was crowded when weakening passing the 250 metres.

**Race 5** | **CAMPBELL INFRASTRUCTURE ROTORUA CUP 14<sup>TH</sup> MAY MAIDEN (1400 metres)**

**CURRENTLY** (R Elliot) - Slow away.

**BLAZING DANCER** (D Danis) - Slow away.

**THE JUNGLE KING** (L Sutherland) - Steadied shortly after the start. Raced wide throughout.

**ABLE WHITE** (L Innes) – Raced three wide without cover.

**MI AMIGO** (C Barnes) - Contacted and unbalanced near the 500 metres by EXZELLO which shifted outwards. O Bosson was advised to exercise care in similar circumstances.

**APERITIF** (T Mitchell) - Lay out rounding the final bend making contact with the hindquarters of EXZELLO which then shifted in slightly inconveniencing APERITIF entering the final straight.

**HOOTIE JOHNSON** (J Fawcett) - Steadied after improving onto heels passing the 300 metres.

**SEEUINABIT** (B Grylls) - Raced in restricted room passing the 250 metres.

**GOOD OIL** (M Cameron) - Raced in restricted room passing the 175 metres.

**Race 6** | **LANCE LAWSON MAIDEN 1400**

**THE FINNSTER** (M Cameron) - Slow away.

**JIMMY DEAN** (A Goindasamy) - Steadied when awkwardly placed near heels near the 1150 metres.

**HARD NOSE** (J Kamaruddin) - Raced wide without cover until crossing to lead near the 600 metres.

**Race 7** | **FAULKNER DRAINAGE MAIDEN 1560**

**MYLA** (A Lawson-Carroll) - Slow to begin. Improved onto heels passing the 1350 metres then shifted out placing VISTOWN in restricted room. Raced keenly through the middle stages.

**GOODO JO** (L Satherley) - Raced keenly in the early stages having to be steadied off heels near the 1300 metres. Had to shift outwards passing the 250 metres to obtain clear running.

**VISTOWN** (J Fawcett) - Steadied when placed in restricted room near the 1350 metres.

**BRIDGERTON** (M Cameron) – Held up rounding the final bend and early in the straight until passing the 250 metres. Then improved onto heels having to be steadied passing the 150 metres.

**Race 8** | **WAITOMO FUELS 1560**

**HEART OF GOLD** (L Satherley) - Slow to begin.

**DAWN JESSIE** (W Pinn) – Slow to begin. Raced wide without cover from near the 1000 metres.

**TURRET** (T Yanagida) - Slow to begin.

**FORTUNE WINGS** (A Goindasamy) – Raced wide without cover in the early stages.

**Race 9** | **NZB INSURANCE PEARL SERIES MAIDEN RACE (1400 metres)**

**FABULOUS NANCY** (A Goindasamy) - Slow away.

**ARDOUR** (M Cameron) - Restrained to obtain cover after jumping from the outside barrier. When questioned regarding the performance the rider advised that in his opinion the filly would benefit from some further easing in the ground.

**DAVONE GEORGIA** (J Kamaruddin) - Came under pressure passing the 800 metres and commenced to give ground from the 600 metres, not being persevered with in the straight. Underwent a post-race veterinary inspection which revealed the mare to have suffered cardiac arrhythmia. Trainer S Tierney was advised that DAVONE GEORGIA will not be permitted to start in any race or trial until a veterinary clearance declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

**QUEEN SARABI** (R Beemud) - Held up behind the weakening DAVONE GEORGIA near the 500 metres.

**BIT NOSY** (W Pinn) – Lay out rounding the final bend.

**ANATOLIA** (A Lawson-Carroll) - Returned to the enclosure with blood present in the nasal area. Following a veterinary examination ANATOLIA was confirmed to have bled. ANATOLIA shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of 1000 metres in the presence of a Veterinarian.

**Race 10** | **HOUSE OF ELLIOTT 1230**

**TINA AGAIN** (J Chung) – Jumped away awkwardly making contact with CLARA BELLE which was forced outwards hampering TEREINE and KOOL CHOUXZ.

**CLARA BELLE** (C Grylls) – Contacted leaving the barriers. Underwent a post-race veterinary examination which did not reveal any abnormality.

**TEREINE** (C Barnes) – Hampered leaving the barriers.

**KOOL CHOUXZ** (D Danis) – Hampered leaving the barriers.

**MAIN MAN** (J Riddell) - Slow away. Had to be steadied off heels near the 1100 metres.

**THATCHER** (T Yanagida) – Restrained in the early stages to obtain cover from a wide barrier.

**GEMMA FLITZ** (M Hashizume) - Steadied when placed in restricted room passing the 1100 metres when KEATS lay out.

**SUPERIORITY** (B Grylls) – Raced three wide without cover throughout. Crowded and checked approaching the 100 metres.

**KEATS** (M Cameron) - Rider dropped his whip near the 250 metres.

**AFTER PARTY** (W Pinn) – Inconvenienced passing the 50 metres after becoming awkwardly placed inside heels.

**L Innes** (UDERZO) - Admitted a charge of using the whip in two consecutive strides on his mount UDERZO near the 100 metres with the Adjudicative Committee imposing a fine of \$150.

**L Innes** (UDERZO) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear crowding SUPERIORITY which was checked approaching the 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of L Innes' licence to ride in races from the conclusion of racing on Saturday 30 April up to and including racing on Friday 6 May, 4 national riding days.

**Race 11**

**RYDGES HOTEL ROTORUA 1230**

**BULLNOSE** (B Grylls) - Slow to begin.

**PODIUM** (O Bosson) - Crowded shortly after the start losing ground. Lay out entering the first bend despite the efforts of its rider, running wide. Shifted out and away from SEAFOAM passing the 250 metres having to be firmly restrained after becoming awkwardly placed on heels. When questioned regarding the performance the rider advised that the filly had proved difficult to ride throughout. Underwent a post-race veterinary examination which did not reveal any abnormality. Connections advised that they would be considering adding blinkers prior to the filly racing next. Connections were advised that a warning would be placed against the filly's racing manners.

**SEAFOAM** (J Kamaruddin) - Began awkwardly losing ground. Lay out rounding the final bend then had some difficulty obtaining clear running for the majority of the final straight.

**CHAMPAGNE LOLA** (L Satherley) - Improved onto heels approaching the 400 metres having to be steadied.
