## GENERAL

Apprentice rider Y Kumagai was stood down from his two rides after failing to provide a medical clearance.

RACE COMMENTS			
Race 1	AON INSURANCE BROKERS 3YO (1600 metres)		
DOUBLE O' SEVEN (L Innes) – Began awkwardly losing ground.			

**CANADIAN GIRL** (J Kamaruddin) - Improved onto heels when the pace steadied passing the 800 metres dropping back onto ZIEGFELD which had to be firmly restrained. Again had to be steadied when improving onto the heels of DUBAI DIVA near the 600 metres. Briefly held up near the 450 metres. J Kamaruddin in the presence of the riding mentor was spoken to regarding his ride and in particular why he had shifted away from the running rail rounding the bend from the 500 metres when there was the opportunity to remain behind the favourite DUBAI DIVA which in Stewards view would have been a better option. J Kamaruddin was advised that he would be expected to show better judgement in future.

**ZIEGFELD** (C Grylls) – Firmly restrained off heels passing the 800 metres.

**POSTER BOY** (A Goindasamy) - Inconvenienced passing the 350 metres when ZIEGFELD shifted outwards. C Grylls was advised to exercise care.

**REVERBERATIONS** (M Hashizume) - Was inclined to race greenly under pressure in the straight.

**M McNab** (DUBAI DIVA) – Spoken to regarding the manner in which he had steadied the pace near the 800 metres.

## Race 2 CAMBRIDGE RACEWAY 1400

RAPOSA RAPIDA (A Calder) - Slow away.

**SAINT ALICE** (A Goindasamy) - Became unbalanced passing the 400 metres when the mare appeared to come together with NEW YORK JAZZ when both runners shifted ground slightly. With film footage being obscured to a degree, this observation was confirmed by riders following. An inspection of this area of the track did not detect any matters of concern. Crowded passing the 250 metres when NEW YORK JAZZ shifted outwards to obtain clear running, simultaneously as TIME TO CELEBRATE shifted inwards under pressure.

**TIME TO CELEBRATE** (J Riddell) - Steadied over the concluding stages when placed in restricted room to the inside of THUNDER which shifted inwards under pressure.

**THUNDER** (M Hashizume) - Had a tendency to lay in under pressure in the straight.

**DAWN PARADE** (W Pinn) - Steadied when becoming awkwardly placed near the heels of SAINT ALICE near the 350 metres. Held up when disappointed for a run approaching the 200 metres.

**T Newman** (NEW YORK JAZZ) - Issued with a warning after permitting her mount to shift outwards when not sufficiently clear of SAINT ALICE which had to be steadied approaching the 200 metres. Contributing was inward movement from TIME TO CELEBRATE.

**J Riddell** (TIME TO CELEBRATE) - Issued with a warning after permitting his mount to shift inwards when not sufficiently clear of SAINT ALICE which had to be steadied approaching the 200 metres. Contributing was outward movement from NEW YORK JAZZ.

**M** Hashizume (THUNDER) - Issued with a warning after permitting his mount to shift inwards when not sufficiently clear of TIME TO CELEBRATE which had to be steadied over the concluding stages.

### Race 3 DECISE ELECTRICAL AND CONTROL 2YO (1200 metres)

CHANNEL SURFER (J Fawcett) - Began awkwardly then hampered shortly after losing ground.

**LEICA MODEL** (A Goindasamy) – Began awkwardly making contact with ALA DI VESPA, becoming unbalanced and losing ground as a result. Made the final turn awkwardly when laying out and continued to race greenly throughout the straight.

ALA DI VESPA (A Calder) – Contacted leaving the barriers.

**THE STATESMAN** (M McNab) – Jumped away awkwardly and shifted outwards abruptly hampering CHANNEL SURFER.

**C Grylls** (COMPLICATE) – Issued with a warning after weighing in 0.5 kgs in excess of the weight at which he had weighed out.

Race 4 HUTTON CONTRACTING 2400

ALOFT (A Calder) – Began awkwardly losing ground. Steadied when improving onto heels near the 700 metres.

**BROOKBOURNE** (R Beemud) - The saddle shifted forward passing the 1300 metres placing the rider in difficulty before being retired from the race rounding the final bend.

WHAEO (L Satherley) - Raced keenly in the early stages.

**SUPER SID** (D Danis) – Made the bend near the 850 metres awkwardly inconveniencing PEECEE PUSSYCAT.

PEECEE PUSSYCAT (J Kamaruddin) – Inconvenienced near the 850 metres.

**AMANO** (M Hashizume) - Steadied near the 700 metres after improving and becoming awkwardly placed inside the heels of SUPER SID. Became awkwardly placed on the heels of SUPER SID near the 350 metres.

#### Race 5 INGLIS SALES CAMBRIDGE BREEDERS' STAKES (G3) (1200 metres)

**SASSY MERLOT** (T Yanagida) - Slow to begin. Had difficulty obtaining clear running throughout the final straight.

**ART DE TRIOMPHE** (R Elliot) – Began awkwardly losing ground.

**LA BELLA BEALS** (M McNab) – Began awkwardly losing ground. Over-raced in the middle stages. Was inclined to lay inwards under pressure in the straight.

**RAGAMUFFIN** (J Laking) - Crowded shortly after the start having to be steadied.

**BONNY LASS** (C Grylls) - Raced three wide without cover.

**COOL CHANGE** (M Hashizume) - Forced wide on the track rounding the final turn.

WAIRAU COVE (J Kamaruddin) - Held up early in the straight.

**BELDARRA** (L Innes) - Had difficulty obtaining clear running early in the straight. Inconvenienced near the 150 metres when COTE DE BEAUNE shifted outwards.

**MERCURIAL** (W Pinn) - Was unable to obtain clear running throughout the final straight going to the line untested by its rider.

**COTE DE BEAUNE** (O Bosson) - Raced in restricted room for a distance passing the 200 metres when LA BELLA BEALS lay in. When questioned regarding the performance, rider was of the opinion that the gelding may have come to the end of its preparation.

Race 6CAMBRIDGE EQUINE HOSPITAL 1200MR UNIVERSE (R Elliot) - Began awkwardly losing ground. Contacted on a number of occasions in the final straight.

HIGHBORN (J Kamaruddin) - Slow to begin.

**PACKING NOBLESSE** (W Pinn) – Raced wide without cover throughout. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**AROMATIC** (O Bosson) - Held up early in the straight then when attempting to improve to the outside of SWISS KITTY which shifted outwards under pressure, AROMATIC made slight contact with MR UNIVERSE on a number of occasions.

TABATA (M McNab) - Had some difficulty obtaining clear running until near the 150 metres.

**JE SUIS TIGER** (M Sanson) – Held up entering the final straight shifting inwards across heels to obtain clear running near the 300 metres. Raced in restricted room for a distance passing the 150 metres when attempting to improve into a tight run.

WILD WEST (M Hashizume) - Held up from the 150 metres until the concluding stages.

PRETTY ROSSA (M Cameron) - When questioned regarding performance the rider could offer no excuse.

**R Beemud** (CHALLA) - Admitted a charge in that he struck his mount CHALLA seven times prior to the 100 metre mark. After considering submissions the Adjudicative Committee suspended R Beemud's licence to ride in races from the conclusion of racing on Saturday 30 April up to and including racing on Saturday 14 May, 10 national riding days. Due to Apprentice rider R Beemud's poor record under this rule he was directed by the Stipendiary Stewards to meet with the NZTR Rider Skills Review Panel as per the provisions of Rule 343.

Race 7 TRAVIS STAKES (G2) (2000 metres)

LES CRAYERES (J Riddell) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

Race 8 MANELINE CAMBRIDGE MILE (1600 metres)

CULLINAN (W Pinn) - Slow to begin. Raced wide without cover throughout.

**JACK THE LASS** (T Yanagida) - Slow to begin. Had to shift outwards passing the 300 metres to obtain clear running. Contacted by SONOFABUTCHER just short of the finish.

NAVALHA (O Bosson) - Held up rounding the final bend and early in the straight.

**THELONGERULOOK** (J Riddell) - Had to shift inwards passing the 300 metres to obtain clear running then bumping with CATWALK GIRL which lay out with THE LONGERULOOK becoming unbalanced.

CATWALK GIRL (M McNab) - Bumped with THELONGERULOOK near the 300 metres.

**SONOFABUTCHER** (M Hashizume) – Lay out over the concluding stages making contact with JACK THE LASS just short of the finish.

**FLAT TRACK BULLY** (L Innes) - Rider reported that the gelding had felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**J Riddell** (THELONGERULOOK) - Admitted a charge in that he struck his mount THELONGERULOOK six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$500.
