Trainer W Hillis advised Stewards at 1.53 pm that Apprentice **E Leighton** was indisposed and would not be attending today's race meeting.

#### RACE COMMENTS

##### Race 1 | HR FISKEN & SONS LTD 1400

**TELLALL** (M McNab) - Re-saddled at the start with this race running approximately 3 minutes late as a result.

**MONACO** (J Fawcett) - Began awkwardly. Raced ungenerously in the early stages. Held up early in the final straight before shifting out approaching the 200 metres.

**SUMMER PASSAGE** (C Grylls) – Raced keenly when being restrained near the 1100 metres and continued to do so for a distance. When questioned regarding the performance rider C Grylls advised that the pace of the race may not have suited the gelding.

**BRANDO** (O Bosson) – Raced wide in the early stages. Received veterinary attention for a minor laceration above the right hind coronet.

**ROYAL PERFORMER** (J Riddell) – Had some difficulty obtaining clear running early in the final straight.

##### Race 2 | FRANKLIN LONG ROOFING 1600

**GLORY BOUND** (C Grylls) – Restrained to obtain cover in the early stages from its outside barrier draw. Briefly contacted 300 metres.

**HORACE** (O Bosson) – Raced keenly in the early and middle stages on a moderate pace. Shifted out to obtain clear running approaching the 300 metres making brief contact with GLORY BOUND.

**MARCHAND** (L Innes) - Lay in when placed under pressure making brief contact with TE TOKI passing the 250 metres.

**TE TOKI** (V Colgan) - Briefly contacted 250 metres.

##### Race 3 | MOUNT SHOP 1100

**RIPPED** (J Riddell) - Slow to begin. Awkwardly placed on heels for a distance passing the 400 metres. Crowded 300 metres by NAVALHA (O Bosson) which was looking to obtain clear running. O Bosson was advised to exercise care in a similar circumstance. RIPPED continued to have difficulty obtaining clear running for the remainder of the race.

**MALT TIME** (C Grylls) - Began awkwardly then taken back from its outside barrier draw.

**ADDICTED TO YOU** (A Goindasamy) – Shifted out near the 200 metres making contact with CALL ME EVIE which became briefly unbalanced. Then shifted out when struck with the whip passing the 100 metres making contact with CALL ME EVIE which became briefly unbalanced.

**CALL ME EVIE** (W Pinn) – Raced wide without cover throughout. Contacted passing the 200 metres and again near the 100 metres becoming unbalanced.

**NAVALHA** (O Bosson) - Had difficulty obtaining clear running early in the final straight shifting out approaching the 300 metres and crowding RIPPED which became awkwardly placed near heels and steadied. Improved onto heels passing the 50 metres and then steadied for the remainder of the race.

**BREEZON** (Y Kumagai) - Raced in restricted room approaching the winning post.

**Race 4** | **FRANKLIN AUCTIONS 1400**

**THREE SIXTY** (M Hashizume) - Began awkwardly losing ground. Held up 400 metres then improved onto heels approaching the 200 metres before shifting out to obtain clear running. Improved onto heels and steadied from near the 50 metres.

**ANGEL OF MY EYES** (C Burdan) – Began awkwardly.

**MANCHU** (L Innes) – Raced wide without cover.

**MACH SCHNELL** (C Grylls) - Steadied when crowded approaching the 1100 metres by MONTANA MIST which was shifting in to obtain cover. Shifted out to obtain clear running passing the 300 metres crowding GINGER TOO which was briefly steadied.

**GINGER TOO** (L Satherley) - Restrained to avoid heels 1100 metres. Steadied when crowded 300 metres when MACH SCHNELL shifted out to obtain clear running. Rider C Grylls was reprimanded and advised he must exercise greater care when shifting ground.

**GEE CEE** (M McNab) – Held up before shifting out approaching the 200 metres making contact with MINI MYSTIC which was hampered and steadied.

**MINI MYSTIC** (W Pinn) – Crowded approaching the 200 metres then steadied when hampered.

**J Fawcett** (MONTANA MIST) - Issued with a warning after permitting MONTANA MIST to shift in near the 1100 metres when insufficiently clear of MACH SCHNELL which was crowded and steadied.

**M McNab** (GEE CEE) - Admitted a breach of careless riding in that he permitted GEE CEE to shift out approaching the 200 metres when insufficiently clear of MINI MYSTIC which was hampered then steadied. After considering submissions the Adjudicative Committee suspended M McNab's licence to ride in races from the conclusion of racing on Saturday 5 February up to and including racing on Friday 11 February, 5 national riding days.

**Race 5** | **DUNSTAN FEEDS 1600**

**TANNAHILL** (C Burdan) - Began awkwardly losing ground. Hampered shortly after leaving the barriers losing ground, when crowded between WAIMOKU FALLS which had shifted in when being briefly crowded by CAROLINA REAPER which lay in despite the efforts of its rider, and MOIRAS TOWN which was crowded by CLEVERCONVERSATION which was dictated outwards slightly by PENNY JANE.

**CAMAROSA** (V Colgan) - Jumped in the air as the start was affected with rider V Colgan becoming unbalanced.

**MOIRAS TOWN** (T Thornton) - Crowded shortly after the start losing ground.

**CLEVERCONVERSATION** (L Satherley) – Steadied when crowded passing the 1300 metres by CAROLINA REAPER which shifted in. Had difficulty obtaining clear running for the majority of the final straight improving onto heels approaching the 100 metres and steadying for the remainder of the race.

**L Innes** (CAROLINA REAPER) - Admitted a breach of careless riding in that he permitted CAROLINA REAPER to shift in passing the 1300 metres when insufficiently of CLEVERCONVERSATION which was hampered. After considering submissions the Adjudicative Committee suspended L Innes' licence to ride in races from the conclusion of racing on Saturday 5 February up to and including racing on Thursday 10 February, 4 national riding days.

**Race 6** | **EAGLE TECHNOLOGY 1600**

**SAINT ALICE** (A Goindasamy) - Got its head down as the start was affected losing ground as a result.

**GONE WITH THE WIND** (T Yanagida) - Began awkwardly losing ground. Hampered 1200 metres.

**CASTLE BAY** (V Colgan) - Restrained in the early stages from its outside barrier.

**RISING DREAM** (M Hashizume) – Jumped inwards at the start making contact with PEPPERELLO.

**ON DEMAND** (C Burdan) - Crowded at the start.

**PAHI LASS** (Y Kumagai) - Raced wide without cover.

**WITHALLMYHEART** (J Riddell) - Crowded and checked approaching the 1200 metres when in restricted room to the inside of EXTORTION which was forced in by LADY MAK which had been crowded to the inside of PEPPERELLO which had shifted in. As a result, GONE WITH THE WIND which was following was also hampered

**EXTORTION** (M Cameron) – Crowded and hampered 1200 metres.

**LADY MAK** (D Danis) – Crowded and hampered 1200 metres.

**VIOLETTA** (K Asano) – Held up early in the final straight before shifting in approaching the 300 metres.

**J Fawcett** (PEPPERELLO) - Admitted a breach of careless riding in that she permitted PEPPERELLO to shift in approaching the 1200 metres when insufficiently clear of LADY MAK, EXTORTION and WITHALLMYHEART which was hampered losing ground. The Adjudicative Committee opened and adjourned the matter after being informed by the oncourse Doctor that J Fawcett was unable to attend the hearing today.

**Race 7** | **HAUNUI FARM 2100**

**SUPER GEE** (C Grylls) – Slow to begin.

**EMBER ATTACK** (V Colgan) – Restrained in the early stages from the outside barrier.

**TARWYN** (W Pinn) - Slow to begin. Raced wide when improving forward near the 1000 metres. Shifted out under pressure passing the 300 metres dictating ENRIGHT out onto SPIRIT OF BAZ which was inconvenienced when forced wider.

**THAT'S ALL FINE** (T Yanagida) – Raced wide in the early stages.

**ENRIGHT** (T Thornton) – Raced keenly in the early and middle stages.

**TIA D'OR** (M Hashizume) - Held up passing the 600 metres until early in the final straight.

**SHEZATHINKA** (J Kamaruddin) - When questioned regarding performance rider J Kamaruddin advised that the mare hung badly passing the 800 metres and failed to respond when placed under pressure in the final straight.

**WHEAO** (L Satherley) - When questioned regarding performance rider L Satherley advised that the gelding had never felt comfortable throughout. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**HIT THE ROAD JACK** (M Cameron) - Raced wide when improving forward near the 1000 metres. M Cameron was reminded of his obligation in that he must ride his mounts out to the end of the race when circumstances permit him to do so.

**O Bosson** (SPIRIT OF BAZ) – Issued with a warning after weighing in 0.6 kgs above the weight at which he weighed out.

**DIAMOND GIRL** (L Satherley) – Began awkwardly losing ground.

**WILD WEST** (M Hashizume) – Restrained in the early stages from its outside barrier.

**SELVA VERDE** (C Burdan) – Began awkwardly racing ungenerously in the early stages. Hampered 1000 metres when forced wide. Crowded and briefly steadied when weakening near the 300 metres.

**CACOFONIX** (L Innes) - Slow to begin. When questioned regarding the performance rider L Innes advised that after a poor beginning the colt had failed to recover. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**FUNTONIC** (T Yanagida) – Restrained in the early stages from a wide barrier draw.

**ROCHMIE RAY** (J Riddell) - Over-raced for a distance passing the 1200 metres. Hampered passing the 800 metres when improving onto the heels of THE REAL TEST which was shifting in when steadying. Inconvenienced when forced wider 300 metres.

**THE REAL TEST** (V Colgan) - Commenced to race fiercely shifting out to avoid heels near the 1000 metres hampering SALVA VERDE which was forced wider on the track. THE REAL TEST then continued to over-race through the middle stages improving three wide without cover from near the 700 metres.

**GIANT GEM** (N Parmar) – Shifted out to obtain clear running approaching the 300 metres inconveniencing ROCHMIE RAY which was dictated out into the line of SELVA VERDE which was steadied.

**N Parmar** (GIANT GEM) - Issued with a warning after permitting GIANT GEM to shift out passing the 300 metres dictating ROCHMIE RAY out into the line of SELVA VERDE which was steadied.

**TESTING TIMES** (B Grylls) - Slow to begin then shifted behind runners in the early stages from its outside barrier. Became awkwardly placed on heels approaching the 650 metres then raced ungenerously shifting out.

**WAITAK** (A Goindasamy) – Began awkwardly.

**REGAL WARRIOR** (J Fawcett) - Shifted outwards shortly after the start hampering WATER ECLIPSE, PATTON, and MISSY MOOLA.

**WATER ECLIPSE** (K Asano) - Badly hampered at the start.

**MISSY MOOLA** (C Burdan) - Hampered at the start.

**PATTON** (M McNab) - Hampered at the start.

**POUR THE WINE** (M Hashizume) - Raced wide without cover.

**CONTAGIOUS** (V Colgan) – Raced keenly when being steadied in the early to middle stages. Had difficulty obtaining clear running early in the final straight before improving onto heels near the 200 metres and was held up for a distance before shifting out near the 150 metres to obtain clear running making brief contact with FREIHEITEN PFEIL.

**Race 10** | **DUNSTAN RECOVERY MASH 1200**

**SNAKEYE** (N Parmar) - Began awkwardly losing ground.

**FLAT TRACK BULLY** (O Bosson) - Crowded at the start. Commenced to race fiercely passing the 600 metres when becoming awkwardly placed, then when shifting out in an attempt to avoid heels, making contact with PINS 'N' ROSES which was forced very wide on the track.

**MIDNIGHT SPECIAL** (M McNab) - Slow to begin.

**OVER THE MOON** (J Fawcett) - Raced wide without cover.

**PINS 'N' ROSES** (L Satherley) - Hampered 600 metres when forced very wide.

**DOVES BAY** (J Kamaruddin) - Hampered 1100 metres becoming unbalanced.

**NOVAK** (C Grylls) - Hampered 1100 metres becoming unbalanced.

**ALL BUSINESS** (M Hashizume) – Held up early in the straight before shifting in approaching the 250 metres.

**J Fawcett** (OVER THE MOON) - Admitted a breach of careless riding in that she permitted OVER THE MOON to shift in near the 1100 metres when insufficiently clear of DOVES BAY which was hampered when contacted shifting in and hampering NOVAK which became unbalanced. The Adjudicative Committee opened and adjourned the matter after being informed by the oncourse Doctor that J Fawcett was unable to attend the hearing today.

**Race 11** | **BELARDO @ HAUNUI FARM 1200**

**SPHERICAL** (M McNab) – Late scratched at 6.23 pm after arriving at the barrier on veterinary advice.

**TAZIMOTO** (T Thornton) - Restrained in the early stages from an outside barrier.

**DON'T LOOK ETHEL** (J Fawcett) – Began awkwardly.

**DECEPTIVE** (O Bosson) – Raced keenly in the middle stages. Became awkwardly placed near heels passing the 700 metres and when being steadied, shifted back onto MONET which was hampered.

**MONET** (D Danis) - Hampered 700 metres.

**RIVERHILL** (M Hashizume) - Became awkwardly placed on heels passing the 700 metres and was restrained.

**DRAGON'S KISS** (A Goindasamy) – Dictated out approaching the 400 metres by A LITTLE BIT BOSSY which shifted out to obtain clear running.

**SEAFOAM** (J Kamaruddin) – Raced greenly under pressure in the final straight with A LITTLE BIT BOSSY becoming awkwardly placed near that runner’s heels over the concluding stages.

**A LITTLE BIT BOSSY** (N Parmar) - Became awkwardly placed over the concluding stages and was steadied.

**MONET** (D Danis) - Was not persevered with in the final straight. When questioned regarding the performance rider D Danis could offer no tangible excuse.
