RACE COMMENTS

Race 1 | WINDSOR PARK SALE & LUNCHEON 13 MAY 1200m

EMANON (S Toolooa) - Slow to begin.

WILD ROVER (K Chowdhoo) - Slow to begin then hampered losing ground.

BUOYANT (R Mudhoo) - Raced keenly in the early and middle stages.

GOLDEN HARVEST (S Wynne) - Raced keenly in the early and middle stages.

MEARA MARY (D Montes de Oca) - Briefly held up near the 400 metres.

ANDUIN (K Williams) - Steadied near the 300 metres when EMANON (S Toolooa) shifted outwards when not fully clear. S Toolooa was advised to exercise greater care. When questioned regarding performance rider advised that ANDUIN had travelled well enough but failed to respond when placed under pressure, and was of the opinion that the gelding would derive benefit from today's race.

Race 2 | **NAUTICAL BOAT INSURANCE 1200m**

DRAKE BAY (T Moseley) - Began awkwardly losing ground. Over raced in the early and middle stages. Steadied and shifted outwards across heels passing the 600 metres, again having to briefly steady when becoming awkwardly placed near the heels of JUSTANACE near the 400 metres.

LORNA DOON (T Newman) - Slow to begin.

JUSTANACE (K Chowdhoo) - Restrained behind runners to obtain cover shortly after the start.

MAXIE TAP (K Kwo) - Restrained behind runners to obtain cover shortly after the start.

HE'S READY (S Wynne) - Ducked outwards abruptly just short of the finish. When questioned regarding performance rider advised that the gelding had not felt entirely comfortable in today's track conditions.

TRIPLE HEART (B May) – Trainer P Harris reported that the mare had lost both hind plates during the running.

Race 3 | **ANGUS MEATS GREAT AUTUMN HANDICAP 2500m**

BENEFICIAL (T Comignaghi) - Raced keenly in the early and middle stages.

LETSBRINGITON (G Jogoo) - Had some difficulty obtaining clear running until inside the final 200 metres

KILOWATT (K Mudhoo) - When questioned regarding performance rider advised that in his opinion the combination of the gelding's top weight and a liking for more rain affected conditions had been factors today. A post race veterinary inspection did not reveal any obvious abnormality.

SUMMER FESTIVAL (C Barnes) - When questioned regarding performance rider was unable to offer any excuse. A post race veterinary inspection did not reveal any obvious abnormality.

Race 4 | **MONTREUX FURNITURE RATING 1600m**

LADY CALYPSO (K Chowdhoo) - Began awkwardly losing ground. Raced in restricted room near the 400 metres before being hampered near the 300 metres when SAVVY BOY was taken in by NOBLE KNIGHT.

EL BEE JACK (C Carmine) - Crowded shortly after the start losing ground.

LADY MODENA (R Mudhoo) - Jumped away awkwardly. Raced keenly in the early and middle stages when being restrained. Inconvenienced near the 150 metres.

FINAL SAVINGS (K Mudhoo) - Slow to begin losing several lengths. Raced ungenerously getting its head up on a number of occasions in the early stages after improving onto heels.

VARDON ROAD (B Murray) - Restrained behind runners to obtain cover shortly after the start.

HEY SOUL SISTER (C Johnson) - Crowded and checked passing the 1400 metres.

SWEET LILLY (S Muniandy) - Raced three wide without cover throughout.

YAMUNA (C Barnes) - Held up entering the final straight and did not obtain clear running until near the 150 metres.

DECISIVE (T Moseley) - Had some difficulty obtaining clear running early in the straight. When questioned regarding performance rider was unable to offer any excuse.

LORD DARCI (J Laking) - Shifted inwards under pressure approaching the 150 metres inconveniencing LADY MODENA.

CHANDLER (L Callaway) - Lay in under pressure having to be corrected by its rider near the 150 metres.

SAVVY BOY (T Comignaghi) - When questioned regarding performance rider was unable to offer any excuse and advised that she has recommended to connections the application of blinkers.

J Lowry (NOBLE KNIGHT) - Admitted a charge of careless riding in that he permitted NOBLE KNIGHT to shift inwards when not sufficiently clear dictating LORD DARCI inwards onto YAMUNA resulting in HEY SOUL SISTER being crowded and checked near the 1400 metres. After considering submissions the Adjudicative Committee imposed a suspension of J Lowry's licence to ride in races from the conclusion of racing on Wednesday 11 May until the conclusion of racing on Thursday 19 May, 6 national riding days.

TAPILDOODLEDO (K Kwo) - Slow to begin.

DEFIANT (R Mudhoo) - Slow to begin. Held up rounding the final turn and in the straight until near the 300 metres.

SEVEN ELEVEN (T Newman) - Slow to begin.

MOOLOOLABA (K Mudhoo) - Shifted away from the heels of TURF WAR contacting KIKIMORA passing the 1000 metres.

KIKIMORA (K Chowdhoo) - Over raced in the early and middle stages. Contacted passing the 1000 metres. Held up rounding the final turn continuing to have difficulty obtaining clear running until near the 250 metres.

JACK BE QUICK (G Jogoo) - Connections were advised that the gelding was under a barrier manners warning after being reluctant to load.

PRENDIDO (L Callaway) - Began awkwardly losing ground. Made the crossing near the 1900 metres awkwardly after improving into restricted room. Was inclined to over race in the early and middle stages.

PRINCESS NALA (T Jonker) - Slow to begin.

DRUMSTORM (S Toolooa) - Restrained behind runners to obtain cover shortly after the start.

JACK BE QUICK (G Jogoo) - Improved quickly onto heels when over racing near the 1800 metres.

OCEANS AWAY (T Newman) - Briefly inconvenienced when CHEEKINI (D Montes de Oca) shifted outwards near the 400 metres. D Montes de Oca was advised to exercise greater care. T Newman reported that the gelding had hung throughout after losing the cheek burr.

AMAZON GODDESS (A Balloo) - When questioned regarding today's improved performance, trainer K Moore advised that the mare had been suited by today's improved track conditions in combination with settling well during the running with the blinkers having been removed today.

DAY LIGHT (S O'Malley) - When questioned regarding performance rider advised that the mare would be better suited to rain affected footing. A post race veterinary inspection did not reveal any obvious abnormality.

S Toolooa (DRUMSTORM) - Admitted a charge in that he used his whip on DRUMSTORM when the gelding was out of contention. After considering submissions the Adjudicative Committee imposed a fine of \$250.

Race 7 | **DAPHNE BANNAN MEMORIAL GREAT EASTER STAKES 1400m**

LIVE DRAMA (K Chowdhoo) - Began awkwardly losing ground. Shifted outwards under pressure in the straight.

HARBOURSIDE (K Williams) - Over raced in the early and middle stages.

BEAU STITCH (B May) - Over raced in the middle stages before improving forward to sit outside the leader passing the 900 metres. Trainer P Harris reported that the gelding had struck itself during the running and would now be sent for a spell.

STREET FIGHTIN MAN (C Johnson) - Inconvenienced near the 250 metres when LIVE DRAMA (K Chowdhoo) shifted outwards under pressure. K Chowdhoo was advised to exercise greater care.

Race 8 | **RACECOURSE HOTEL & MOTOR LODGE 1800m**

The start was delayed after ATHENE and KAARERAWAY had arrived behind the barriers wearing the wrong saddle cloth numbers necessitating both runners having to be re-saddled.

T Rae (ATHENE & KAARERAWAY) - Admitted a charge of neglect in saddling after her two runners were presented with incorrect saddlecloth numbers. After considering submissions the Adjudicative Committee imposed a fine of \$150.

ITS ALL OVER ROVER (T Moseley) - Slow to begin. Improved onto heels having to be steadied and racing ungenerously near the 1400 metres. Lay inwards under pressure in the straight.

AQUATTACK (S Wynne) - Slow to begin. Held up early in straight shifting outwards across heels to obtain clear running near the 350 metres.

RAINMAN (G Jogoo) - Slow to begin. Hampered near the 400 metres. Lay in under pressure in the straight inconveniencing CAPO DELL IMPERO near the 100 metres.

DA VINCI GIRL (T Newman) - Slow to begin. Raced wide without cover throughout.

ARE YOU CEREAL (W Papier) – Over raced in the middle stages having to be heavily restrained when improving onto the heels of SPLENDIOR approaching the 1200 metres then shifting outwards becoming awkwardly placed for a distance before being steadied passing the 1000 metres. W Papier was shown footage in the presence of the Apprentice Mentor and spoken to advisedly. Crowded near the 350 metres. Trainer J Burrows will be spoken to regarding the right hind bandage coming loose and detaching rounding the final turn.

ITSONLYMONEY (T Comignaghi) - Raced three wide without cover.

CAPO DELL IMPERO (J Lowry) – Contacted and forced outwards near the 350 metres. Inconvenienced near the 100 metres.

KAARERAWAY (L Allpress) – Contacted on several occasions rounding the final turn. Crowded and checked near the 350 metres.

J Lowry (CAPO DELL IMPERO) - Issued with a warning after making contact with KAAARERAWAY on several occasions when attempting to obtain clear running rounding the final turn.

W Papier (ARE YOU CEREAL) – Issued with a warning after permitting ARE YOU CEREAL to shift outwards hampering RAINMAN near the 400 metres.

S Wynne AQUATTACK – Defended a charge of careless riding in that she permitted AQUATTACK to shift outwards when not sufficiently clear of CAPO DELL IMPERO which was forced outwards onto KAAARERAWAY which was crowded and checked near the 350 metres. After considering evidence and submissions the Adjudicative Committee found the charge to be proven imposing a suspension of S Wynne’s licence to ride in races from the conclusion of racing on Sunday 15 May until the conclusion of racing on Thursday 26 May, 6 national riding days.
