RACE COMMENTS**Race 1** | **SVS STARTING GATES 2100**

RISING STORM (M Hashizume) - Slow to begin.

MOTUMAN (S Weatherley) - Improved forward from near the 1300 metres when the pace eased to sit outside the leader approaching the 900 metres.

TARWYN (R Elliot) – Held up rounding the final bend and early in the straight before having to shift outwards passing the 250 metres to obtain clear running.

Race 2 | **LEGACY LODGE 1200**

PETRACHOR (M McNab) - Dropped its head as the start was affected with the jockey becoming unbalanced, losing ground as a result.

SCOTCH (A Goindasamy) - Began awkwardly. Held up rounding the final bend.

ROC CHA (R Beemud) - Began awkwardly. Raced wide without cover throughout. Improved onto the heels of JE SUIS TIGER which shifted outwards passing the 200 metres having to be steadied. M Hashizume was advised to exercise care.

CLEVER RUDS (L Satherley) - Raced keenly in the early stages.

BARI (J Riddell) - Steadied when placed in restricted room passing the 900 metres to the outside of CLEVER RUDS which shifted out slightly when racing keenly. When questioned regarding the performance rider J Riddell advised that the gelding had found the impost of 61½ kgs had a negative bearing on the performance.

JE SUIS TIGER (M Hashizume) - Lay out when placed under pressure in the final straight. Underwent a post-race veterinary examination which found the mare to be suffering from thumps.

Race 3 | **PLATINUM HOMES 2YO CLASSIC (1200 metres) (G3)**

PATTON (M McNab) - Began awkwardly then crowded shortly after having to be steadied. Raced keenly in the early stages.

DELOREAN (S Weatherley) - Crowded at the start losing ground. Raced keenly in the early and middle stages. Made the bend near the 900 metres awkwardly.

VILLON (L Innes) - Raced wide without cover throughout. Raced keenly in the early and middle stages. Raced greenly when placed in restricted room to the inside of VAL DI ZOLDO and outside of GWEN STEPHANI which shifted out slightly passing the 400 metres.

ZAHER (M Cameron) - Had to be steadied passing the 400 metres when placed in restricted room.

VAL DI ZOLDO (C Grylls) – Lost the right front plate during the running.

O Bosson (MAVEN BELLE) - Issued with a warning for permitting his mount to shift outwards when not sufficiently clear of ZAHER which had to be steadied when placed in restricted room passing the 400 metres.

<p>ORLEANS BELLE (S Weatherley) - Crowded at the start clipping a heel and blundering shortly after.</p> <p>GOLDEN HUE (R Beemud) - Began awkwardly. Raced wide without cover throughout.</p> <p>MYRTLE CREEK (M McNab) - Slow to begin.</p> <p>SWEY MY WAY (J Kamaruddin) - Slow to begin.</p> <p>ANGE DE REVE (N Parmar) - Raced wide without cover. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.</p> <p>OVER THE MOON (S Spratt) - Held up for a distance passing the 300 metres.</p> <p>COOL CHANGE (A Goindasamy) – Improved onto heels passing the 150 metres having to shift outwards.</p> <p>LEONAROAR (M Cameron) - When questioned regarding the performance the rider advised that the filly had raced greenly throughout and had been unsuited by today’s track conditions.</p>	
Race 5	PETER KELLY – BAYLEYS REAL ESTATE 1300
<p>ELUSIVE EMPIRE (T Thornton) - Began awkwardly losing ground. Restrained passing the 1000 metres when in restricted room to the inside of GIANT GEM.</p> <p>GO YOU GOOD THING (M Sanson) - Began awkwardly.</p> <p>HIGHLIGHTER (Y Kumagai) - Steadied off the heels of MISS CARTIER which shifted in when not fully clear passing the 950 metres. M McNab was advised to exercise care. Shifted inward abruptly passing the 300 metres.</p> <p>TIFFEN (C Grylls) - Held up early in the final straight before attempting to improve into a marginal run approaching the 300 metres when inside of HIGHLIGHTER which then shifted inwards abruptly resulting in TIFFEN having to be firmly restrained. Also hampered as a result was VERSTAPPEN.</p> <p>VERSTAPPEN (V Colgan) - Hampered passing the 300 metres. When questioned regarding the performance rider V Colgan advised that the filly had never travelled comfortably. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.</p> <p>GIANT GEM (J Kamaruddin) – Improved onto heels over the concluding stages having to be steadied.</p> <p>J Kamaruddin (GIANT GEM) - Issued with a warning after permitting GIANT GEM to shift in near the 1000 metres when insufficiently clear of ELUSIVE EMPIRE which was crowded and steadied.</p> <p>Y Kumagai (HIGHLIGHTER) - Issued with a warning after permitting his mount to shift inwards when not sufficiently clear of TIFFEN which had to be steadied after attempting to improve into a marginal run approaching the 300 metres. Also hampered as a result was VERSTAPPEN. When assessing the incident Stewards took into account the racing manners of HIGHLIGHTER which had shifted inwards abruptly when struck with the whip.</p>	
Race 6	DAVID & KARYN ELLIS FILLIES CLASSIC (2000 metres) (G2)
<p>CANADIAN GIRL (J Kamaruddin) - Began awkwardly.</p>	

MUSTANG VALLEY (V Colgan) - Crowded shortly after the start. Had to be steadied after improving onto heels passing the 1400 metres when the pace steadied.

BIGIFF (A Goindasamy) - Had to be checked to avoid heels passing the 1800 metres. Had to be steadied after improving onto heels passing the 1400 metres when the pace steadied.

PRINCESS LOWRY (L Satherley) - Raced keenly when being restrained in the early to middle stages. Was eased down by its rider from near the 500 metres. Underwent a post-race veterinary inspection which found the filly to be 3/5 lame in the right foreleg. Connections were advised that a veterinary clearance would be required prior to racing next.

BELLE EN ROUGE (O Bosson) – Held up for a distance approaching the 400 metres. When questioned regarding the performance rider O Bosson advised that after being in a comfortable position early in the race he had then been shuffled back in a slowly run race and had failed to recover.

SELF OBSESSION (M McNab) - Came together with GLORY BOUND passing the 350 metres when SELF OBSESSION shifted in slightly.

GLORY BOUND (C Grylls) - Contacted passing the 350 metres. Shifted in and away from SELF OBSESSION passing the 50 metres. Following the race co-trainer S Autridge viewed Stewards footage before electing not to proceed with a protest.

C Grylls (GLORY BOUND) - Admitted a charge of careless riding in that he permitted his mount to shift in near the 1800 metres when not clear of BIGIFF which was checked. After considering submissions the Adjudicative Committee suspended C Grylls' licence to ride in races from the conclusion of racing on Saturday 19 February up to and including racing on Wednesday 2 March, 6 national riding days and in addition imposed a fine of \$400.

Race 7 | **HERBIE DYKE STAKES (2000 metres) (G1)**

THE CHOSEN ONE (M Cameron) - Underwent a pre-race veterinary examination after arriving on course when an abrasion was found to the left knee and was declared fit to start. Raced wide without cover throughout.

ROYAL PERFORMER (J Riddell) - After becoming fractious in the barrier underwent a pre-race veterinary examination and was declared fit to start.

COVENTINA BAY (C Grylls) - Restrained at the start from a wide barrier.

THE MAYOR (V Colgan) - Became awkwardly placed on the heels of JOE'S LEGACY passing the 1800 metres and was then placed in restricted room by SOUND which shifted in. L Innes was advised to exercise care.

HARLECH (M McNab) - Held up for a distance approaching the 400 metres.

D Turner (LLANACORD) - Admitted a charge in that he struck his mount LLANACORD six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee suspended D Turner's licence to ride in races from the conclusion of racing on Saturday 12 February up to and including racing on Friday 25 February, 7 national riding days and in addition imposed a fine of \$200.

Race 8 | **WAIKATO STUD 1400**

FOUR QUEENS (L Innes) - Slow to begin. Held up passing the 400 metres.

BLUE MOON (S Weatherley) - Slow to begin.

KEATS (M Cameron) - Raced keenly in the early stages.	
Race 9	BCD GROUP SPRINT (1400 metres) (G1)
GINO SEVERINI (M McNab) - Slow to begin then crowded shortly after.	
MARKUS AURELIUS (S Weatherley) - Slow to begin.	
MONACO (T Thornton) – Raced wide without cover throughout.	
SHOWOROSSES (V Colgan) - Contacted and unbalanced passing the 400 metres.	
ENTRIVIERE (O Bosson) - Held up rounding the final bend before shifting outwards passing the 400 metres making contact with SHOWOROSSES which was unbalanced. O Bosson was advised to exercise care.	
Race 10	PAK 'N SAVE CLARENCE ST MILE (1600 metres)
LE VILLI (M McNab) - Slow to begin.	
SUPERETTE (C Grylls) - Began awkwardly.	
ELUSIVE CAPITAL (N Parmar) – Began awkwardly then crowded shortly after. Held up until near the 350 metres.	
SOPHIA'S MAGIC (V Colgan) - Had to be steadied after improving onto heels near the 700 metres.	
J Riddell (HONG KONG) - Admitted a charge in that he struck his mount HONG KONG six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$500.
