RACE COMMENTS

Race 1 FIONA STUART MEMORIAL MAIDEN 1600m

ACQUITTAL (W Pinn) - Contacted at the start.

KOPUTAROA (G Jogoo) - Contacted at the start.

**IDEAL WARRIOR** (S Toolooa) - Hampered shortly after the start when inside runners shifted out. Travelled three wide without cover throughout.

**CHAVELA** (K Chowdhoory) - Hampered and dictated wider at the start losing ground.

**POSER** (B Murray) - Slow to begin. When asked to comment on the performance, rider advised that the mare had been disappointing and may not have handled today's track conditions.

**LISTENLIKETHIEVES** (J Laking) - Slow to begin.

**MR GHIBSON** (T Comignaghi) - Held up approaching the 600 metres having to be angled out across heels to obtain clear running passing the 300 metres.

**S Toolooa** (IDEAL WARRIOR) - Stewards enquired into the manner in which rider S Toolooa used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.

**W Pinn** (ACQUITTAL) - Admitted a charge in that he struck his mount ACQUITTAL 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of W Pinn's licence to ride in races from the conclusion of racing on 12 February until the conclusion of racing on 23 February, 5 national riding days.

The track was downgraded to Slow 9 retrospective to this race.

#### Race 2 ALISTAIR GRAY MEMORIAL MAIDEN 1400m

The start was delayed approximately 3½ minutes due to several runners proving difficult to load.

**SANTIAGO MISS** (L Callaway) - Buffeted at the start losing ground. When asked to comment on the performance of this favoured runner, rider advised that after losing ground at the start he found it hard to make ground in today's track conditions.

JUSTA LAD (A Balloo) - Slow to begin becoming awkwardly placed on heels losing ground.

**BENTLEY** (J Laking) - Blundered at the start with the rider losing the use of his inside iron for a short distance losing ground. Placed in restricted room shortly after the start.

**TAIMATE DIVA** (T Comignaghi) - Crowded and checked shortly after the start. Held up entering the final straight and was unable to obtain clear running with the filly going to the line not fully tested.

**SWEET LILLY** (R Mudhoo) – When over racing had to be severely restrained to avoid the heels of NOBLE KNIGHT and shifted outwards abruptly inconveniencing SERAPHIC passing the 1100 metres. Obliged to race three wide without cover from the 1100 metres.

**SERAPHIC** (K Chowdhoory) - Inconvenienced 1100 metres.

**SWISS 'N' GIGGLES** (B Murray) - Lost the near side winker approaching the 400 metres.

STAN WITH ME (B Grylls) - Rider reported that the gelding had battled on fairly in today's testing track conditions.

**J Lowry** (NOBLE KNIGHT) - Admitted a charge of careless riding in that he permitted NOBLE KNIGHT to shift inwards when not sufficiently clear of BENTLEY which was dictated inwards onto TAIMATE DIVA which was crowded and checked shortly after the start. After considering submissions the Adjudicator imposed a suspension of J Lowry's licence to ride in races from the conclusion of racing on 19 February until the conclusion of racing on 25 February, 4 national riding days.

## Race 3 NZB INSURANCE PEARL SERIES RACE 1000m

**KIKIMORA** (K Chowdhoory) - Began awkwardly losing ground. Over raced in the early and middle stages. Rider dropped his whip approaching the 300 metres.

**DELPHILLIUS** (C Barnes) - Began awkwardly then over raced in the early stages.

## Race 4 MICK AND MELBA MURFITT MEMORIAL 1100m

**VINO BELLA** (T Moseley) - Began awkwardly. Held up entering the final straight and unable to find clear running until approaching the 150 metres.

**LIGHT UP** (R Mudhoo) - Began awkwardly losing ground.

**CAN'T SAY ENOUGH** (G Jogoo) - Raced keenly in the early stages. Made brief contact with BEAU STITCH passing the 900 metres unbalancing rider G Jogoo for a short distance.

BEAU STITCH (C Barnes) - Contacted 900 metres.

**CHOKITO** (T Comignaghi) - Lay out under pressure over the concluding stages.

Following this race the track was downgraded to Heavy 10.

### Race 5 RANGIORA EQUINE SERVICES MAIDEN 1200m

The start was delayed approximately 5 minutes due mainly to THE CATS PYJAMAS proving difficult to load as well as other runners being difficult.

**THE CATS PYJAMAS** (D Bothamley) - The connections were advised that the gelding was under a barrier manners warning after proving very difficult to load. Held up approaching the 400 metres and unable to obtain clear running until passing the 250 metres.

HOMBRE (J Lowry) - Began awkwardly.

SATELLITE (A Balloo) - Slow to begin.

CATS IN THE CRADLE (B Murray) - Began awkwardly then crowded losing ground.

LIGHTNING RIDGE (K Mudhoo) - Began awkwardly.

**SPORT MODE** (C Johnson) - Crowded shortly after the start losing ground.

AREYOUOKAY (B Grylls) - Raced keenly in the early and middle stages.

DUBAI LADY (K Williams) - Rider reported that the mare had not handled today's heavy track conditions.

**J Lowry** (HOMBRE) - Admitted a charge in that he struck his mount HOMBRE 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$500.

Following this race Stewards met with a delegation of senior jockeys following concerns about visibility as a result of rain and the high humidity levels fogging up goggles. After discussion jockeys confirmed their willingness to continue with the day's programme subject to the situation being monitored race by race.

### Race 6 RICCARTON PARK GOLF COMPLEX 1200m

MOREIRA (T Moseley) - Crowded shortly after the start losing ground when runners to either side shifted ground.

FINAL SAVINGS (J Laking) - Slow to begin.

**VENTURESOME** (K Mudhoo) - Began awkwardly briefly unbalancing the rider.

FETTERCAIRN (D Bothamley) - Slow to begin.

**THE BUFFER** (B Grylls) - Raced ungenerously through the early and middle stages. Briefly placed in restricted room passing the 900 metres when PAPAGENA lay inwards.

**O'JESSICA** (C Johnson) - Raced keenly through the early to middle stages becoming awkwardly placed on heels having to be steadied when PAPAGENA (S Toolooa) shifted in when not clear passing the 900 metres. S Toolooa was advised to exercise greater care.

## Race 7 ODT SOUTHERN MILE QUALIFIER 1600m

**DECISIVE** (W Pinn) - Began awkwardly. When asked to comment on performance, rider advised that the mare had not handled today's heavy track conditions.

**HUNTER VILLAIN** (J Lowry) - Slow to begin.

VARDON ROAD (B Murray) - Slow to begin.

SECOND THOUGHT (K Mudhoo) - Began awkwardly losing ground.

**HOLY LOCH** (S Toolooa) - Crowded shortly after the start losing ground. Raced three wide without cover throughout. Over raced getting its head up and as a result shifted out passing the 1400 metres.

**CHEEKINI** (T Comignaghi) - Over raced in the early stages.

**SWEET FIELDS** (R Mudhoo) - Had to be steadied to avoid the heels of HEE'S OUR SECRET (T Moseley) passing the 1400 metres. T Moseley was advised to exercise greater care.

## Race 8 C S STEVENS MEMORIAL BANKS PENINSULA CUP 1800m

**WILLIAM WALLACE** (B Murray) - Slow to begin. Rider could offer no tangible excuse for the disappointing performance.

**CAMINO ROCOSO** (J Laking) - Restrained to obtain cover shortly after the start.

**C Barnes** (WANNABE 'N' PARIS) - Admitted a charge of failing to ride her mount WANNABE 'N' PARIS out fully to the end of the race when there was a chance of her running fourth. After considering submissions the Adjudicator

imposed a suspension of C Barnes' licence to ride in races from the conclusion of racing on 19 February until the conclusion of racing on 2 March, 6 national riding days.

## Race 9 RURAL LIVESTOCK 1400m

LARPOWER (K Kwo) - Began awkwardly losing ground. Rider advised that the saddle had moved during the running.

GOODANYA (C Barnes) - Slow to begin.

EL BEE DARCI (K Mudhoo) - Raced keenly in the early and middle stages.

**SPLENDIOR** (C Campbell) - Raced three wide without cover for the majority of the race.

ST ANDRE (W Pinn) - Lay in in the run home with the rider swapping the whip to his left hand passing the 200 metres.

**TREYBON** (J Laking) - Rider reported that the gelding had not handled today's track conditions.

FEELIN' FANCY (K Chowdhoory) - Rider reported that the gelding had not handled today's track conditions.

#### Race 10 TIM DYER – BAYLEYS CANTERBURY 2000m

**DA VINCI GIRL** (K Chowdhoory) - Began awkwardly losing ground.

YAMUNA (B Murray) - Slow to begin.

MISS TAVI (B Grylls) - Held up rounding the final bend and early in the run home.

**LARIPPA** (C Campbell) - Lay in throughout the run home having to be continually straightened. Rider reported that the mare had lay in throughout the running.
