<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>MATAMATA FUNCTION CENTRE MAIDEN 1600</b>
<p><b>REDELLA</b> (A Lawson-Carroll) - Began awkwardly losing ground.</p> <p><b>AMATERASU</b> (J Kamaruddin) - Slow to begin. When questioned regarding the performance the rider advised that the mare failed to handle today's track conditions.</p> <p><b>EKSTATIQUE</b> (T Yanagida) – Slow to begin. Held up entering the final straight then lay in near the 250 metres having to be straightened by its rider.</p> <p><b>QUEEN SARABI</b> (S Spratt) – Restrained from its wide barrier at the start.</p> <p><b>OUTRIVAL</b> (A Goindasamy) - Raced wide without cover throughout. Forced outwards slightly passing the 350 metres.</p> <p><b>CALLISSIDENT</b> (C Grylls) - Held up early in the straight.</p> <p><b>AVONDALAY</b> (M McNab) - Steadied when placed in restricted room passing the 1300 metres to the inside of THE BIG SHOW which shifted inwards when not clear. Forced outwards slightly passing the 350 metres. Y Kumagai was advised to exercise care in similar circumstances.</p> <p><b>PRAETORIAN</b> (M Hashizume) - Shifted outwards passing the 350 metres forcing OUTRIVAL outwards onto AVONDALAY and THE BIG SHOW.</p> <p><b>THE BIG SHOW</b> (Y Kumagai) - Forced outwards slightly passing the 350 metres.</p>	
<b>Race 2</b>	<b>FAIRVIEW MOTORS MATAMATA MAIDEN 1600</b>
<p><b>ESPIONAGE</b> (J Kamaruddin) - Began awkwardly making contact with LOFTYS GIFT, losing ground. Raced keenly in the early stages. When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p> <p><b>LOFTYS GIFT</b> (E Nicholas) - Contacted at the start.</p> <p><b>KANTRA</b> (D Prastiyou) – Crowded shortly after the start.</p> <p><b>DROVERS YARN</b> (D Danis) - Began awkwardly. Steadied when placed in restricted room just prior to the winning post.</p> <p><b>SENROR UNO</b> (W Pinn) - Raced keenly in the early stages.</p> <p><b>MILLIONDOLLAR BABY</b> (C Barnes) - Raced wide without cover throughout.</p> <p><b>W Pinn</b> (SENROR UNO) - Issued with a warning for making a celebratory gesture prior to the winning post.</p>	
<b>Race 3</b>	<b>NZB INSURANCE PEARL SERIES MAIDEN RACE 1200</b>
<p><b>TO BE FAIR</b> (J Chung) - Blundered on jumping away losing ground as a result.</p> <p><b>KICHEKO SANA</b> (A Calder) - Slow to begin. Raced keenly in the early stages when being restrained.</p>	

**SHE'S A SHOWOFF** (K Asano) - Contacted and forced wider at the start. Over-raced in the early and middle stages. Raced wide without cover throughout. Underwent a post-race veterinary examination which found the filly to have a delayed recovery.

**MOVIN' ON** (M Hashizume) - Raced wide without cover throughout.

**DAME COUNTY** (R Elliot) - Shifted outwards entering the final straight making contact with SILVERINA when attempting to improve into a marginal run. Then had to be steadied passing the 150 metres when TARGHEE shifted out slightly.

**IFYOURAMPLE** (L Allpress) - Had difficulty obtaining clear running early in the final straight. Steadied when placed in restricted room passing the 500 metres. When questioned the rider advised that the filly had hung throughout with her unable to fully ride the filly out.

**SILVERINA** (M McNab) - Contacted on a number of occasions approaching the 200 metres.

**EPIPHANY** (W Pinn) - Hung outwards when placed under pressure rounding the bend and in the final straight with the rider being unable to fully ride the filly out. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**Race 4** | **MATAMATA VETERINARY SERVICES MAIDEN 1200**

**LEEDOX** (R Elliot) - Reared at the start losing ground.

**THIMBLE THEATRE** (C Grylls) – Began awkwardly making contact with VENT VERT, losing ground. Over-raced in the early and middle stages when being restrained. Inconvenienced passing the 800 metres.

**ALA DI VESPA** (M Hashizume) - Crowded at the start. Had some difficulty obtaining clear running early in the final straight.

**FAIRSHARE** (A Goindasamy) - Began awkwardly.

**UNTETHERED** (C Barnes) – Over-raced in the early stages. Made the bend near the 800 metres awkwardly running wide inconveniencing the trailing THIMBLE THEATRE.

**MALBOROUGH BAY** (L Allpress) – Raced wide without cover throughout.

**MATTER OF HONOUR** (M McNab) - Rider M McNab advised that the gelding had proved difficult to ride throughout, over-racing in the early and middle stages.

**MEDINA** (M Cameron) - Held up for a distance approaching the 350 metres before shifting outwards to obtain clear running, inconveniencing **HARDCORE HENRY**.

**HARDCORE HENRY** (J Riddell) – Inconvenienced passing the 350 metres. Received post-race veterinary attention to the right hind leg.

**Race 5** | **MBS ADVISORS MAIDEN 1200**

**WHO'S SAM** (W Pinn) - Late scratched on veterinary advice at 12.58 pm after becoming fractious in its barrier.

**BENEFICENT** (A Calder) - Slow to begin. Held up rounding the final bend and early in the final straight.

**LEX REX** (M McNab) – Raced keenly in the early stages when being restrained.

**ASPERITAS** (L Allpress) - Raced wide without cover throughout.

**OSO SHOCKING** (L Satherley) - Had to be steadied when placed in restricted room approaching the 1000 metres.

**READY TO DRINK** (C Grylls) – Held up until passing the 200 metres.

**APACHE BOY** (K Asano) – Held up for a distance passing the 400 metres.

**L Te Keeti** (MISS CAPRICORN) – Issued with a Minor infringement Notice and fined \$50 after presenting MISS CAPRICORN to race without notified gear (shadow roll).

**D Fleming** (OSO SHOCKING) - Issued with a warning after presenting OSO SHOCKING to race without notified gear (ear covers).

<b>Race 6</b>	<b>PGG WRIGHTSON 1400</b>

**I'M NOT BOSSY** (C Grylls) - Slow to begin.

**SHE'S APPLES** (C Lindsay) - Slow to begin. Held up rounding the final bend.

**NEIGHBOURHOOD** (M McNab) – Crowded shortly after the start. Over-raced in the early stages before having to be steadied passing the 1000 metres to avoid heels. Had some difficulty obtaining clear running early in the final straight.

**KIRRA LAD** (A Calder) - Slow to begin. Over-raced before shifting out abruptly to avoid heels approaching the 1000 metres.

**A BOX OF TRICKS** (T Thornton) - Raced keenly when being restrained in the early stages. Held up early in the final straight then shifted out approaching the 150 metres to obtain clear running inconveniencing RIDGEVIEW CHIEF.

**RIDGEVIEW CHIEF** (J Fawcett) – Raced wide without cover throughout.

**CASINO PRINCESS** (E Nicholas) - Held up until passing the 200 metres.

**AURORA DOLCE** (M Hashizume) - Held up until passing the 100 metres.

**PARISIAN** (B Rogerson) - Dislodged its rider on pulling up who was uninjured. Stewards excused apprentice B Rogerson from weighing in under Rule 647(1).

<b>Race 7</b>	<b>STABLE BOOKS 1400</b>

**ROCKSPELL** (T Yanagida) - Began awkwardly losing ground. When questioned regarding the performance the rider advised that the gelding had got back further than intended and had failed to make up ground.

**MADAME MOET** (M McNab) - Began awkwardly losing ground. When questioned regarding the performance the rider advised that the mare got further back than intended after beginning poorly and in his opinion may be feeling the effects of recent racing. Underwent a post-race veterinary inspection which found the mare to be in season.

**HUGH GLASS** (A Lawson-Carroll) - Slow to begin.

**HAPPY EGO** (A Goindasamy) - Began awkwardly. When questioned regarding the performance the rider advised that the gelding held its breath during the running.

**THE FIRST LINK** (J Fawcett) - Crowded shortly after the start losing ground.

**BELLA DORA** (W Pinn) - Had to be steadied when placed in restricted room to the outside of **ROCKWITHATTITUDE** passing the 350 metres.

**GEMMA FLITZ** (M Hashizume) - Rider M Hashizume reported the mare had hung badly and was unable to be ridden out fully in the straight.

**ROCKWITHATTITUDE** (L Satherley) – Inconvenienced passing the 300 metres when awkwardly placed on the heels of **EDGE OF WONDER** which shifted out when not fully clear.

**L Satherley** (**ROCKWITHATTITUDE**) - Issued with a warning after permitting her mount to shift outwards when not sufficiently clear of **BELLA DORA** which had to be steadied when placed in restricted room passing the 350 metres.

**R Elliot** (**EDGE OF WONDER**) – Issued with a warning after permitting his mount to shift out when not sufficiently clear inconveniencing **ROCKWITHATTITUDE** near the 300 metres.

<b>Race 8</b>	<b>MATAMATA TRACTORS &amp; MACHINERY MAIDEN 1200</b>

**PRISMATIC** (L Allpress) - Slow to begin.

**JUST A TIPPLE** (A Goindasamy) – Began awkwardly. Raced greenly throughout.

**CARMENERE** (C Grylls) - Raced wide without cover throughout.

**SERENA'S SPIRIT** (S Spratt) - Raced keenly in the early stages.

**GIMMEALLYOURLOVIN'** (M Cameron) - Raced keenly in the early stages when being restrained.

**GWEN'S DAUGHTER** (M Alam) - Held up for clear running room until passing the 200 metres.

**SHOW A MILLION** (E Nicholas) - When questioned regarding the performance the rider advised that the gelding had failed to gain the lead which had been detrimental to its chances.

<b>Race 9</b>	<b>SLATTERY CONTRACTING LTD 1200</b>

**SILVERDALE CHIEF** (M McNab) - Resaddled at the start which resulted in this race running approximately 3 minutes late. The rider dropped his whip passing the 50 metres.

**ROC CHA** (B Rogerson) - Began awkwardly losing ground. Raced keenly in the early stages when being restrained.

**TWO MADISON** (Y Kumagai) - Contacted at the start losing ground.

**MR UNIVERSE** (R Elliot) - Raced wide without cover throughout.

**PACKING NOBLESSE** (M Cameron) - Stewards questioned rider M Cameron regarding the riding tactics adopted. M Cameron explained that after being instructed to ride the gelding in a forward position he had attempted to encourage the gelding to travel comfortably through the middle stages, however when placed under pressure **PACKING NOBLESSE** had failed to respond. Connections advised that they would be considering the racing future of the gelding.

<b>Race 10</b>	<b>PEARSON 2000</b>

**LEITRIM LAD** (S Spratt) - Slow to begin.

**QUALITY SEEKER** (T Mitchell) – Crowded shortly after the start.

**INDEEM** (A Lawson-Carroll) - Raced keenly in the early stages when being restrained.

**PLUSHENKO** (J Chung) - Steadied when placed in restricted room near the 1900 metres.

**SHOCKING PENNY** (M Sanson) – Steadied when awkwardly placed passing the 1600 metres. Raced wide without cover until passing the 1300 metres.

**OSTASIO** (C Jones) - Raced wide in the early stages until obtaining cover passing the 1300 metres. Underwent a pre-race veterinary inspection and was declared fit to start.

**PEPPERELLO** (T Thornton) - Raced wide without cover for the majority of the race.

**THE MIGHTY SPAR** (J Kamaruddin) - Improved onto the heels of the weakening TAIKA passing the 550 metres having to shift outwards abruptly hampering CHARMINGAFFAIR.

**CHARMINGAFFAIR** (D Danis) - Hampered passing the 550 metres.

**TAIKA** (Y Kumagai) - Commenced to give ground passing the 600 metres. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

<b>Race 11</b>	<b>J SWAP CONTRACTORS LTD MAIDEN 2000</b>

**THE DASH** (M Sanson) - Began awkwardly losing ground.

**MEANDEEL** (J Fawcett) - Restrained at the start from its wide barrier. Raced greenly when placed under pressure in the final straight.

**GALLIVANTER** (C Grylls) – Commenced to race ungenerously for a distance when being restrained passing the winning post on the first occasion.

**RUHIA** (W Pinn) - Raced keenly in the early stages then raced wide without cover from near the 800 metres.

**THEGREATHASS** (R Elliot) - Raced wide without cover throughout. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

**CLEAT** (K Asano) - Had to shift inwards passing the 300 metres to obtain clear running.
