**RACE COMMENTS** 

Race 1 WAIROA STAR/WAIROA CLUB MAIDEN 2200

**OVERAGAIN** (J Riddell) - Restrained to obtain cover in the early stages after jumping from a wide barrier. When questioned regarding performance rider had no excuse.

BAYARMAA (J Parkes) - Inclined to over-race in the early stages.

**REET PETITE** (K Asano) - Over-raced in the middle stages, being allowed to improve forward outside the leader near the 800 metres.

**MONKEY BUSINESS** (R Hannam) - When questioned regarding performance, rider advised the gelding was today having its first run over a middle distance and would benefit from the experience.

#### Race 2 K9 PETFOODS MILE MAIDEN 1600

KALUANUI (M McNab) - Slow away.

**FIERCE FLIGHT** (S Weatherley) - Restrained to obtain cover after jumping from the outside barrier. Inclined to lay in under pressure in the final straight.

**ROCABURY** (J Riddell) - Inclined to over-race in the early to middle stages.

WEOWNA TIGER (K Hercock) - Lay out rounding the turn.

## Race 3 NELSON GOODLEY MEMORIAL MILE 1600

PRIORESS (K Asano) - Crowded shortly after the start.

LOVE LETTER (S Weatherley) - Taken back to obtain cover after jumping from the outside barrier.

**ONE DREAM ONE SOU**L (A Mudhoo) - Raced three wide without cover. Lay in over the final stages and had to be straightened near the finish.

**HOROPITO** (J Parkes) - Had to be steadied when placed in restricted room to the inside of ASK PA (L Allpress) rounding the bend near the 1400 metres. L Allpress was advised to exercise greater care. HOROPITO was then inclined to over-race for a distance.

**SAILOR JERRY** (J Kamaruddin) - Over-raced when being restrained approaching the 1200 metres. Bumped early in the home straight.

**NOSSENKO** (M McNab) - Held up early in the home straight and when being angled out bumped with SAILOR JERRY. M McNab was advised to exercise greater care.

ASK PA (L Allpress) - Held up for some distance in the home straight gaining clear running passing the 200 metres.

L Allpress (ASK PA) - Reminded of her obligation to ride her mount out fully to the finish when circumstances permit.

## Race 4 KIWI TRANSPORT LTD MAIDEN 3YO 1400

**ELETTRICA** (S Weatherley) - Jumped away awkwardly.

RIP WHEELER (K Hercock) - Checked 1100 metres. Shifted in over the final stages and had to be straightened.

**ELETTRICA** (S Weatherley) and **EXTRAORDINAIRE** (S Macnab) came together and bumped several times in the home straight when both runners shifted ground. S Weatherley, the rider of ELETTRICA viewed footage but elected not to proceed with an objection against the  $2^{nd}$  place EXTRAORDINAIRE.

**L Hemi** (HYDRO CHARM) - Admitted a charge of careless riding in that she permitted her mount HYDRO CHARM to shift inwards when not sufficiently clear of RIP WHEELER, which was checked near the 1100 metres. After considering

submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Wednesday, 2 March, until the conclusion of racing on Wednesday, 9 March, 4 national riding days.

Track downgraded to Dead 6 following Race 4.

# Race 5 BROKERWEB RISK SERVICE (HB) MAIDEN 1400

SILVIEMOSA (R Lazet) - Raced three wide without cover.

Track further downgraded to Slow 9 following Race 5 after a heavy downpour.

### Race 6 WAIROA BUSINESS SUPPORTERS MAIDEN 1200

**PAY WAVE** (L Hemi) - Very slow to begin. Trainer F Pratt was advised the gelding must barrier trial to the satisfaction of Stipendiary Stewards prior to racing next.

BEE STING (F Lazet) - Jumped away awkwardly hampering PINS 'N' ROSES and SHAKEOUT.

PINS 'N' ROSES (C O'Beirne) - Hampered leaving the barriers, losing ground.

**SHAKEOUT** (M McNab) - Hampered leaving the barriers, losing ground.

FLAT TRACK BULLY (S Weatherley) - Slow away. Raced greenly under pressure in the home straight.

### Race 7 BAY FORD SPRINT 1200

**TEREINE** (K Asano) - Jumped in the air at the start.

### Race 8 AFFCO NZ LTD WAIROA CUP 2100

**L Hemi** (MOTIVATION) - Admitted a charge in that she struck her mount MOTIVATION 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$500.

**S McKay** (SAGUNTO) - Admitted a charge in that he struck his mount SAGUNTO 7 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a suspension of his licence to ride in races from the conclusion of racing on Wednesday, 2 March until the conclusion of racing on Friday, 11 March, 6 national riding days.

#### Race 9 WAIROA EXPATS AND SUPPORTERS 2100

PRINCESS ANI (J Parkes) - Over-raced in the early stages.

**ROSE DIVA** (J Kamaruddin) - Raced keenly early.
