## RACE COMMENTS

Race 1 **CAMPBELL INFRASTRUCTURE 3YO MAIDEN 1400**

**EKSTATIQUE** (C Barnes) – Began awkwardly losing ground. Had to shift outwards to avoid heels near the 750 metres forcing COMPOSURE wider and again ducked outwards near the 650 metres hampering COMPOSURE. Lay in near the 500 metres and clipped a heel losing ground. Raced greenly when placed under pressure in the final straight.

**ON THE PROWL** (T Newman) – Slow to begin after being fractious in the barrier stall. Rider reported that the filly was showing signs of being in season pre-race.

**RHEINBERG** (R Elliot) - Held up until near the 200 metres. Lost the left front plate during the running.

**MISTER ZIPPY** (N Parmar) – Raced keenly for a distance approaching the 1100 metres when awkwardly placed near heels.

**HASSTOBEFAST** (M McNab) - Raced three wide without cover from near the 1000 metres.

**EAU DE VIE** (J Kamaruddin) – Shifted out when racing keenly passing the 800 metres hampering CHANCELLOR. Returned to the enclosure with blood present in both nostrils. Following a veterinary inspection EAU DE VIE was confirmed to have bled. EAU DE VIE shall not be ridden in exercise for a period of two months or start in any Race or Trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

**CHANCELLOR** (T Yanagida) – Hampered passing the 800 metres.

**COMPOSURE** (C Burdan) – Forced wider passing the 750 metres then hampered near the 650 metres.

**ICE COLD GOLD** (R Elliot) – Began awkwardly losing ground. Raced wide throughout when racing greenly.

**RUDYARD** (M McNab) – Began awkwardly then crowded losing ground.

**MARVELOUZ** (S Weatherley) - Crowded at the start losing ground.

**ROYALZ** (J Kamaruddin) – Crowded having to be checked approaching the 1000 metres.

**WATER ECLIPSE** (B Grylls) – Crowded having to be checked approaching the 1000 metres.

**MINI MOET** (K Asano) – Crowded having to be steadied approaching the 1000 metres.

**ARROWETTE** (L Innes) – Steadied when placed in restricted room approaching the 1000 metres.

**RELIABLY INFORMED** (S Spratt) – Raced three wide without cover throughout.

**S Spratt** (RELIABLY INFORMED) – Admitted a charge of careless riding in that she allowed her mount to shift RELIABLY INFORMED to shift in near the 1000 metres when not sufficiently clear of ARROWETTE and MINI MOET who were crowded onto ROYALZ and WATER ECLIPSE who were checked. After considering submissions the Adjudicative Committee suspended S Spratt’s licence to ride in races from the conclusion of racing on Thursday 10 March up to and including racing on Saturday 19 March, 6 national riding days.

**HUGS** (T Thornton) - Slow to begin.

**ALPINO** (T Yanagida) – Raced three wide without cover throughout. Placed in restricted room passing the 300 metres.

**O'LUCY** (S Spratt) - Lay out when placed under pressure from near the 600 metres then shifted out and away from TIDAL RUSH passing the 300 metres. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

**Race 4** | **ATKINSON AND DONALDSON PLUMBERS MAIDEN 1215**

**BLOOD DIAMOND** (V Colgan) - Reared as the start was affected losing ground. Improved onto heels approaching the 100 metres having to be steadied.

**ELUSIVE FIGHTER** (A Mudhoo) - Began awkwardly losing ground. Raced three wide without cover throughout. Contacted and unbalanced rounding the final bend.

**CADA CAMINO** (L Satherley) – Raced ungenerously in the early stages then had to be restrained off heels approaching the 700 metres.

**PRAETORIAN** (J Fawcett) – Lay out rounding the final bend making contact with ELUSIVE FIGHTER which was unbalanced. Lay out approaching the 100 metres with BLOOD DIAMOND improving onto its heels having to be steadied.

**SHOW COURAGE** (C Burdan) - Rider dropped her whip jumping out of the barriers.

**POP CULTURE** (N Parmar) - Held up rounding the final bend then had to be steadied when placed in restricted room approaching the 100 metres.

**A Calder** (ROW OF EIGHTS) - When questioned the rider advised that after beginning fairly the mare had to work to obtain a position outside the leader racing down the back straight. Entering the first bend he elected to take a hold to obtain cover behind LOUISIANA MAN who was continuing to work forward however once placed amongst runners ROW OF EIGHTS had been reluctant to maintain its position.

**Race 5** | **TW MOORE MAIDEN 1560**

**OCEAN CRUIZER** (T Thornton) - Slow to begin.

**ROCABURY** (J Riddell) - Began awkwardly making contact then crowded shortly after and hampered, losing ground.

**SO GRACEFUL** (S Spratt) – Raced ungenerously in the early stages when being steadied.

**JUSTUANDME** (B Grylls) - Raced ungenerously in the early stages when being steadied.

**N Parmar** (ENDEAN MAGIC) - Issued with a warning for his whip use on a runner out of contention.

**Race 6** | **LASER ELECTRICAL ROTORUA MADIEN 1560**

**DELECTABLE** (S Spratt) - Slow to begin.

**LUDISIA** (J Kamaruddin) - Slow to begin.

**TURNMEON** (L Satherley) - Steadied when placed in restricted room shortly after the start, losing ground. Crowded and hampered passing the 1500 metres losing ground. Footage of this incident proved inconclusive. Raced wide without cover for the majority of the race. Underwent a post-race veterinary inspection including an endoscopic examination which revealed mucous in the trachea.

**MAENAD** (A Goindasamy) - Improved onto heels passing the 300 metres having to be steadied.

**JABELLA** (J Fawcett) – Had difficulty obtaining clear running early in the final straight.

**Race 7** | **ISCL 1215**

**ELUSIVE EMPIRE** (A Mudhoo) - Began awkwardly then restrained to obtain cover from a wide barrier.

**HIGHLIGHTER** (S Weatherley) - Reared as the start was affected losing ground.

**LIVE FOR YOUR LOVE** (A Goindasamy) - Raced keenly in the middle stages. Held up until near the 250 metres.

**ORLEANS BELLE** (J Fawcett) – Held up rounding the final bend and early in the straight.

**MINI MINER** (C Burdan) - Steadied when placed in restricted room near the 300 metres.

**Race 8** | **LANCE LAWSON MAIDEN 1400**

**POSTER BOY** (A Goindasamy) - Slow to begin then crowded by GOODO JO losing ground. Made the bend awkwardly near the 900 metres, running wide losing ground.

**GOODO JO** (D Danis) – Began awkwardly shifting out.

**KEEP IT LOOSE** (K Asano) - Raced wide without cover for the majority of the race.

**Race 9** | **WAITOMO FUELS 1950**

**GINGER TOO** (J Fawcett) – Began awkwardly losing ground.

**IFFRAAJINATOR** (M Sanson) - Began awkwardly with the rider becoming unbalanced. Held up rounding the final bend.

**SHOCKALLIA** (J Riddell) - Steadied from a wide barrier.

**KIRRA LAD** (T Newman) - Raced keenly when being restrained in the early stages.

**SAILOR JERRY** (W Pinn) - Raced wide without cover until improving forward to lead near the 1000 metres.

**VIRGINIA REEL** (M Cameron) – Held up until passing the 200 metres then raced in restricted room for a distance approaching the 100 metres.

**Race 10** | **SWEENEY TOWNSEND INSURANCE BROKERS MAIDEN 1950**

**KEEP IT CASUAL** (A Goindasamy) - Began awkwardly losing ground.

**DAWNTING** (N Parmar) - Very slow to begin (10L). Connections were advised that a warning would be placed against the gelding's barrier manners. Trainer J Trumper advised that the gelding is likely to be retired from racing.

**REET PETITE** (B Grylls) – Crowded shortly after leaving the barriers losing ground.

**YELLOW JERSEY** (W Pinn) - Commenced to buck shortly after leaving the barriers and continued to do so for some distance and was then retired from the race. Connections were advised that YELLOW JERSEY would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**ELUSIVE CAPITAL** (A Mudhoo) – Raced wide without cover. Had difficulty obtaining clear running for the majority of the race.

**DIVINE SAVA** (M McNab) - Over-raced in the middle stages.

**RACONTEUSE** (T Newman) - Rider reported that the filly had hung throughout.

**T Thornton** (SMUG) - Was spoken to and reminded of her obligations after weighing in 0.3 kgs under the handicapped weight.
