**Race 8 GRANGEWILLIAM STUD "DERRYN" OAKS PRELUDE (1600 metres) (Listed Race)**

**EVA CHIARA** (L Innes) – Trainer S Marsh advised Stewards EVA CHIARA has jarred up and will now be sent for a spell.

**Race 10 FRANKLIN PRIVATE HOSPITAL GALLOP MAIDEN (1600 metres)**

**POLLY POWER** (T Newman) – Trainer T Mitchell reported to Stewards POLLY POWER underwent a veterinary examination on Friday 25 February which revealed the mare to be showing signs of jarring up. T Mitchell further advised POLLY POWER has been participating in light trackwork and may nominate the mare for the next Auckland Thoroughbred Racing meeting on Saturday 12 March and will step POLLY POWER up in distance.

**Matamata Racing Club – Saturday, 26 February 2022**

**Race 1 GAVELHOUSE.COM 1600**

**GONE WITH THE WIND** (L Innes) - Co-trainer A Scott advised Stewards after undergoing a post-race endoscopic examination which showed mucus in the mare's trachea, GONE WITH THE WIND has now been placed on a course of antibiotics. A Scott further advised the mare has been participating in light track work and will look to make a race day return in the next three weeks.

**RACE COMMENTS**

**Race 1** | **CARLTON EVENTS 1600**

**MARMELLOS** (N Parmar) - Reared at the start losing ground.

**WITHALLMYHEART** (J Riddell) – Restrained from its wide barrier at the start.

**EL BANDOLERO** (M Hashizume) - Restrained from its wide barrier at the start. Had to steady and shift ground to obtain clear running near the 200 metres.

**GO YOU GOOD THING** (J Fawcett) - Began awkwardly.

**EL COOLIO** (T Thornton) - Attempted to buck for a short distance after the start. A warning will be placed against the gelding's racing manners.

**SELVA VERDE** (T Newman) - Over-raced in the early stages.

**ROCCIA** (V Colgan) - When questioned regarding performance the rider was unable to offer any excuse other than the mare possibly having not backed up. Underwent a post-race veterinarian inspection which did not reveal any obvious abnormality.

**K Asano** (OHCEEDEE) - Admitted a charge in that he struck his mount OHCEEDEE six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

**Race 2** | **RACE IN AUSTRALIA WITH GO RACING NATHANS MEMORIAL (2200 metres)**

**BEAUDZ WELL** (L Satherley) – Crowded leaving the barriers. Hampered passing the 200 metres.

**HURRY CANE** (S Macnab) - Slow to begin.

**STARRYBEEL** (M McNab) – Commenced to over-race when being restrained shortly after the start.

**CAMINO ROCOSO** (J Parkes) - Raced wide without cover throughout.

**SUPER SID** (D Danis) - When attempting to improve into a marginal run made contact with SPIRIT OF BAZ near the 350 metres. Checked when crowded just short of the finish.

**SPIRIT OF BAZ** (M Cameron) – Contacted near the 350 metres. Crowded just short of the finish.

**TE AKAU CALIBURN** (N Parmar) - Held up when disappointed for a run near the 200 metres then shifting outwards across heels to obtain clear running hampering BEAUDZ WELL.

**MASETTO** (S Weatherley) - Placed in restricted room when weakening rounding the final turn near the 450 metres. Rider S Weatherley reported that the gelding had felt indifferent in its action throughout. Underwent a post-race veterinary inspection which found the gelding had lost the left front plate causing an abraded sole.

**N Parmar** (TE AKAU CALIBURN) – Issued with a warning after angling his mount TE AKAU CALIBURN outwards passing the 200 metres when not fully clear of BEAUDZ WELL.

**J Kamaruddin** (LINCOLN KING) - Admitted a charge of careless riding in that he permitted LINCOLN KING to shift outwards over the concluding stages crowding SUPER SID which was checked and forced onto SPIRIT OF BAZ just short of the finish. After considering submissions the Adjudicative Committee suspended J Kamaruddin's licence to ride in races from the conclusion of racing on Sunday 13 March up to and including racing on Saturday 26 March, 7 national riding days.

**Race 3** | **BROKERWEB RISK SERVICES 1500**

**TANNAHILL** (C Burdan) - Restrained at the start from its wide barrier.

**PRISE DE FER** (N Parmar) - Slow to begin.

**ROYAL PERFORMER** (J Riddell) - Restrained at the start from its wide barrier.

**PERFECT SCENARIO** (M Hashizume) - Unbalanced shortly after the start when making contact with THE BUZZ.

**TELLALL** (K Asano) - Got its head up when being steadied and shifted outwards near the 1100 metres then raced wide without cover for the remainder of the race.

**MARRONI** (R Elliot) - Steadied off the heels of IRISH GIRL near the 1200 metres then racing in restricted room for a distance to the inside of AOTEA LAD before having to be steadied. After questioning riders and viewing films it was established that after a poor beginning PRISE DE FER had improved into restricted room between AOTEA LAD and RED HUSSAR with RED HUSSAR then laying in away from THE BUZZ and having to be steadied. Underwent a post-race veterinary inspection which found the gelding to be suffering 1/5 lameness due to a musculoskeletal injury to the left hind leg.

**RED HUSSAR** (V Colgan) - Steadied near the 1100 metres.

**AOTEA LAD** (J Kamaruddin) – Had to shift ground to obtain clear running passing the 200 metres.

**Race 4** | **STELLA ARTOIS MUFHASA STAKES (Listed Race) (1400 metres)**

**FOLLOW YOUR DREAMS** (S Spratt) - Raced fiercely in the early stages and shifted outwards to avoid heels forcing I WISH I WIN and BONNY LASS wider on the track approaching the 1000 metres. Continued to over-race into the middle stages. Contacted near the 350 metres. Steadied when placed in restricted room to the inside of I WISH I WIN approaching the 200 metres.

**I WISH I WIN** (M McNab) - Hampered and forced wider near the 1000 metres. Was inclined to lay inwards under pressure in the straight.

**BONNY LASS** (A Goindasamy) - Hampered and forced wider near the 1000 metres. Made contact with FOLLOW YOUR DREAMS when shifting outwards to obtain clear running near the 350 metres.

**BELDARRA** (L Innes) - Commenced to race ungenerously when being restrained passing the 1200 metres.

**SASSY MERLOT** (M Cameron) - Gave ground quickly near the 250 metres and was not persevered with over the concluding stages, finishing a distant last. When questioned regarding performance rider was of the opinion that the filly may be feeling the effects of recent racing and travelling. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

**M McNab** (I WISH I WIN) - Issued with a warning after permitting his mount I WISH I WIN to shift inwards approaching the 200 metres.

**Race 5** | **GRAEME THOMSON ANTIQUE & ESTATE JEWELLERY 1600**

**FUNTONIC** (T Yanagida) - Slow to begin. Held up rounding the final turn and early in the final straight.

**THE ACTRESS** (B Grylls) - Restrained from its wide barrier at the start.

**STRINGLINE** (M Hashizume) - Restrained from its wide barrier at the start.

**THUNDER** (N Parmar) - Raced wide without cover throughout.

**KEATS** (A Goindasamy) – Raced keenly when being restrained in the early stages.

**DIAMOND GIRL** (L Satherley) - Commenced to race keenly passing the 1000 metres.

**MAKTOUM** (J Riddell) – Disappointed for a run passing the 200 metres having to steady and shift outwards across heels to obtain clear running near the 100 metres.

**IMAGE OF YOU** (J Kamaruddin) - When questioned regarding performance rider advised that the mare had travelled comfortably but had failed to quicken in today's track conditions and may prefer more give in the ground.

**Race 6** | **MCKEE FAMILY SUNLINE VASE (G3) (2100 metres)**

**INVINCIBEEL** (K Asano) - Began awkwardly. Commenced to over-race when being restrained passing the winning post on the first occasion.

**LE VILLI** (L Allpress) – Restrained from its wide barrier at the start.

**BELLE EN ROUGE** (J Kamaruddin) – Improved onto the heels of MISS ELLA and blundered near the 1600 metres. Rider dropped his whip near the 200 metres.

**MISS ELLA** (M McNab) – Forced over extra ground rounding the final turn.

**MUSTANG VALLEY** (V Colgan) - Raced three wide without cover rounding the first bend before improving forward to lead near the 1400 metres. Lay out rounding the final turn, running wide entering the final straight forcing MISS ELLA over extra ground.

**BELLATRIX BLACK** (T Yanagida) – Held up near the 400 metres having to shift ground inwards to obtain clear running.

**THATSALLSHEWROTE** (M Hashizume) - Rider reported that the filly had felt to pull up sore. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

**J Kamaruddin** (BELLE EN ROUGE) - Reminded of his obligation to ride his mounts out fully to the finish when circumstances permit.

**Race 7** | **VERTICAL LOGISTICS 1200**

**NAVALHA** (J Parkes) - Slow to begin. When questioned regarding performance rider advised that after beginning slowly the gelding had felt reluctant to race amongst runners.

**LIGHTNING FIELD** (J Kamaruddin) - Slow to begin.

**JOHNY JOHNY** (L Satherley) - Lay out under pressure in the straight.

**TIGHTLIGN** (C Burdan) - Rider dropped her whip near the 300 metres.

**Race 8** | **HAUNUI FARM KING'S PLATE (G3) (1200 metres)**

**MONACO** (T Thornton) - Restrained from its wide barrier at the start.

**MEGA BOURBON** (V Colgan) - Got its head up when being steadied near the 1000 metres.

**MANRICO** (T Newman) - Steadied to avoid the heels of TEVERE which shifted outwards for clear racing room approaching the 300 metres. Rider reported that the gelding had been making abnormal breathing noises. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

**BABYLON BERLIN** (K Asano) - Lay out under pressure over the final 250 metres.

**Race 9** | **VODAFONE NZ DERBY (G1) (2400 metres)**

**REGAL LION** (M Cameron) – Slow to begin. Received post-race veterinary attention for a minor wound to the right hind pastern.

**YES WE KHAN** (A Calder) - Slow to begin.

**ASTERIX** (J Parkes) – Restrained at the start from its wide barrier.

**LA CRIQUE** (V Colgan) - Steadied passing the 1400 metres when the pace eased and again steadied passing the 1100 metres going back onto PINARELLO resulting in PRIVILEGED SON being hampered and checked. Held up rounding the final turn before obtaining clear running near the 300 metres.

**SOLDIER BOY** (K Hercock) - Raced wide until improving to lead passing the 1400 metres.

**PINARELLO** (J Riddell) - Steadied to avoid the heels of LA CRIQUE passing the 1100 metres.

**PRIVILEGED SON** (K Asano) - Checked to avoid the heels of PINARELLO passing the 1100 metres.

**MARCHAND** (L Innes) - When questioned regarding performance rider advised that the gelding had felt indifferent in its action. Underwent a post-race veterinary inspection including an endoscopic examination which did not reveal any obvious abnormality.

**L Innes** (MARCHAND) - Admitted a charge of careless riding in that he directed his mount MARCHAND outwards when not sufficiently clear making contact with PINARELLO for a distance forcing that runner and ASTERIX over extra ground passing the 800 metres. After considering submissions the Adjudicative Committee suspended L Innes' licence to ride in races from the conclusion of racing on Sunday 13 March up to and including racing on Sunday 27 March, 8 national riding days.

**Race 10**

**BARFOOT & THOMPSON 1400**

**ZEITAKU** (R Elliot) - Slow to begin.

**SIDE EYE** (D Danis) - Improved onto heels having to be steadied passing the 1000 metres.

**BUTTERFIELD** (K Hercock) – Raced wide without cover.
