PEPPERMINT LIL (J Kamaruddin) - Raced in restricted room soon after the start. Raced keenly in the early stages when being restrained. Underwent a post-race veterinary examination which did not reveal any abnormality.	
CABALLO NOIR (A Lawson-Carroll) - Made the crossing awkwardly.	
UHTRED (M Sanson) - Raced keenly in the early and middle stages. Held up making the final turn and early in the final straight.	
TE ATATU MEMPHIS (T Yanagida) - Held up approaching the 200 metres.

MAGIC CANNON (T Moki) – Crowded soon after leaving the barrier and steadied.	
TOMMYRA (R Cole) – Raced in restricted room soon after leaving the barrier and steadied.	
ZEDMAN (N Downs) – Restrained to avoid the heels of VIRGINIA REEL passing the 1800 metres.	
TAHUROA HEIGHT (L Douglas) – Lay out rounding the final bend.	
VIRGINIA REEL (M Roustoby) - Raced in restricted room to the outside of TAHUROA HEIGHT approaching the 400 metres.	
MISS TWINKLETOES (E Farr) - When questioned regarding the performance the rider reported that the mare had felt indifferent. Underwent a post-race veterinary examination which did not reveal any abnormality.	
T Moki (MAGIC CANNON & IMA WONDER) - Admitted a charge in that she failed to make the contracted weight on her mounts MAGIC CANNON (R3) and IMA WONDER (R4). After considering submissions the Adjudicator suspended T	

Moki's licence to ride in races from the conclusion of racing on Wednesday 25 May up to and including racing on Friday 17 June, 3 days and in addition imposed a fine of \$300.

T Moki (MAGIC CANNON) - Issued with a warning after she weighed in 0.7 kgs over the weight that she weighed out at.

H McNeill (DELEGATE) - Issued with a warning after he struck his mount six times prior to the 100 metre mark with Stewards taking into account his clear recent record with regard to any breach of a whip rule.

M Cropp (FLYINGWITHOUTWINGS) - Admitted a charge in that he struck his mount six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$250.

M Roustoby (VIRGINIA REEL) - Issued with a warning after permitting VIRGINIA REEL to shift in passing the 1800 metres when insufficiently clear of ZEDMAN which had to be restrained to avoid that runner's heels.

WINEXPRESS (S Weatherley) – Held up for clear running before shifting out passing the 300 metres when improving into a marginal run making contact with HIGHLY HI.

RAVEN (K Asano) - Rider dropped his whip near the 400 metres.

TIMELESS (C Jones) – Lay in under pressure in the straight.

MAGICAL ROAD (T Newman) - When questioned regarding the performance the rider could offer no excuse.

KIWI SHARK (C Barnes) – Performed below market expectations. When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormalities.

S Marsh (KENTUCKY ROSE) - Issued with a warning for presenting his runner without the notified gear (pre-race muffs).

M Brosnan (GRACE 'N' GLORY) - Trainer M Brosnan admitted a charge in that he omitted a towel when saddling GRACE 'N' GLORY. As a result, L Satherley weighed in 0.4 kgs underweight with the Adjudicator imposing a fine of \$150.

Had difficulty obtaining clear running until approaching the 100 metres.</p> <p>KICHEKO SANA (A Calder) - Crowded approaching the 1100 metres between BUBALINA which shifted in, and NEVER EASY which had lay out. As a result, KICHEKO SANA was hampered losing ground.</p> <p>M Sanson (BUBALINA) - Issued with a warning for permitting BUBALINA to shift in approaching the 1100 metres crowding KICHEKO SANA which was hampered losing ground. When assessing the incident Stewards took into account outward movement from NEVER EASY.</p> <p>J Riddell (CAMELLA) - Admitted a charge in that he struck his mount six times prior to the 100 metre mark. After considering submissions, the Adjudicator suspended J Riddell’s licence to ride in races from the conclusion of racing on Saturday 4 June up to and including racing on Monday 6 June, 2 national riding days and in addition imposed a fine of \$500.</p>

Briefly hampered approaching the 800 metres.</p> <p>ZOULANDER (J Riddell) – Crowded leaving the barriers and steadied.</p> <p>ORLEANS BELLE (J Fawcett) - Steadied from a wide barrier.</p> <p>TANGO LOVE (L Allpress) – Steadied when placed in restricted room passing the 900 metres when ACTING UP shifted inwards.</p> <p>FLEURGUNDY (M Sanson) - Made contact with the running rail approaching the 800 metres, going off stride shifting back onto MYRTLE CREEK who was briefly hampered.</p> <p>REGAL DUCHESS (E Nicholas) - Held up for the majority of the straight.</p>

AMOROUS STU (L Douglas) - Raced in restricted room shortly after leaving the barrier between **CENTANNI** which had lay out and away from runners, and **EL CABALLO** which had shifted in slightly.

CAKEBYTHEOCEAN (A Goindasamy) - Shifted out to avoid the heels of **RELIABELLE DEB** approaching the 1000 metres.

ME LIBEREZ (J Chung) - Lay in under pressure over the concluding stages.

ATOMIC (S Weatherley) – Performed below market expectations. Underwent a post-race veterinary examination which did not reveal any abnormality.
