**Race 4 LANACREE FARMS 1650m**

**FIDDYAFORTNIGHT (L Allpress)** – Trainer Ms JJ Rayner advised Stewards FIDDYAFORTNIGHT underwent a veterinary examination on Thursday 23 June which revealed a rupture to the superficial digital flexor tendon in the left foreleg. JJ Rayner further advised the mare is weight bearing and comfortable at walk, however, will be retired from racing and sent to stud.

<b>Race 1</b>	<b>VETS ON RIVERBANK 2YO 1100</b>
<p><b>PLATINUM CRUISER</b> (J Parkes) - Slow away.</p> <p><b>MANHATTAN JAZZ</b> (K Hercock) - Jumped away awkwardly. Hampered 800 metres.</p> <p><b>NOVELLA</b> (L Sutherland) - Checked when crowded passing the 800 metres, going back on to MANHATTAN JAZZ, which was hampered. Raced wide without cover from the 800 metres.</p> <p><b>ROCABABY</b> (A Mudhoo) - Raced thee wide throughout.</p> <p><b>VERARDINO</b> (C Dell) - Lay inwards under pressure over the concluding stages.</p> <p><b>SUN AND HEIR</b> (L Allpress) - Performed below market expectations. When questioned rider could offer no tangible excuse.</p> <p><b>A Mudhoo</b> (ROCABABY) - Issued with a warning after permitting ROCABABY to shift inwards when not sufficiently clear of NOVELLA near the 800 metres. Stewards took into account some outward movement from SUN AND HEIR.</p>	
<b>Race 2</b>	<b>JCE CONSTRUCT MAIDEN 1200</b>
<p><b>SHE'S MISS GEVIOUS</b> (M Hudson) - Slow away.</p> <p><b>JOE ROMINO</b> (R Hannam) - Contacted leaving the barriers. Lay out under pressure in the home straight.</p> <p><b>STEVIE NIX</b> (L Allpress) - Lay out under pressure over the concluding stages inconvenienced NEVER FEAR near the 200 metres.</p> <p><b>NEVER FEAR</b> (J Parkes) - Momentarily inconvenienced near the 200 metres.</p> <p><b>MASTER BREWER</b> (K Hercock) - Raced three wide without cover.</p> <p><b>PRADASPHERE</b> (V Jalalkuncha) - Raced four wide without cover.</p>	
<b>Race 3</b>	<b>AQUASHIELD ROOFING HANDICAP 1200</b>
<p><b>RONI</b> – C Grylls replaced B Grylls.</p> <p><b>MY FATHER'S GUN</b> (H Schofer) - Restrained to the rear from a wide draw.</p> <p><b>PERFECTSISTER</b> (C Dell) - Performed below market expectations. When questioned rider was of the opinion the filly would derive benefit from today's run and was also of the opinion the filly could benefit from the addition of blinkers.</p>	
<b>Race 4</b>	<b>THE TELE OTAKI MAIDEN 2200</b>
<p><b>ZEDTAC</b> - C Dell replaced B Grylls.</p> <p><b>SAILOR JACK</b> (D Turner) - Began awkwardly.</p> <p><b>UNCLE CHARLIE</b> (C Grylls) - Began awkwardly bumping HERECOMESTHESUN.</p> <p><b>HERECOMESTHESUN</b> (R Hannam) - Bumped at the start.</p>	

**NO TEARS** (T Bau) - Raced wide in the early to middle stages. Commenced to give ground near the 900 metres. When questioned rider was of the opinion the gelding had not been suited by the holding track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

**M Hudson** (ROCMANA) - Admitted a breach of Rule 636(1)(d) in that she failed to ride her mount out to the end of the race when there was a reasonable chance of running into 3<sup>rd</sup> placing. After considering submissions the Adjudicator imposed a suspension of her licence to ride in races from the conclusion of racing on Friday, 8 July until the conclusion of racing on Friday, 22 July, 2 weeks.

**Race 5** | **CAVALLO FARM & CHRIS RUTTEN BLOODSTOCK HANDICAP 1400**

**IF YOU DANCE** - M Hudson replaced B Grylls. Steadied when awkwardly placed on heels passing the 1000 metres.

**FIANO** (A Mudhoo) - Slow away. Steadied when over-racing near the 1000 metres.

**SON OF THUNDER** (F Lazet) - Over-raced in the early to middle stages.

**SURPRIZE ME** (T Taiaroa) - Briefly steadied away from the heels of SON OF THUNDER, which was taken outwards by MORMAIRE (L Allpress) near the 300 metres. L Allpress was advised to exercise care.

**Race 6** | **SPEEDY SIGNS KAPITI MAIDEN 1600**

**S O'Malley** (VALHALLA RISING) - Admitted a charge in that he failed to make the handicapped weight on VALHALLA RISING with the Adjudicator imposing a fine of \$100. S O'Malley was replaced by C Grylls.

**FOXALOT** (J Parkes) - Slow away.

**JESKO** (H Schofer) - Restrained in the early stages to obtain cover after jumping from the outside barrier.

**WATTABREEZE** (A Bohorun) - Over-raced in the early to middle stages.

**LINCOLN LOVER** (M McMab) - Lay inwards in the home straight having to be straightened on several occasions.

**Race 7** | **RIVERSTONE CAFE MAIDEN 1600**

**NUN SO BAD** (F Lazet) - Slow away then being further hampered shortly after the start when crowded, losing ground.

**KUVALDA** (R Hannam) - Commenced to over-race badly shortly after the start, proving a difficult ride until improving to trail the leader approaching the 1000 metres.

**TOBKAY** (A Mudhoo) - Lay inwards over the concluding stages. When questioned into the improved performance of the gelding, Trainer G McKay advised that the addition of blinkers and being ridden forward with an uncontested lead had contributed to today's win.

**BUDDY MARVELLOUS** (M Hudson) - Raced three wide throughout.

**THE DUTCH DAME** (C Grylls) - Raced four wide throughout.

**WIND IN MY WINGS** (D Turner) - Performed below market expectations. When questioned rider advised that in his opinion the gelding had not handled the holding track conditions. A post-race veterinary examination revealed an increased respiratory effort and poor race recovery.

**A Mudhoo** (TOBKAY) - Spoken to with regard to his celebratory gesture.

<b>Race 8</b>	<b>HARCOURTS OTAKI HANDICAP 1600</b>
<b>ROCKTILY OUDROP</b> – C Dell replaced B Grylls.	
<b>MASSO</b> (A Mudhoo) - Slow away.	
<b>Race 9</b>	<b>EL CHEAPO CARS HANDICAP 2100</b>
<b>ALL IN BLACKBERRY</b> (M Hudson) - Slow away after being fractious in the barriers.	
<b>ROAD DIVA</b> (T Bau) - Slow away.	
<b>IRRIGATE</b> (F Lazet) - Over-raced in the early and middle stages.	
<b>KEYBOARD WARRIOR</b> (T Taiaroa) - Steadied when placed in restricted room near the 1800 metres.	
<b>OXYGEN</b> (L Sutherland) - Over-raced in the early and middle stages. Rider dropped her whip near the 550 metres.
