Rider J Kamaruddin advised Stewards he was unwell would not be attending today's meeting. J Kamaruddin is to provide a medical clearance prior to riding next.

Rider R Elliot advised he would not be attending today's meeting as he was indisposed.

Rider B Grylls did not attend today's meeting due being injured at yesterday's meeting at Otaki.

On Thursday 23 June, Rider M Hashizume was released from his engagement in Race 1 after a misunderstanding.

**SUPPLEMENTARY**

**Race 3 FAIRVIEW MOTORS WAIKATO HURDLE (3200 metres)**

**AIGNE** (M Roustoby) – Co-trainer T Carter reported to Stewards AIGNE underwent a veterinary examination on Thursday 23 June which included an endoscopic examination which revealed no abnormalities and blood tests which showed slightly low levels of protein, with T Carter advising the stable now having made adjustments to the gelding's feed. T Carter further advised the stable may look to nominate the gelding for the Hawke's Bay meeting on Saturday 2 July.

**TOMMYRA** (E Farr) – Trainer B Autridge advised Stewards he was satisfied with the post-race condition of the gelding, however, in his opinion TOMMYRA failed to handle the Heavy 10 track conditions. B Autridge further advised it is his intention to continue on with the gelding's current preparation.

**RACE COMMENTS**

**Race 1** | **ULTIMATE MAZDA MAIDEN 1200**

**ROOFTOP** (T Newman) - Slow to begin. Raced keenly having to be steadied racing into the first bend.

**DEGREE OF POWER** (M Hashizume) - Crowded soon after leaving the barriers and steadied.

**Race 2** | **TAURANGA HARDWARE PLUMBING 3YO 1300**

**BOOMER** (M McNab) - Restrained to obtain cover in the early stages.

**MUSIGNY LASS** (A Lawson-Carroll) - Shortly after leaving the barriers received heavy contact when crowded between SAGAN which shifted in leaving the barriers, and DIGGER which was forced outwards by DRUM MAJOR which had been hampered by TURN THE ACE which had shifted out when beginning awkwardly. As a result apprentice Rider A

Lawson-Carroll became badly unbalanced with MUSIGNY LASS losing ground. Shifted out to obtain clear running approaching the 300 metres making contact with DIGGER which was unbalanced.

**DIGGER** (C Jones) - Began awkwardly and badly crowded soon after leaving the barriers. Contacted approaching the 300 metres and unbalanced by MUSIGNY LASS which shifted out. Apprentice Rider A Lawson-Carroll was advised to exercise care in a similar circumstance.

**DRUM MAJOR** (B Rogerson) – Crowded leaving the barriers.

**TURN THE ACE** (C Grylls) – Began awkwardly making heavy contact. When questioned regarding the performance C Grylls advised that with the impost of 59.5 kgs the gelding had travelled strongly in very testing track conditions which had been detrimental to its performance.

**C Jones** (DIGGER) - Issued with a warning after using his whip in two consecutive strides over the concluding stages with Stewards taking into account his clear recent record with regard to any breach of this whip rule.

**C Jones** (DIGGER) - Admitted a charge in that he struck his mount six times prior to the 100 metre mark with the Adjudicative Committee imposing a fine of \$400.

**PURSUED** (M Kareem) - Slow to begin.

**SHARKY** (K Hercock) – Began awkwardly making contact. Steadied passing the 1200 metres when in restricted room.

**CORK** (M McNab) – Contacted leaving the barriers.

**DARCI'S QUEEN** (M Cameron) - Crowded leaving the barriers.

**OFFENDED** (C Grylls) - Raced ungenerously when in restricted room passing the 1100 metres to the inside of COME BACK TIGER which shifted in before then shifting out relieving pressure. A Lawson-Carroll was reprimanded and advised to exercise care. Again raced in restricted room passing the 900 metres to the inside of COME BACK TIGER which was dictated in slightly by OUR WONDERLAND. B Rogerson was reprimanded and advised to exercise greater care.

**CATWALK GIRL** (D Prastiyou) - Began awkwardly losing ground.

**AONGATETE EXPRESS** (C Grylls) - Restrained in the early stages to obtain cover.

**ENCHANTED ELLE** (M McNab) – Crowded shortly after the start. Improved into a tight run approaching the 800 metres to the outside of BEAR GRYLLS which lay out when weakening with ENCHANTED ELLE racing in restricted room.

**SHOCKING PENNY** (M Sanson) - Slow to begin.

**ZEDMAN** (A Lawson-Carroll) - Raced wide without cover throughout. Rider A Lawson-Carroll dropped his left rein near the 100 metres.

**LED ZED** (J Chung) - Steadied 900 metres when awkwardly placed.

**LOGAN'S LOGIC** (V Colgan) – Contacted and briefly unbalanced 800 metres when weakening.

**BEAR GRYLLES** (K Hercock) - Underwent a post-race veterinary examination which did not reveal any abnormality.

**RODOLFO** (T Mitchell) - When questioned regarding the improved performance Trainer S Cameron advised that the gelding had been better suited by today's deep testing conditions.

**Race 5** | **SEEKA KIWIFRUIT CUP 2100**

**RISING ROAD** (C Lindsay) - Slow to begin.

**EL BANDOLERO** (Y Kumagai) – Restrained to obtain cover in the early stages.

**RUA ROCKS** (K Hercock) – Raced keenly in the early and middle stages.

**ROGER THAT** (C Jones) - When questioned regarding the performance C Jones advised that the impost of 58 kgs along with the testing track conditions had been detrimental to the gelding's chances. Underwent a post-race veterinary examination which did not reveal any abnormality.

**Race 6** | **ZEST HANDICAP 1200**

**DIAMOND PEGASUS** (J Chung) – Underwent a veterinary examination after being kicked at the start and was cleared fit to start.

**OSELETA** (S Weatherley) - Slow to begin (4L).

**LADY DE WINTER** (M Hashizume) – Began awkwardly.

**BUTTERFIELD** (A Lawson-Carroll) - Raced in restricted room shortly after the start.

**ROCKET SCIENCE** (R Hannam) – Crowded at the start.

**SHE'S A MANEATER** (M Sanson) - Restrained from a wide barrier. Raced in restricted room passing the 350 metres and was further crowded when ROCKET SCIENCE lay in when contacted.

**BERGAMO FOX** (A Goindasamy) - Underwent a post-race veterinary examination which did not reveal any abnormality. Rider A Goindasamy reported that the gelding may have held its breath.

**Race 7** | **TEAM WEALLEANS TAURANGA CLASSIC 1400 (Listed Race)**

**WHOSHE'S GIRL** (M Sanson) - Slow to begin then shifted outwards making contact with FONTEYN.

**FONTEYN** (A Goindasamy) - Slow to begin then contacted.

**PULLYOURSOCKSUP** (S Spratt) - Over-raced in the early stages.

**LE SABLIER** (M Hashizume) – Crowded over the concluding stages when FONTEYN shifted in. A Goindasamy was advised to exercise greater care.

**MILLEFIORI** (M McNab) - When questioned regarding the performance M McNab advised that the filly had struggled in the ground after being caught on the inside part of the track.

**ONEROA** (M Cameron) - When questioned regarding the performance M Cameron advised that the mare may be feeling the effects of recent racing. Underwent a post-race veterinary examination which did not reveal any abnormality.

**Race 8**

**RHYS MISCHEFSKI, BAYLEYS WHAKATANE HANDICAP 1400**

**ALWAYS MORE** (M McNab) – Restrained from its outside barrier to obtain cover. Forced wide 800 metres.

**ROCKWITHATTITUDE** (S Spratt) – Began awkwardly making contact.

**DIVINE DUDE** (B Rogerson) – Began awkwardly making contact.

**ZOUPERB** (S Weatherley) - Contacted shortly after leaving the barriers.

**POSTER BOY** (A Goindasamy) - Hampered when forced wider approaching the 800 metres by SHIVERS which shifted out. ALWAYS MORE which was following was also forced wider as a result

**IFFIE SHOWS** (M Hashizume) – Inconvenienced passing the 300 metres when GOLDEN HUE shifted out under pressure.

**D Danis** (ANNA GRACE) - Stewards inquired into the manner in which he used his whip in the home straight and could not be conclusively satisfied that he had contravened the rules.

**T Mitchell** (SHIVERS) - Issued with a warning after directing SHIVERS outwards approaching the 800 metres hampering POSTER BOY and ALWAYS MORE which were forced wider on the track.
