Race 5 SPEIGHT'S MAIDEN 1600m

LINCOLN LANE (C Johnson) – Trainer Mr M House advised Stewards LINCOLN LANE has now been retired from racing.

**RACE COMMENTS****Race 1 TAGGART EARTHMOVING (2000m)**

**RAINMAN** (M Taylor) - Slow to begin.

**FIVE PRINCES** (C Barnes) - Hampered then crowded shortly after the start losing ground.

**ZAMBEZI ZIPPER** (L Allpress) - Restrained behind runners to obtain cover shortly after the start.

**VULTURE STREET** (K Asano) - Held up entering the final straight and was unable to obtain clear running for the majority of the run home with the gelding going to the line without being fully tested by its rider.

**K Asano** (VULTURE STREET) - Reprimanded after weighing in 0.4kg under the required weight which was within the 0.5kg tolerance allowed under Rule 648(3).

**M Taylor** (RAINMAIN) - Issued with a warning after she struck her mount 6 times prior to the 100 metres mark with Stewards taking into account her clear recent record with regard to any breach of the whip rule.

**Race 2 GRAND NATIONAL FESTIVAL TICKETS ON SALE NOW (1400m)**

The explanation given by trainer **J Burrows** for the late declaration of a rider for CASTLE ON THE HILL was accepted on this occasion.

**A LITTLE VAGUE** (C Barnes) - Began awkwardly losing ground.

**LENNON** (C Johnson) - Began awkwardly briefly unbalancing its rider and losing ground. Raced wide without cover before being allowed to improve forward to lead near the 900 metres.

**MR GHIBSON** (L Allpress) - Slow to begin. Commenced to race ungenerously in the early and middle stages.

**WHISKEY IN THE JAR** (T Jonker) - Slow to begin. Over-raced in the middle stages on a moderate tempo.

**IFITHAPPENSAGAIN** (C Carmine) - Commenced to over-race when the pace steadied near the 1100 metres having to shift outwards to avoid heels near the 1000 metres inconveniencing CASTLE ON THE HILL, then raced three-wide without cover from this point.

**TAKE A RISK** (K Asano) - Checked when crowded to the inside of I'M A TIGER near the 1100 metres. Held up in the final straight until near the 150 metres.

**CASTLE ON THE HILL** (B May) - Inconvenienced near the 1000 metres.

**REGAL GIRL** (C Campbell) - Held up early in the final straight then had to briefly steady to avoid the heels of RUSSIAN FABLE (S Toolooa) which shifted outwards to obtain clear running near the 250 metres. S Toolooa was advised to exercise care when shifting ground.

**RUSSIAN FABLE** (S Toolooa) - Held up in the final straight until shifting outwards across heels to obtain clear running near the 250 metres.

**K Williams** (I'M A TIGER) - Admitted a charge of careless riding in that she allowed her mount to shift inwards near the 1100 metres when not clear of TAKE A RISK which was crowded and checked. After viewing replays and considering submissions on penalty the Adjudicative Committee suspended K William's licence to ride in races from the conclusion of racing on Thursday 30 June 2022 up to and including Wednesday 6 July 2022, 4 national riding days.

<b>Race 3</b>	<b>THE GRAND SSLAM TRADING COMPANY 2YO (1000m)</b>
<p><b>EXPRESS COUP</b> (K Chowdhury) - Jumped away awkwardly then raced greenly in the early stages.</p> <p><b>TWITCHY SQUIRREL</b> (T Jonker) - Crowded shortly after leaving the barriers.</p> <p><b>RHONDA WOOD</b> (R Beeharry) - Lay out under pressure in the final straight.</p> <p><b>SECRETXPRESS</b> (L Allpress) - Rider reported that the filly had hung outwards during the running.</p> <p><b>R Beeharry</b> (RHONDA WOOD) - Admitted a charge of using the whip in five consecutive strides on his mount over the concluding stages. After viewing replays and considering submissions on penalty the Adjudicative Committee imposed a suspension of R Beeharry's licence to ride in races from the conclusion of racing on Sunday 3 July 2022 until the conclusion of racing on Friday 15 July 2022, 7 national riding days.</p>	
<b>Race 4</b>	<b>DAPHNE BANNAN MEMORIAL (1000m)</b>
<p><b>SHAMELESS TART</b> (K Asano) - Slow to begin.</p> <p><b>KAPALKA</b> (T Moseley) - Slow to begin.</p> <p><b>BLAIR FLIGHT</b> (L Callaway) - Hampered shortly after the start.</p> <p><b>TAVILIGHT</b> (D Montes de Oca) - Crowded shortly after the start losing ground.</p> <p><b>PONY EXPRESS</b> (S Toolooa) - Contacted then crowded shortly after the start losing ground.</p> <p><b>LADY CORA</b> (C Barnes) - Raced ungenerously getting its head up in the early stages.</p> <p><b>MR HASS</b> (L Allpress) - Rider reported the gelding had felt indifferent in its action on pulling up. A post-race Veterinary examination revealed grade three lameness in the right fore leg. Connections were advised that a Veterinary clearance would be required prior to MR HASS racing next.</p>	
<b>Race 5</b>	<b>SMITHS HIRE HANDICAP (1200m)</b>
<p><b>GOODANYA</b> (B May) - Slow to begin.</p> <p><b>LOUIE LOUIE</b> (C Johnson) - Crowded shortly after the start losing ground. Hung outwards in the final straight and was not persevered with over the concluding stages. A post-race Veterinary examination did not reveal any obvious abnormality.</p> <p><b>EMANON</b> (S Toolooa) - Raced keenly in the early and middle stages.</p> <p><b>CHOKITO</b> (Y Atchamah) - Held up rounding the final turn.</p> <p><b>CHILLY FILLY</b> (L Allpress) - When asked to comment on the performance of the mare rider advised she was disappointed with the effort however could offer no tangible excuse. A post-race Veterinary examination did not reveal any obvious abnormality.</p> <p><b>B May</b> (GOODANYA) - Admitted a charge in that he struck his mount six times prior to the 100 metres mark. After viewing replays and considering submissions on penalty the Adjudicative Committee imposed a suspension of B May's licence to ride in races from the conclusion of racing on Sunday 3 July 2022 until the conclusion of racing on Friday 15 July 2022, 7 national riding days.</p>	

<b>Race 6</b>	<b>SAM KEENAN – TENNIS COACH (1400m)</b>
<p><b>AUGUSTACE</b> (K Williams) - Began awkwardly.</p> <p><b>WILD ROVER</b> (K Chowdhoo) - Began awkwardly losing ground.</p> <p><b>GALILEO EXPRESS</b> (B May) - Began awkwardly. Raced keenly in the early and middle stages.</p> <p><b>ALL ASHORE</b> (T Moseley) - Slow to begin then became awkwardly placed on heels having to be steadied losing ground.</p> <p><b>MAMMA SANS</b> (B Murray) - Raced keenly in the early and middle stages and three-wide without cover throughout.</p> <p><b>SEA SHEPHERD</b> (C Campbell) - Held up rounding the final turn and early in the home straight before being disappointed for a run between AUGUSTACE and ANDUIN near the 200 metres when both of those runners shifted ground slightly. When questioned rider C Campbell advised that the gelding is still relatively inexperienced and had been reluctant to improve between runners in the straight.</p>	
<b>Race 7</b>	<b>OPTIMISE FERTILISERS &amp; EQUI-LISE (1400m)</b>
<p><b>ALEGRE</b> (K Chowdhoo) - Fractious in the barriers then began awkwardly losing ground.</p> <p><b>MATSCOT</b> (T Moseley) - Slow to begin. Held up entering the final straight having to shift outwards across heels to obtain clear running.</p> <p><b>ZACAT</b> (C Johnson) - Slow to begin.</p> <p><b>THISTLE DO</b> (C Carmine) - Crowded having to be steadied when becoming awkwardly placed on heels shortly after the start, losing ground. Hampered when crowded near the 1000 metres. Over-raced through the middle stages.</p> <p><b>BURNVUE</b> (L Callaway) - Steadied when awkwardly placed close to the heels of BLUE VEIN (S O'Malley) which shifted inwards near the 1000 metres when not fully clear. S O'Malley was advised to exercise care when shifting ground. Lay inwards under pressure in the straight.</p> <p><b>DRAKE BAY</b> (D Montes de Oca) - Hampered when crowded near the 1000 metres.</p> <p><b>FINAL SAVINGS</b> (L Allpress) - Hampered when crowded near the 1000 metres.</p> <p><b>R Mudhoo</b> (MR RAFIKI) - Admitted a charge of careless riding in that he permitted his mount to shift inwards near the 1000 metres resulting in crowding to DRAKE BAY, THISTLE DO and FINAL SAVINGS which were all hampered. After viewing replays and considering submissions on penalty the Adjudicative Committee imposed a suspension of R Mudhoo's licence to ride in races from the conclusion of racing on Thursday 30 June 2022 until the conclusion of racing on Wednesday 6 July 2022, 4 national riding days.</p>	
<b>Race 8</b>	<b>GREENWOOD AMBERLEY CUP (1600m)</b>
<p><b>ORIGINAL GANGSTER</b> (K Williams) - Blundered leaving the barriers. When questioned regarding the performance rider advised that after its poor beginning the gelding had got further back than intended and is better suited racing closer to the pace, adding that it had not felt entirely comfortable in today's holding track conditions. A post-race Veterinary examination did not reveal any obvious abnormality.</p> <p><b>SILENT BATTLER</b> (T Moseley) - Crowded leaving the barriers.</p>	

**WILLIAM WALLACE** (C Campbell) - Slow to begin.

**FRANKIE THE FOX** (R Mudhoo) - Slow to begin.

**WHALE SONG** (D Montes de Oca) - When questioned regarding the performance rider was unable to offer any excuse other than the gelding possibly not handling today's holding track conditions.

**CANNOLI** (K Chowdhoo) - When questioned regarding the performance rider advised that the mare had failed to handle today's holding track conditions.

<b>Race 9</b>	<b>RACECOURSE HOTEL &amp; MOTOR LODGE (2000m)</b>

**RED RUFUS** (C Barnes) - Began awkwardly.

**KITTY POWER** (B May) - Slow to begin.

**BAILADOR** (G Jogoo) - Slow to begin.

**WILD LIKE** (K Chowdhoo) - Crowded shortly after the start.

**ENOUGH SAID** (C Johnson) - Restrained behind runners to obtain cover shortly after the start.

**LETZ'AV BUBBLES** (K Williams) - Raced ungenerously getting its head up in the early stages.

**LA COFRADIA** (K Asano) - Raced ungenerously and got its head up when being steadied near the 1800 metres. Again raced ungenerously getting its head up near the 1600 metres.

**HEY MICKEY** (M Taylor) - Rider dropped her whip passing the 200 metres.

**C Johnson** (ENOUGH SAID) - Issued with a warning after weighing in just just within within the 0.5kg tolerance allowed under Rule 648(3).

**B Murray** (LITTLE WING) - Admitted a charge in that he struck his mount six times prior to the 100 metres mark. After viewing replays and considering submissions on penalty the Adjudicative Committee imposed a fine of \$500.

Following the race authorisation of dividends was delayed whilst the Stewards reviewed the photo finish with an initial result of 4 - HEY MICKEY 1<sup>st</sup>, 2 - RED RUFUS 2<sup>nd</sup>, 3 - ENOUGH SAID 3<sup>rd</sup> having been announced. Stewards then requested that the Judge review his decision where it became apparent that when using the photo finish technology, a close up zoom image had been viewed with an identification error being made of the two horses heads when utilising the inside camera view. Following this review placings were amended by the Judge and payment of dividends authorised on final placings of 2 - RED RUFUS 1<sup>st</sup>, 4 - HEY MICKEY 2<sup>nd</sup>, 3 - ENOUGH SAID 3<sup>rd</sup>.
