<b>Race 1</b>	<b>HAWKE'S BAY HUNT MAIDEN HURDLE 2500</b>
<b>MAJOR TOM</b> (C Case) - Jumped the first fence indifferently. Misjudged the fence near the 1000 metres.	
<b>FABULOUS NANCY</b> (N Downs) - Put in a poor jump at the first two fences losing ground and continued to jump indifferently throughout.	
<b>DAL KILCHOAN</b> (P Matthews) - Raced wide without cover throughout. Put in a poor jump at the second last fence.	
<b>NOESS</b> (S Phelan) - Hit the final fence.	
<b>E Farr</b> (BROTHER MAX) - Issued with a warning after failing to retire her mount from the race when out of contention.	
<b>Race 2</b>	<b>TE WHANGAI ROMNEY'S HAWKE'S BAY HURDLE 3100</b>
<b>CANDY CROSS</b> (S Karnicnik) - Misjudged the second fence. Put in a poor jump at the fence near the 1200 metres.	

**DR HANK** (H McNeill) - Badly misjudged the second last fence.

**TRISHA LEA** (S Fannin) - Retired from the race prior to the second last fence when well beaten.

**N Downs** (KAJINO) - Admitted a charge of using the whip in two consecutive strides on his mount near the 250 metres. After considering submissions the Adjudicative Committee imposed a fine of \$550.

**Race 3** | **WINTER FEATURE RACEDAY 9 JULY SPRINT 1200**

**TIMES TICKING** (J Mudhoo) - Crowded between runners leaving the barriers, losing ground.

**DURHAM LAD** (F Lazet) - Jumped away awkwardly shifting outwards making contact with **TIMES TICKING**.

**EAGLE COUNTY** (D Bradley) - Jumped away awkwardly shifting inwards making contact with **TIMES TICKING**.

**DEERFIELD** (Y Kumagai) - Jumped away awkwardly. Steadied when placed in restricted room to the inside of **MAISON ROXANNE** (K HercocK) near the 1000 metres. K HercocK was advised to exercise care. Had to be firmly restrained getting its head up when improving onto the heels of **MAISON ROXANNE** near the 900 metres.

**NO ROCK NO POP** (L Sutherland) - Raced three wide without cover.

**Race 4** | **LIVAMOL CLASSIC TICKETS ON SALE NOW 1400**

**PLATINUM STAR** (A Mudhoo) - Slow away. Lay out rounding the final turn and in the straight.

**SACRED PEARL** (C Dell) - Raced wide without cover.

**LORD VALENTINE** (T Thornton) - Shifted ground under pressure in the straight.

**Race 5** | **JUST A SWAGGER/PERRY MASON MAIDEN STEEPLECHASE 4000**

**MRS TWINKLETOES** (E Farr) – Put in a poor jump at the first of the double on the first occasion. Badly misjudged the fence near the 800 metres on the final occasion almost dislodging its rider.

**THE ANARCHIST** (S Phelan) - Misjudged the second of the double on the first occasion. Put in a poor jump at the fence near the 800 metres on the final occasion.

**KEYBOARD WARRIOR** (S Karnicnik) - Landed awkwardly after jumping the fence near the 1000 metres. Underwent a post-race veterinary examination which revealed minor bruising and puncture wounds to the left hind stifle.

**RITESAIDZED** (B Lammas) - Retired from the race prior to the final fence. Underwent a post-race veterinary examination which did not reveal any abnormality.

**BLANCO BAY** (D Parker) - Retired from the race prior to the final fence.

**B Lammas** (RITESAIDZED) - An Information was filed alleging B Lammas had breached Rule 636(1)(b) in that he failed to take all reasonable and permissible measures to obtain the best possible finishing position prior to retiring his mount from the race before the final fence. B Lammas requested and was granted an adjournment by the Adjudicative Committee with the matter now likely to be heard at Woodville on Thursday, 14 July 2022.

**Race 6** | **AHD HAWKE'S BAY STEEPLECHASE 4800**

**ZAMORA** (N Downs) - Badly misjudged the second of the double on the final occasion, dislodging its rider. N Downs was attended to by St Johns Ambulance personnel and transferred to Hastings' hospital for further evaluation. Underwent a post-race veterinary examination which did not reveal any abnormality.

**WEST COAST** (S Fannin) - Put in a poor jump at the fence near the 500 metres.

**DELEGATE** (H McNeill) - Retired from the race prior to the second last fence when well beaten.

**Race 7** | **BIRCHLEIGH POLO CLUB 2200**

**TAUMALOLO** (C Dell) - Shifted outwards leaving the barriers, hampering **CARPE DIEM**, **RED 'N' SURF** and **SEAJETZ**.

**CARPE DIEM** (R Hannam) - Hampered leaving the barriers. When questioned into performance rider advised that in his opinion the gelding was unsuited by the step up to 2200 metres in today's track conditions.

**RED 'N' SURF** (L Sutherland) - Hampered leaving the barriers.

**SEAJETZ** (Y Kumagai) - Hampered leaving the barriers.

**NASSAK DIAMOND** (L Allpress) - Steadied to obtain cover in the early stages after jumping from the outside barrier.

**SUFFICE TO SAY** (T Thornton) - Came under pressure passing the 800 metres commencing to give ground shortly after, dropping out to finish a distant last. A post-race veterinary inspection found the gelding to have suffered from cardiac arrhythmia with the appropriate veterinary clearance now being required prior to racing again.

**D Turner** (**CROSS ROADS**) - Admitted a charge in that he struck his mount **CROSS ROADS** six times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$250.

**Race 8** | **TARADALE CLUB MILE 1600**

**JUSTASKME** (J Mudhoo) - Crowded leaving the barriers.

**COLORADO STAR** (L Allpress) - Raced three wide without cover throughout.

**Race 9** | **COLLIERS SPRING RACING CARNIVAL 1600**

**FATTORE OTTO** (A Mudhoo) - Raced wide throughout.

**THE TWINKLING** (E Nicholas) - When questioned regarding performance rider was of the opinion the mare had failed to handle today's holding track conditions.

**SPLODGE** (C Dell) - Inconvenienced passing the 100 metres when **JAKKALNUTS** shifted inwards before being immediately corrected by its rider.
