## RACE COMMENTS

**Race 1** | **ALLEVIATE ADMINISTRATION MAIDEN 1600m**

**GABBY DIAZ** (R Beeharry) - Slow to begin.

**TREKOLURE** (S Toolooa) - Slow to begin.

**BACK HUT** (S Muniandy) - Over raced in the early stages on a slow tempo.

**Race 2** | **HIREPOOL MAIDEN 1400m**

**MIDNIGHT JANE** (T Mitchell) - Fractious in its barrier prior to the start then began awkwardly shifting in crowding REINEDELARIVIERE.

**THE DUDE** (D Montes de Oca) - Shifted out at the start crowding outside runner.

**BAUBLE** (C Campbell) - Crowded at the start losing ground. Held up passing the 500 metres having to shift out to obtain clear running. Lay out rounding the final bend.

**REINEDELARIVIERE** (L Callaway) - Crowded at the start losing ground. Placed in restricted room having to be steadied when BAUBLE shifted out when not fully clear near the 400 metres.

**LOCKDOWN LEGACY** (D Bothamley) - Lay out shortly after the start losing ground then got its head up when over racing in the early stages.

**DICELAND** (S Muniandy) - Raced three wide without cover in the early stages.

**VELARDE** (T Moseley) - When questioned regarding performance rider could offer no excuse. Underwent a post-race veterinary examination which revealed the gelding to have suffered cardiac arrhythmia with connections being advised VELARDE will now be required to have a veterinary clearance prior to racing again. Trainer J Burrows advised Stewards she would be reassessing the racing career of the gelding.

**C Campbell** (BAUBLE) - Issued with a warning for allowing his mount to shift out when not fully clear of REINEDELARIVIERE. When assessing the interference Stewards took into consideration the racing manners of BAUBLE which was having its first start.

**Race 3** | **SPEIGHT'S MAIDEN 2200m**

**OLE MATE** (K Mudhoo) - Began awkwardly shifting out making contact with the outside runner losing ground as a result. Commenced to give ground near the 400 metres and was not persevered with in the home straight. When questioned regarding performance rider could offer no tangible excuse. A post-race veterinary examination revealed no abnormalities.

**RULZTHENIGHT** (M Taylor) - Over raced in the early stages. Lay in under pressure throughout the final straight.

**PRIMA DONNA** (T Moseley) - Briefly steadied when placed in restricted room when PRIMA DONNA and RULZTHENIGHT shifted ground simultaneously near the 1900 metres.

**DUBLIN HUNTER** (B Murray) - Under pressure passing the 800 metres and was not persevered with in the run home. When questioned regarding performance rider advised the gelding made abnormal breathing sounds and may have held its breath. A post-race veterinary examination revealed respiratory noises with connections being advised a veterinary clearance will be required prior to the gelding racing again.

**T Moseley** (PRIMA DONNA) – Issued with a warning under Rule 638(3)(f)(vii) for using his whip on a runner when clearly winning.

**Race 4** | **NELLIES RESTAURANT & BAR 2200m**

**JACK BE QUICK** (G Jogoo) - Became fractious, getting both hind legs over the top of its barrier. JACK BE QUICK was removed from its barrier and underwent a veterinary examination and was cleared fit to start. Connections were advised that the gelding will now be required to barrier trial prior to racing next. Steadied when becoming awkwardly placed on the heels of IDEAL WARRIOR passing the 1900 metres. Y Atchamah was advised to exercise greater care. Held up early in the run home having to shift out across heels to obtain clear running passing the 200 metres.

**HOLY LOCH** (S Toolooa) - Slow to begin. Improved quickly onto heels near the 1400 metres getting its head up when being steadied.

**UPHOLD** (C Barnes) - Slow to begin.

**YING RESOLUTE** (M Taylor) - Restrained behind runner from a wide draw to obtain cover.

**ZAMBEZI ZIPPER** (T Mitchell) - Raced wide without cover through the early and middle stages.

**NEVETS** (T Moseley) - Raced keenly through the early and middle stages. Commenced to give ground near the 400 metres and was not persevered with through the final straight. When questioned regarding performance rider advised that when pulling up, the mare was making heavy respiratory noises. Underwent a post-race veterinary examination which revealed no abnormalities.

**COLOUR ME RED** (L Callaway) - Placed in restricted room having to be steadied to the inside of JACK BE QUICK approaching the 1900 metres. G Jogoo was advised to exercise greater care. Lay in under pressure for the majority of the run home having to be corrected by its rider.

**HILLERSDEN** (D Montes de Oca) - When over racing became awkwardly placed on heels having to be steadied near the 1900 metres. When questioned regarding performance rider advised the gelding failed to handle the heavy track conditions.

**EAVESDROP** (C Campbell) - Held up entering the final straight and was unable to obtain clear running until near the 100 metres.

**B Murray** (DAY LIGHT) – Admitted a breach of Rule 619 in that he changed his boots after weighing out with the Adjudicator imposing a fine of \$100 under the Minor Infringement Schedule.

**MOVIE STAR** (M Taylor) - Fractious in its gate and then began awkwardly losing ground (5 lengths).

**IRON MIKE** (T Moseley) - Raced three wide without cover throughout.

**MR MISTER** (C Johnson) - Raced greenly in the early stages and when passing the 1000 metres lay outwards hampering REPO MAGIC.

**REPO MAGIC** (C Campbell) - Hampered near the 1000 metres and was then obliged to race wide without cover for the rest of the race.

**HIDALGO** (D Montes de Oca) - Shifted out abruptly having to be corrected by its rider approaching the 50 metres.

**T Mitchell** (GO LOTTE) - Stewards inquired into the manner in which T Mitchell used her whip in the home straight but could not be conclusively satisfied that she had contravened the rule.

**RITA HAYWORTH** (T Moseley) - Slow to begin. When being steadied to avoid heels near the 900 metres shifted out abruptly making firm contact with CASTLE ON THE HILL.

**SWEET MOLLY MALONE** (K Mudhoo) - Began awkwardly losing ground.

**REGAL GIRL** (C Campbell) - Began awkwardly. Crowded shortly after the start having to be steadied when GALLERY GIRL was taken in by KERANY. S Muniandy was advised to exercise greater care. Commenced to over race getting its head up on a number of occasions throughout the early stages.

**CASTLE ON THE HILL** (W Papier) - When racing in tight quarters near the 900 metres between KERANY and RITA HAYWORTH who when being steadied overreacted and shifted out abruptly despite the rider's efforts, making heavy contact with CASTLE ON THE HILL which was buffeted and unbalanced losing ground with GALLERY GIRL being hampered as a result.

**GALLERY GIRL** (Y Atchamah) - Hampered near the 900 metres.

**OPHELIA ROSE** (R Beeharry) - Lay out rounding the final bend

**KERANY** (S Muniandy) - Received post-race veterinary attention after suffering abrasions to the left hind leg consistent with the mare being galloped on during the race with the abrasions requiring stitching.

**Race 7** | **POSITIVE SIGNS 1600m**

There was a delay of approximately three minutes due to the veterinarian being required to attend to a horse post-race six.

**TRABRUK** (D Montes de Oca) - Began awkwardly and then raced three wide without cover for the majority of the race.

**MIRADELLO** (S Toolooa) - Crowded shortly after the start losing some ground.

**Race 8** | **27<sup>TH</sup> AUGUST – OTAGO AWARDS EVENING 1600m**

**SHE'S GOT THE LOOK** (K Mudhoo) - Slow to begin.

**HONESTY** (T Moseley) - Crowded at the start losing ground.

**CHEYENNE DREAMS** (C Johnson) - Raced keenly in the early and middle stages. When questioned regarding performance rider advised when the mare had been placed under pressure had failed to let down.

**OUR TEDDY BOY** (T Mitchell) - Raced three wide without cover for the majority of the event.

**SADLER'S LASS** (S Muniandy) - Lay in rounding the final bend and near the 350 metres became awkwardly placed on the heels of HONESTY which resulted in SADLER'S LASS clipping a heel and blundering losing some momentum.

**GLAMOUR** (L Callaway) - When questioned regarding performance of favoured runner rider advised the mare had failed to respond to his urgings in the run home and may not have backed up for last week's run.
