Mr Carmine was advised he would require a medical clearance prior to riding next. Due to the incident in Race 3 races 4, 5 and 6 had their start times amended.

RACE COMMENTS	
Race 1	NORM & LEANNE STEWART 1600m
<p>SEA SHEPHERD (C Campbell) - Underwent a veterinary inspection for a potential issue with its left eye. Trainer S Kirkland was advised that a veterinary clearance would be required prior to SEA SHEPHERD racing again. Lay outwards in the run home contacting LORD DARCI on at least two occasions.</p> <p>WEE TADHG (K Kwo) - Began awkwardly losing ground and was further hampered shortly after the start.</p> <p>DA VINCI GIRL (D Montes de Oca) - Began awkwardly losing ground. Lay in throughout the run home with the rider using the whip in the left hand.</p> <p>MR RAFIKI (R Mudhoo) - Dictated inwards inside the line of the running rail at the crossing near the 1450 metres having to be restrained and when being brought back onto the racing line made contact with the running rail.</p> <p>TIFFEN (M Taylor) - Raced three wide without cover throughout.</p> <p>ANDREA (T Moseley) - Dictated inwards at the crossing near the 1450 metres.</p> <p>S Toolooa (CHOKITO) – Admitted a breach of careless riding in that he allowed his mount to shift in near the 1450 metres dictating ANDREA inwards who in turn dictated MR RAFIKI inwards off the line of running with MR RAFIKI having to check and making contact with the running rail near the 1400 metres. After hearing submissions the Adjudicator imposed a suspension of his licence to ride in races from the end of racing today up to and including 20 July 2022 (7 national days).</p> <p>R Mudhoo (MR RAFIKI) – Was issued with a warning under Rule 638(3)(f)(iii) for the manner in which he used his whip on a runner out of contention.</p>	
Race 2	STACKHOUSE FARMING 1400m
<p>BELASARD (D Montes de Oca) - Slow away. Inconvenienced near the 800 metres when SENTIENT shifted outwards.</p> <p>IFITHAPPENSAGAIN (C Campbell) - Blundered leaving the barriers losing ground. Hampered near the 800 metres when SENTIENT had to shift across heels when over racing.</p>	

RUN FOR COVER (R Mudhoo) - Shifted in abruptly at the start.

SCALA SANCTA (T Moseley) - Restrained to obtain cover in the early stages after jumping from the outside barrier. Made the bend near the 900 metres awkwardly when racing keenly.

SENTIENT (Y Atchamah) - Over raced in the middle stages shifting outwards across heels near the 800 metres to improve forward and raced wide without cover from that point.

MASQUE (M McNab) - When asked to comment on performance of favoured runner rider advised the gelding had been disappointing and could offer no tangible explanation.

Race 3	GARY MCCORMICK TRANSPORT MAIDEN 1400m

BORNHOLM (B Murray) - Blundered leaving the barriers.

PERIA'S LEGACY (G Jogoo) - Shifted out at the start contacting BRANCASTER BOMBER.

BRANCASTER BOMBER (W Papier) - Contacted at the start. Clipped a heel and fell passing the 1100 metres with the trailing DEVIL IN DISGUISE being badly hampered with the rider being unbalanced and falling and LIT'L ROCK who was unable to avoid the fallen horse being brought down dislodging the rider. Also hampered in this incident was SHOW US PLENTY. All three horses underwent veterinary inspections. All three riders were immediately attended to by oncourse paramedics with all three riders being transported to hospital for further assessment. Lamé in the right hind leg with a veterinary clearance required prior to racing again.

DEVIL IN DISGUISE (S Muniandy) - Badly hampered with rider being unbalanced and falling near the 1100 metres. Veterinary inspection revealed no abnormalities.

LIT'L ROCK (C Campbell) - Brought down dislodging rider near the 1100 metres. Veterinary inspection revealed no abnormalities.

SHOW US PLENTY (Y Atchamah) - Hampered near the 1100 metres.

VICTOR ROUGE (T Moseley) - Treated post-race for a minor abrasion to a hind leg.

T Moseley (VICTOR ROUGE) – Admitted a breach of careless riding in that he allowed his mount to shift in passing the 1100 metres when not fully clear of BRANCASTER BOMBER who clipped a heel and fell resulting in the trailing DEVIL IN DISGUISE being badly hampered dislodging its rider and LIT'L ROCK being unable to avoid the fallen horse and falling dislodging its rider. After hearing from Stewards and Mr Moseley the Adjudicator suspended his licence to ride from the conclusion of racing today up to and including 3 August (4 weeks).

Race 4	SIMS BAKERY CAKES FOR ALL OCCASIONS 1400m

A BOX OF TRICKS (L Callaway) - Was fractious in the barriers was removed, underwent a veterinary inspection and then cleared to start.

A LITTLE VAGUE (K Mudhoo) - Began awkwardly losing ground.

GEMSTONE JEWELS (G Jogoo) - Crowded at the start losing ground. Inconvenienced near the 250 metres when MAKABAR shifted out to find clear racing room. D Montes de Oca was advised to exercise greater care.

USURER (T Mitchell) - Raced three wide without cover for the majority of the event.

MAKABAR (D Montes de Oca) - Shifted out near the 250 metres to find clear racing room inconveniencing GEMSTONE JEWELS.

T Mitchell (USURER) – Admitted a breach of Rule 638(3)(g)(i) in that she struck her mount USURER six times prior to the 100 metre mark with the Adjudicator imposing a fine of \$500.

Race 5 | **SMALLBONE ISUZU 2200m**

ENOUGH SAID (M McNab) - Crowded leaving the barriers losing ground. Lay in over the concluding stages making contact with HEY MICKEY near the 50 metres before being straightened by its rider.

EKSTREMEMISS (G Jogoo) - Crowded leaving the barrier when VISTOCK jumped outwards. Held up by tiring runner passing the 500 metres and continued to be held up until entering the home straight having to shift outwards across heels to find racing room passing the 350 metres.

NO RIGMAROLE (J Chung) - Over raced when leading through the early and middle stages.

YING RESOLUTE (T Mitchell) - Raced wide without cover in the early stages before improving forward to sit outside the leader near the 1000 metres.

CAST IN BRONZE (L Callaway) - Had to be steadied away from heels near the 1900 metres when over racing.

YOUNEVERKNOW (S Toolooa) - Steadied away from heels near the 1500 metres when over racing.

HEY MICKEY (M Taylor) - Dictated inwards over the concluding stages.

M McNab (ENOUGH SAID) – Was issued with a warning when allowing his mount to shift in near the 50 metres making contact with HEY MICKEY who was dictated off its line.

The connections of the second placed HEY MICKEY viewed Stewards' footage of the incident over the concluding stages before deciding not to proceed with a protest.

Race 6 | **TREMBATH PLUMBING OPEN HANDICAP 2200m**

VULTURE STREET (K Asano) - Restrained in the early stages to obtain cover after jumping from the outside barrier. Improved wide from the 800 metres.

NOMEN LUDI (M McNab) - Raced wide without cover rounding the first bend before improving forward to lead passing the 1400 metres.

WANNABE 'N' PARIS (C Johnson) - Raced keenly in the early stages and when shifting out to avoid heels made contact with ATHENE near the 1600 metres and was then allowed to stride forward to lead near the 1400 metres.

ATHENE (K Mudhoo) - Contacted by WANNABE 'N' PARIS near the 1600 metres.

VAGUE (G Jogoo) - Finished a distant last with rider unable to offer any tangible excuse other than the mare had hung in the back straight. A veterinary examination revealed no abnormalities.

K Asano (VULTURE STREET) – Admitted a breach of Rule 638(3)(g)(l) in that he struck his mount VULTURE STREET six times prior to the 100 metres with the Adjudicator imposing a fine of \$500.

T Mitchell (ZAMBEZI ZIPPER) – Admitted a breach of Rule 638(3)(g)(i) in that she struck her mount ZAMBEZI ZIPPER eight times prior to the 100 metres with the Adjudicator imposing a suspension of her licence to ride from the conclusion of racing on 16 July up to and including 28 July (6 days).

Race 7 | **DUNSTAN HORSEFEEDS 1200m**

DORIS DIOR (T Jonker) - Jumped away awkwardly.

TADITA (C Johnson) - Slow to begin then raced wide without cover through the early stages.

WHERE'S WALLY (K Williams) - Slow to begin. Held up late in the race going to the line not fully tested by its rider.

EMANON (S Toolooa) - When asked to comment on performance of favoured runner rider could offer no tangible excuse.

Race 8 | **WINNING EDGE PRESENTATIONS WINTER CUP TRIAL HCP 1400m**

LOUIE LOUIE (C Johnson) - Slow away. Raced wide without cover and hung for the majority of the event and then ran very wide rounding the final turn. Continued to lay out under pressure in the straight and was unable to be ridden to full advantage as a result. Connections were advised the gelding was on a racing manners warning.

KING COUGAR (T Mitchell) - Over raced outside the leader in the early and middle stages.

SEVERINE (K Asano) - Rider reported that the mare had felt sore behind with a post-race veterinary inspection revealing the mare to be 3/5 lame in the right hind leg. Connections were advised a veterinary clearance was required prior to racing again.

SCARFI (T Moseley) - When asked to comment on the performance of favoured runner rider was of the opinion the mare had not been helped by the holding nature of the track particularly in the run home.

Race 9 | **COCHRANES OF CANTERBURY 1400m**

Trainer N Coulbeck – Admitted a breach of Rule 614(2) in that he was neglectful in saddling when he presented ZACAT with an incorrect saddle cloth with a fine of \$50 being imposed under the Minor Infringement Schedule.

MATSCOT (T Moseley) - Slow to begin while being further hampered losing ground. Over raced for a distance passing the 1000 metres having to shift out to avoid heels and continued to race ungenerously for a distance.

ALEGRE (K Asano) - Jumped away awkwardly making contact with PAZE THE POWER losing ground.

PAZE THE POWER (K Kwo) - Contacted leaving the barriers. Rider was of the opinion that the mare needs tracks with more moisture in them.

LOVINGYOURWORK (B Murray) - Jumped away awkwardly.

JACK ATTACK (K Williams) - Raced keenly in the early stages.

CAMPING (T Mitchell) - Improved onto heels near the 1000 metres having to shift ground outwards.

ZACAT (C Johnson) - Placed in restricted room and buffeted when RUSSIAN FABLE shifted in and SILVER CANNON attempted to shift out.

HUNTER VILLAIN (M Taylor) - Held up passing the 250 metres then had to shift ground inwards to find clear racing room and was then held up again when improving onto the heels of **RUSSIAN FABLE** near the 125 metres and went to the line not fully tested by its rider.

LIGHT UP (T Newman) – Steadied when placed in restricted room passing the 150 metres when **HUNTER VILLIAN** was taken out by **RUSSIAN FABLE** (S Toolooa) who shifted ground at this point. S Toolooa was advised to exercise more care and keep his mounts straighter than he had on this occasion.

RUSSIAN FABLE (S Toolooa) – Was inclined to shift ground over the concluding stages.

Race 10	AGRAFORUM COMCAT 1600M

SPLENDIOR (T Jonker) - Slow away.

WHALE SONG (J Chung) - Crowded leaving the barriers. Rider spoken to advisedly when using his whip on a runner out of contention.

CANNOLI (D Montes de Oca) - Crowded shortly after the start losing ground.

BURNVUE (L Callaway) - Raced keenly in the early stages.

FACETIME (M McNab) - Lay in early in the run home. When asked to comment on the performance rider was of the opinion that the mare had not been suited when forced to race on the inside of the track where he believed the ground was the stickiest.

Race 11	AGRAFORUM GROWING INNOVATION 1600m

TANTALEE (R Mudhoo) - Jumped away awkwardly hampering **EL BEE JACK** which lost ground. Hampered over the concluding stages.

EL BEE JACK (K Williams) - Hampered leaving the barriers losing ground.

TARAMEA LAD (M McNab) - Restrained to obtain cover in the early stages after jumping from the outside barrier. When asked to comment on performance rider was of the opinion the gelding was looking for tracks with more moisture in them.

TELLING TALES (D Montes de Oca) - Was inclined to shift ground under pressure in the straight and shifted outwards over the concluding stages hampering **MR GHIBSON**, **TANTALEE** and **YEAH RIGHT**. D Montes de Oca, in the company of the jockey mentor Mr D Walsh, was shown replays of the concluding stages and advised he must keep his mount straight on future occasions.

MR GHIBSON (K Asano) - Hampered over the concluding stages.

YEAH RIGHT (B Murray) - Hampered over the concluding stages.

PLATINUM PETALS (C Johnson) - When asked to comment on performance of the favourite rider could offer no tangible explanation.
