GENERAL

Permission was granted for M McNab to ride OSELETA (R2) 1 kg over the handicapped weight.

RACE COMMENTS

Race 1 SVS STARTING GATES 3YO (1200 metres)

JUSTASCOOTA (V Colgan) - Began awkwardly then crowded, losing ground. Became tailed off in the early stages. When questioned regarding the performance the rider advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary inspection which did not reveal any abnormality.

SHEJENGAR (A Goindasamy) – Jumped inwards leaving the barrier crowding JUSTASCOOTA.

SEAMSEW (M McNab) - Restrained in the early stages to obtain cover from a wide barrier.

BARBARINA (K Asano) - When questioned regarding the performance the rider advised that the filly had failed to handle today's track conditions. Underwent a post-race veterinary inspection which confirmed the filly to have bled. BARBARINA shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

Race 2 | **GROUP ONE TURF BAR SPRINT (1200 metres)**

AERO DE PARIS (Y Kumagai) - Slow to begin.

ANGELICA (M Kareem) - Restrained in the early stages to obtain cover from an outside barrier.

HELENA BABY (D Danis) - Underwent a post-race veterinary inspection which did not reveal any abnormality.

T Mitchell (BUTLER) - Admitted a charge in that she struck her mount BUTLER six times prior to the 100 metre mark. After considering submissions the Adjudicator suspended T Mitchell's licence to ride in races from the conclusion of racing on Thursday 28 July up to and including racing on Friday 12 August, 7 national riding days. T Mitchell is to be referred to the Rider Skills Review Panel given her record in recent months.

Race 3 | **JOHN YOUNG FAMILY 2200**

FINEST WINE (R Beemud) - Began awkwardly then skied its head leaving the barriers, losing ground.

KHAN HUNTER (J Kamaruddin) - Began awkwardly losing ground.

RENEGADE FIGHTER (K Asano) - Began awkwardly.

SHOCKING PENNY (M Sanson) - Raced keenly in the early stages.

RODOLFO (T Mitchell) – Raced keenly when placed in restricted room for a distance passing the 1800 metres.

Race 4 | **MARK SANDERS MEMORIAL (2100 metres)**

PRIOR ENGAGEMENT (N Parmar) - Slow to begin.

OSTASIO (A Lawson-Carroll) – Shifted out abruptly leaving the barriers hampering PLUSHENKO.

PLUSHENKO (J Chung) – Stewards granted permission for the gelding not to race in the notified blinkers due to today's track conditions. Hampered leaving the barriers losing ground.

ELECTRIC TIME (R Beemud) - Began awkwardly. Steadied when placed in restricted room passing the 850 metres.

CINNAMON STAR (M Hashizume) - Crowded leaving the barriers.

HUSK (J Riddell) - Began awkwardly.

MY MAEBELLINE GIRL (L Satherley) - Raced keenly in the early stages.

BEAR GRYLS (C Jones) - Raced wide without cover throughout. Underwent a post-race veterinary inspection which did not reveal any abnormality.

Following the running of this race Stewards inquired into the reasons why a number of runners appeared to contact the front of the starting gates prior to the field being released. It was established that the button that activates the gates had failed to function when pressed. The Starter was reprimanded and reminded of his obligations in that he

must remove any runner from its barrier that has firmly contacted the starting stalls to undergo a veterinary examination prior to being reloaded.

Race 5 | **J F GRYLLES MEMORIAL CLASSIC (1500 metres)**

TEEN TITAN (Y Kumagai) - Began awkwardly.

KYA KHOOB LAGTI HO (S Weatherley) - Shifted inwards leaving the barriers making contact with **HOT SALSA**.

HOT SALSA (D Danis) - Contacted leaving the barriers.

INDEEM (E Nicholas) - Slow to begin.

THOMAS AQUINAS (M Cameron) - Slow to begin.

DEEBEE ZAPOWER (V Colgan) – Over-raced through the middle stages.

HOT PINX (R Elliot) - Rider R Elliot was excused from weighing in by Stipendiary Stewards after being dislodged on pulling up. R Elliot was attended to by oncourse ambulance personnel and cleared to fulfil his remaining rides.

Race 6 | **IRWIN'S TRUCK & BUS MILE (1600 metres)**

RAKAU (J Chung) – Shifted in at the start making contact with **DIAMOND JAK**. Had to be firmly restrained after laying inwards becoming awkwardly placed on heels near the 1300 metres.

DIAMOND JAK (S Weatherley) - Contacted at the start.

VAVE (D Prastiyou) - Began awkwardly.

LEGIT (N Parmar) - Began awkwardly.

CANHEROC (A Lawson-Carroll) - Began awkwardly making contact with **LITTLE JOE** unbalancing its rider.

LITTLE JOE (T Thornton) - Contacted leaving the barriers.

DAYDREAM BELIEVER (D Danis) – Restrained in the early stages to obtain cover from an outside barrier.

TE ATATU PASH (Y Kumagai) - Raced keenly in the early stages.

N Parmar (LEGIT) - Issued with a warning after failing to ride his mount out to the end of the race when circumstances permitted him to do so.

Race 7 | **UBP TE AWAMUTU CUP (1600 metres)**

SHERRIF (S Weatherley) - Began awkwardly.

HEZTHEWONFORUS (S Spratt) - Raced keenly in the early stages. When questioned regarding the performance the rider could not offer any excuse.

Race 8 | **OTL GROUP LTD 1400**

ANNA GRACE (D Danis) – Shifted out leaving the barriers making contact with **GO YOU GOOD THING**.

GO YOU GOOD THING (V Colgan) – Contacted leaving the barriers.

ODINPOWER (A Lawson-Carroll) – Came together with THE BOOGEYMAN leaving the barriers.

THE BOOGEYMAN (J Chung) - Over-raced in the early stages. Had to be steadied when awkwardly placed on heels passing the 1000 metres. When questioned regarding the performance the rider advised that the gelding had over-raced in the early to middle stages and had failed to handle today's track conditions.

EVA CHIARA (M McNab) - Placed in restricted room over the concluding stages to the outside of LEICALOT which lay out and away from APACHE BOY which lay out over the concluding stages.

APACHE BOY (M Hashizume) – Lay out when placed under pressure in the final straight.
