**KASUDA (M McNab)** – Trainer Mr. P Didham advised Stewards, KASUDA underwent a veterinary examination on Monday 4 July which included an endoscopic examination and blood test with no abnormalities being detected. P Didham further advised it is his intention to continue on with the mare's current preparation.

### RACE COMMENTS

**Race 1**      **BAYLEYS FEILDING 2200**

**GREYSTONE** (K Hannan) - Broke through the barriers but was quickly pulled up and returned to the start. A veterinary examination was carried out with the gelding being cleared to start. Blundered at the start, crowding outside runners.

**DUCK ROAD** (R Hannam) - Removed from the barriers to undergo a veterinary examination and was cleared to start. Crowded at the start. Over-raced in the early stages. Finished last. When questioned, rider advised the gelding had not handled today's holding track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

**PRINCESS ANI** (F Lazet) - Crowded at the start losing ground.

**CHARLIE HORSE** (D Turner) - Over-raced in the early stages. Finished towards the rear. When questioned, rider advised his mount was not suited to the holding track conditions. Connections advised the gelding is now retired.

**CROSS ROADS** (J Parkes) - Performed below market expectations. When questioned rider advised the gelding was not suited to the testing conditions underfoot.

Race 2	<b>BONNY GLEN LANDFILL 2YO 1100</b>

**MISS LONE STAR** (A Mudhoo) - Slow away, tailed off and was uncompetitive. Stewards requested a post-race veterinary examination which was clear. Connections were advised the filly is required to trial to the satisfaction of Stewards prior to racing next.

**ABOVE SUSPICION** (K Hannan) - Began awkwardly, crowding **FREEDOM REINS**.

**FREEDOM REINS** (R Hannam) - Crowded at the start.

**NIGHT RAIDER** (J Parkes) - Raced wide throughout. Lay in near the 150 metres, having to be straightened.

**MANHATTAN JAZZ** (K Hercock) - Lay in rounding the final bend.

**D Turner** (YOU KNOW) - Issued with a warning after weighing in 0.5kg above the weight at which he weighed out.

Race 3	<b>J &amp; J WALTERS LTD 3YO 1650</b>

**DIVINE SPIRIT** (R Hannam) - Restrained to the rear from its wide draw.

**ZENA ROCKS** (K Hercock) - Over-raced through the middle stages.

**QUEEN OF SPADES** (L Allpress) - Angled wide entering the home straight in search of better footing.

**LIKE IT SWEET** (J Parkes) - Inconvenienced near the 250 metres.

**ARBRE ROUGE** (L Sutherland) - Inconvenienced near the 250 metres.

**SON OF THUNDER** (H Schofer) - Checked off heels and had to change ground near the 250 metres when SHA CARRI shifted out when insufficiently clear, inconveniencing runners to its outside.

**K Hannan** (SHA CARRI) - Defended a charge of careless riding in that she permitted her mount to shift outwards near the 250 metres when not sufficiently clear of SON OF THUNDER. After hearing evidence and viewing footage the Adjudicator found the charge proved and suspended K Hannan's licence to ride in races from the conclusion of racing today, Saturday, 9 July 2022 up to and including racing on Friday, 15 July 2022, 4 national riding days.

Race 4	<b>EVANS HENDERSON WOODBRIDGE 1650</b>

**PRECIOUS NIAMH** (L Sutherland) - Restrained to the rear from its wide draw. Inconvenienced near the 300 metres, becoming awkwardly placed on heels, having to be straightened.

**ALL BLACK BOURBON** (J Parkes) - Made the final bend awkwardly when hanging out, then shifted out resulting in HOOTER which was improving to its outside, being dictated into the line of SPLODGE, which in turn inconvenienced PREVIOUS NIAMH.

**HALLELUJAH BROTHER** (A Mudhoo) - Raced ungenerously in the early to middle stages when wide.

**BAHIA EMERALD** (K Hercock) - Performed below market expectations. Rider advised the mare had not handled today's track conditions. A post-race veterinary examination revealed lameness in the right hind with connections being advised BAHIA EMERALD will require a veterinary clearance prior to racing next.

**L Sutherland** (PRECIOUS NIAMH) - Stewards inquired into the manner in which L Sutherland used her whip in the home straight and could not be conclusively satisfied that she had contravened the rule.

**C Dell** (SPLODGE) - Reminded of his obligation that he is expected to ride his mount out fully to the finish when circumstances permit after relaxing his ride over the concluding stages.

Race 5	<b>RICHARDS CONSTRUCTION LTD 1200</b>

**MEKELLE** (M Singh) - Slow away.

**VALZACELLA** (T Taiaroa) - Slow away.

**MAKE TIME** (L Sutherland) - Held up throughout the home straight, gaining clear running inside the final 100 metres.

**ACTING OUT** (T Newman) - Finished last. When questioned rider advised the mare had felt awkward in its action. A post-race veterinary examination did not reveal any obvious abnormalities.

**HOT SHOCKOLATE** (K Hannan) - Lay out over the concluding stages.

**C Dell** (NOBELLEM) - Shown footage and advised to exercise care when shifting wider on the track on entering the home straight.

Race 6	<b>COOMBE SMITH RANGITIKEI 1400</b>

**HACKSAW RIDGE** (L Allpress) - Began awkwardly and got back.

**INVISILE SPIRIT** (D Turner) - Lay out near the 400 metres.

Race 7	<b>RAYNER BUILDING/BJW MOTORS LTD STAYERS 2200</b>

**SMART ATTIRE** (J Parkes) - Slow away then raced wide in the early stages. Hampered 1800 metres. Performed below market expectations. Rider advised the gelding had not handled today's track conditions. A post-race veterinary examination did not reveal any obvious abnormalities.

**ECHO BAY** (R Hannam) - Hampered leaving the home straight near the 1800 metres when RED 'N' SURF (L Sutherland) shifted out. Also hampered was SMART ATTIRE, which was dictated over ground. RED 'N' SURF and ECHO BAY continued to bump for some distance. L Sutherland was shown footage of her ride in the presence of the Apprentice Mentor and reminded of her obligation when shifting ground.

**GOLDEN EAGLE** (T Taiaroa) - T Taiaroa reported to Stewards that her mount, which was having its first start over ground, had over-raced through the early and middle stages which placed her in a position where she was a lot further in front than intended.

**T Taiaroa (GOLDEN EAGLE)** - Reminded of her obligation that she is expected to ride her mount out fully to the finish when circumstances permit after relaxing her ride over the concluding stages. Stewards were satisfied her finishing position was not compromised on this occasion.
