RACE COMMENTS

Race 1 | **CROFT POLES (1200 metres)**

ONEROA (E Nicholas) - Restrained from a wide barrier at the start.

EXPRESS PRINCESS (K Hannan) - Began awkwardly losing ground. Held up rounding the final turn until approaching the 200 metres.

LADY DE WINTER (J Kamaruddin) – Restrained from a wide barrier at the start. Raced keenly in the early stages.

TROUBLE (A Lawson-Carroll) - Raced wide without cover throughout.

Race 2 | **NZB INSURANCE PEARL SERIES RACE (1200 metres)**

EL ROSEAY (S Weatherley) - Was removed from its barrier to undergo a pre-race veterinary inspection and was declared fit to start. Began awkwardly then crowded shortly after the start. Raced keenly through the early and middle stages.

MAGIC SHOW (M McNab) - Was removed from its barrier to undergo a pre-race veterinary inspection and was late scratched on veterinary advice at 1.02 pm.

REGAL DUCHESS (A Lawson-Carroll) - Slow to begin. Held up until near the 200 metres.

MACUSHLA (T Newman) - Raced keenly in the early stages when being restrained. Steadied when placed in restricted room over the concluding stages to the outside of REGAL DUCHESS which shifted outwards. A Lawson-Carroll was advised to exercise care in similar circumstances. Underwent a post-race veterinary inspection which did not reveal any abnormality.

NEW DAWN (K Asano) - Improved onto heels passing the 800 metres having to be steadied.

TARGHEE (M Hashizume) - Inconvenienced passing the 250 metres by ALICE TINKER which shifted out when placed under pressure.

ALICE TINKER (D Danis) - Raced greenly when placed under pressure in the final straight.

Following the race, connections of the 2nd placed horse TARGHEE lodged a protest against the 1st placed horse ALICE TINKER alleging interference in the final straight. After viewing films and hearing submissions the Adjudicative Committee dismissed the protest with the placings standing 1st ALICE TINKER, 2nd TARGHEE, 3rd REGAL DUCHESS, 4th EL ROSEAY.

Race 3 | **ITM/GIB 2YO WINTER CHAMPIONSHIP SERIES FINAL (1200 metres)**

FEEL THE THUNDER (T Newman) - Slow to begin. Raced wide without cover throughout when laying out.

BELTHIL (L Satherley) - Began awkwardly.

WESSEX (K Hannan) - Raced wide without cover throughout.

VILLON (K Asano) – Crowded having to be checked passing the 700 metres.

MIGHTY BRIGHT (M Cameron) - Crowded having to be checked passing the 700 metres.

DEPLOY (J Fawcett) - When questioned regarding performance the rider advised that in her opinion the filly had held its breath. Underwent a post-race veterinary inspection which did not reveal any abnormality.

J Fawcett (DEPLOY) - Admitted a charge of careless riding in that she permitted her mount to shift inwards when not sufficiently clear crowding VILLON onto MIGHTY BRIGHT which was checked passing the 700 metres. After

considering submissions the Adjudicative Committee suspended J Fawcett's licence to ride in races from the conclusion of racing on Saturday 23 July up to and including racing on Wednesday 3 August, 6 national riding days.

Race 4 | **GRANT CROSBIE MEMORIAL (1200 metres)**

RABADA (S Weatherley) - Began awkwardly making contact with **RISING DREAM**.

RISING DREAM (D Prastiyou) - Contacted at the start.

VAN DIESEL (C Grylls) - Began awkwardly losing ground. Raced keenly in the early and middle stages.

THE BOOGEYMAN (E Nicholas) - Contacted at the start.

LAGERFELD (M Cameron) - Began awkwardly. Underwent a post-race veterinary inspection which did not reveal any abnormality.

FLAT TRACK BULLY (J Kamaruddin) - Raced keenly in the early stages.

M McNab (FLAT TRACK BULLY) - Admitted a charge of breaking his riding engagement on **FLAT TRACK BULLY** with the Adjudicative Committee imposing a fine of \$200.

Race 5 | **ITM/GIB 3YO WINTER CHAMPIONSHIP SERIES FINAL (1600 metres)**

CRUISEY LASS (S Weatherley) - Began awkwardly losing ground.

SERESIN (M McNab) - Crowded shortly after the start.

DIVINE FORCE (L Satherley) - Slow to begin.

THE BIG SHOW (T Thornton) - Slow to begin.

FOLLOW YOUR DREAMS (K Hannan) - Raced keenly in the early and middle stages.

ONTHEPIGSBACK (J Kamaruddin) - Underwent a post-race veterinary inspection which found the gelding to be lame in the right foreleg. Connections were advised that a veterinary clearance would be required prior to racing next.

Race 6 | **ITM/GIB WHANGAREI GOLD CUP STAYERS FINAL (2100 metres)**

TWO MADISON (Y Kumagai) - Restrained from its wide barrier at the start.

SELVA VERDE (C Lindsay) - Slow to begin. Raced keenly in the early stages.

RISING ROAD (C Grylls) - Slow to begin. When questioned regarding the performance the rider advised that the mare had never travelled comfortably throughout.

RUA ROCKS (M Cameron) – Steadied when placed in restricted room approaching the 350 metres to the outside of **TWO MADISON** which shifted outwards. Y Kumagai was advised to exercise care in similar circumstances. When questioned regarding the performance the rider advised that in his opinion the gelding was feeling the effects of recent racing.

CORUBA JAK (S Spratt) - Had to shift outwards early in the final straight to obtain clear running.

Race 7 | **ITM/GIB SPRINTERS WINTER CHAMPIONSHIP SERIES FINAL (1400 metres)**

JODELIN GAL (L Satherley) - Slow to begin.

NEW YORK JAZZ (C Jones) - Restrained at the start from its wide barrier.

ZELENSKI (A Lawson-Carroll) - Raced wide without cover throughout.

DIAMOND GIRL (T Newman) - Had to be steadied when placed in restricted room to the inside of IRISH GIRL which shifted inwards passing the 1000 metres. K Hannan was advised to exercise care in similar circumstances.

TIGHTLIGN (C Lindsay) - When questioned regarding performance the rider advised that she had been disappointed in the gelding's performance. Underwent a post-race veterinary inspection which did not reveal any abnormality.

Race 8

ITM/GIB PROGRESSIVE WINTER CHAMPIONSHIP SERIES FINAL (1600 metres)

ZA'FARAN (V Colgan) - Slow to begin.

HIT THE SWITCH (M Hashizume) - Crowded at the start.

THEGEEWAGON (J Kamaruddin) - Crowded at the start. Had difficulty obtaining clear running early in the final straight.

ON FIFTH AVE (K Hannan) - Contacted at the start.

SHIVERS (T Mitchell) - Restrained from its wide barrier at the start.

VEGAS STRIP (J Fawcett) - Raced wide without cover throughout.

AQUA MAN (A Lawson-Carroll) - Raced keenly through the middle stages.

RUBYSHOWOFF (T Newman) – Raced wide for a majority of the race.

KAIMAI QUEEN (N Parmar) - Improved onto heels approaching the 350 metres having to be steadied before shifting outwards to obtain clear running.

MIRIELLA (S Spratt) - Had some difficulty obtaining clear running until near the 200 metres.

ROSE CRESCENT (C Grylls) - Held up until passing the 100 metres.
