GENERAL

Stewards were advised on race morning that T Newman would not be attending the meeting due to incurring an injury at trackwork. T Newman is required to provide a medical clearance prior to riding next.

Race 1 CELLAR DOOR WAIMAUKU 2100

LOT OF ZEES (L Satherley) – Restrained at the start from its wide barrier. Forced over extra ground by QUEEN SARABI over the final 200 metres.

ZABDI (A Lawson-Carroll) – Slow to begin. Raced keenly in the early stages when being restrained. Not persevered with in the final straight when well beaten.

LATE TO THE PARTY (N Parmar) – Raced keenly through the middle stages. Rider N Parmar dropped his left rein passing the 200 metres.

MIGHTY COLOMBO (C Barnes) - Finished a distant last. When questioned regarding the performance the rider could offer no explanation.

R Beemud (QUEEN SARABI) - Issued with a warning after allowing his mount to shift outwards over the final 200 metres dictating LOT OF ZEES over extra ground.

Race 2OFF THE RAILS LUNCHBAR RAILSIDE AVE MAIDEN 2100 – AMATEUR RIDERSACAPULCO (S Mynott) - Reared as the start was affected losing ground.

MONBEAU (C Sharp) - Slow to begin then crowded shortly after.

MOKELE MBEMBE (N Smith) - Slow to begin.

TE ATATU MEMPHIS (C Isdale) - Began awkwardly.

MEANDEEL (L Zydenbos) – Raced wide in the early stages before being restrained to obtain cover. Lay out and away from BURCHA over the concluding stages.

EKSTRA GHIA (V Mason) – Raced wide without cover throughout.

BURCHA (S MacNab) - Lay out under pressure over the final 200 metres. When questioned regarding the improved performance connections advised that the gelding appreciated the heavy loose conditions and racing back on a right-handed track.

KATE VELOUR (O Dalton) - Raced below market expectations. When questioned regarding the performance the rider advised that the mare failed to handle today's heavy track conditions. Underwent a post-race veterinary examination which did not reveal any abnormalities.

Race 3 MARSHALL STAND FUNCTION CENTRE MAIDEN 1200

STANIMA MAN (E Bragg) - Slow to begin.

CHASE 'N' GOLD (K Asano) - Slow to begin.

GAME PATROL (V Colgan) - Slow to begin.

MAGIC ACE (C Grylls) - Briefly raced in restricted room passing the 300 metres. Raced below market expectations. When questioned regarding the performance the rider advised that the gelding failed to handle the heavy track conditions.

SNORKEL (E Nicholas) – Came together with MR FANTASTIC approaching the 100 metres.

GREY WOLF (R Elliot) - Raced below market expectations. When questioned regarding the performance the rider advised that the gelding failed to handle the heavy track conditions.

Race 4 NZB INSURANCE PEARL SERIES MAIDEN RACE (1200 metres)

PRINCESS OF ROC (D Danis) - Slow to begin.

FASHION A BELLE (K Hannan) – Contacted at the start.

MADIRAN (S Spratt) - Shifted in at the start making contact with FASHION A BELLE. When questioned regarding the performance the rider advised that the filly failed to handle the heavy track conditions.

PINKYBAR (A Goindasamy) – Raced wide without cover throughout.

TREAT DAPAINTER (C Lindsay) - Underwent a post-race veterinary examination which revealed a laceration to the left nostril.

Race 5 WESTBROOK WINES MAIDEN 1400

MIDDLE KHAN (E Bragg) - Late scratched at the barrier after refusing to load. Trainer R Gavin was advised that the gelding must barrier trial to the satisfaction of Stewards prior to racing next.

IRISH MOONSHINE (T Yanagida) - Restrained at the start from its wide barrier. Clipped a heel near the 400 metres when attempting a marginal run between THELASTINVINCIBLE and TOGA PARTY. Rider T Yanagida was advised to exercise greater care in similar circumstances.

TURNAROUND (A Lawson-Carroll) - Began awkwardly briefly unbalancing its rider.

THELASTINVINCIBLE (T Harris) - Contacted at the start.

TRUE NORTH (D Danis) - Slow to begin.

SWISSABEEL (N Parmar) – Raced keenly in the early stages when being restrained. Finished a distant last. When questioned regarding the performance the rider could offer no explanation.

Race 6 AJC MEMBERS MAIDEN 1400

JUSTASCOOTA (S Weatherley) - Underwent a pre-race veterinary examination after becoming fractious in at the barrier and was late scratched at 2.56 pm. Connections were advised that the gelding must barrier trial to the satisfaction of Stewards prior to racing next.

ROOFTOP (J Fawcett) - Slow to begin.

JUST A TIPPLE (C Grylls) - Slow to begin.

INVIALO (B Rogerson) - Slow to begin.

AMARILLO SLIM (E Nicholas) - Crowded at the start losing ground.

WHO'S SAM (E Bragg) – When questioned regarding the improved performance trainer N Tanner advised that the gelding had benefitted from racing in blinkers for the first time.

JACK'S BEAU (C Lindsay) - Contacted at the start.

LIKE IT SWEET (R Elliot) - Lay in under pressure in the straight.

THE FINNSTER (C Grylls) - Bumped near the 350 metres by LIKE IT SWEET which was laying in under pressure. Raced below market expectations. When questioned regarding the performance the rider advised that the gelding failed to handle the heavy track conditions.

PRINCE LIA (S Spratt) - Raced below market expectations. When questioned regarding the performance the rider advised that the gelding failed to handle the heavy track conditions.

Race 8 TOPWELL BAKERY 1600

MRS BIG (C Dell) - Began awkwardly losing ground.

BELLA DORA (J Kamaruddin) - Slow to begin.

DROVERS YARN (D Danis) - Slow to begin.

CHILLAX (R Elliot) - Raced below market expectations. When questioned regarding the performance the rider advised that the gelding failed to handle the heavy track conditions.

T Harris (IFFIE SHOWS) - Issued with a warning after he struck his mount six times prior to the 100 metre mark with Stewards taking into account his clear recent record with regard to any breach of this whip rule.
