RACE COMMENTS	
Race 1	CARPET KING 1400
ROCK ISLAND LINE (L Sutherland) - Restrained to the rear to obtain cover.	
TUI ROCKS (F Lazet) - Over-raced in the early stages.	
Race 2	CARRFIELDS LIVESTOCK/WOOLS OF NZ 3YO 1400
SHE'S MISS GEVIOUS (L Sutherland) - Slow away. Raced greenly, becoming awkwardly placed on heels passing the 1000 metres, bumping ONLYWORDS TO TRADE, continued to race greenly in the home straight.	

MCKHAN (H Schofer) - Began awkwardly then commenced to race ungenerously in the early and middle stages, placing the rider at a disadvantage.

ONLYWORDS TO TRADE (J Parkes) - Bumped near the 1000 metres. Raced wide throughout. Commenced to give ground from the 800 metres. When questioned rider advised the gelding was unsuited to the Heavy 10 track conditions. A post-race veterinary examination did not reveal any obvious abnormalities.

H Schofer (MCKHAN) - Issued with a warning after weighing in 0.5kg above the weight at which she weighed out.

L Sutherland (SHE'S MISS GEVIOUS) - Admitted a charge in that she struck her mount SHE'S MISS GEVIOUS 6 times prior to the 100 metre mark. After considering submissions the Adjudicator imposed a fine of \$500.

Race 3 | **FARMERS TRANSPORT 2YO 800**

RUBY SEEKER (K Hercock) - Refused to jump away and took no part in the event. Connections were advised RUBY SEEKER must barrier trial to the satisfaction of Stewards prior to racing next.

GUNNAGETYABEANS (D Turner) - Began awkwardly losing ground. When questioned into performance rider advised that after losing ground at the start the gelding was unable to make ground over the 800 metre sprint. A post-race veterinary examination was clear.

ESHAY (R Hannam) - Slow away.

THE DIVINER (K Hannan) - Raced greenly in the home straight.

AGATHA (J Fawcett) - Lay inwards under pressure in the home straight.

PLATINUM FURY (C Dell) - Lay inwards, having to be straightened over the concluding stages.

TANTRUMS (S Weatherley) - Lay outwards over the concluding stages.

Race 4 | **PGG WRIGHTSON LIVESTOCK 2200**

RED 'N' SURF (J Parkes) - Slow away and then over-raced through the early stages.

ALMERAKE (J Mudhoo) - Slow away.

OCEANIDES (C Dell) - Over-raced through the early stages. Finished towards the rear. When questioned into performance rider advised that the mare had failed to handle the track conditions, however was nevertheless disappointing.

JAKAMA KRYSTAL (E Nichols) - Lay outwards under pressure near the 350 metres, bumping with SHE'S SO RELIABLE.

SHE'S SO RELIABLE (L Allpress) - Bumped 350 metres.

Race 5 | **STOCKCO/NEILSON LIVESTOCK MAIDEN 1650**

SERENGETI (E Nicholas) - Fractious in the barriers prior to the start, then slow away. Connections were advised that a warning is to be placed on the gelding's barrier manners.

MYSALLY (A Mudhoo) - Over-raced near the 1400 metres.

BRIAR (K Hercock) - Finished last. When questioned rider advised the mare had failed to handle today's track conditions.

KHANT CATCH HER (L Allpress) - Performed below market expectations. When questioned rider advised the mare had failed to handle today's track conditions.

Race 6 | **WAIROA WANDERERS/KEN BROWNE LIVESTOCK 1650**

MAHOMES (K Hannan) - Slow away.

FATTORE OTTO (C Dell) - Crowded at the start when THIS LADY ROCKS began awkwardly.

THIS LADY ROCKS (F Lazet) - Began awkwardly.

FRANKENSTEIN (R Hannam) - Over-raced early stages.

TOBKAY (A Mudhoo) - Shifted ground in the home straight when being ridden out having to be straightened.

DECADENCE (J Kamaruddin) - Performed below market expectations. When questioned rider advised the mare had failed to handle today's track conditions.

Race 7 | **ROSS DYER LIVESTOCK MAIDEN 1200**

TIN PAN ALLEY (L Sutherland) - Began awkwardly losing ground.

EREBUS (K Hercock) - Over-raced in the early and middle stages.

CHASING MY TAIL (D Prastiyou) - Finished towards the rear. Rider advised the filly had failed to handle today's track conditions.

POLAR BLAST (J Riddell) - Performed below market expectations. When questioned rider advised the gelding had raced further back than anticipated and was unable to make ground in today's Heavy 10 track conditions.

Race 8 | **JIMMY RURAL 1200**

PERFECTSISTER (F Lazet) - Underwent a pre-race veterinary examination at the trainer's request prior to parading to the start and was cleared to start.

SHOWSHANELLE (C Dell) - Slow away and out of contention thereafter.

JUSTASKPERCY (J Parkes) - Performed below market expectations. When questioned rider advised the gelding had failed to handle today's track conditions.
